

FROM THE PRESIDENT



The white coats are coming! The (short) white coats are coming!

ithin just a few months, Lehigh Valley Health Network will become "home" to 18 University of South Florida (USF) medical students for all of their third and most of their fourth year rotations. By now, you have no doubt heard of the SELECT (which stands for <u>S</u>cholarly <u>Excellence</u>, <u>L</u>eadership <u>Experiences</u>, <u>C</u>ollaborative <u>Training</u>) Program partnership between LVHN and USF – but why USF and why now?

"LVHN has had a longstanding commitment to training medical students to become good clinicians," says J. Alan Otsuki, MD, MBA, Associate Dean and Chief, Medical Education, University of South Florida, "and USF has a reputation for innovation. This is a unique opportunity to create a medical school environment that is different – medical students will make their 'home' here. They won't be finishing up one rotation and running off to another 'big city' hospital. We can offer them a more personalized experience, blending good clinical training with 'new era' skills."

Health care today is different than it was years ago. According to Dr. Otsuki, "Everything is

more complex. The demographics of our population have shifted – we have more elderly patients and those living with chronic conditions. Advances in medical knowledge and technology have been enormous, and health care delivery systems are now more team-based. This additional complexity demands new skills and innovative ways to apply clinical knowledge." That's why, in addition to their clinical studies, USF students get exposure to interdisciplinary care and process improvement in their curriculum. Prior to their acceptance into SELECT, our USF students also participated in an additional layer of qualitative interviews designed to identify students with leadership potential and emotional intelligence skills. The goals of SELECT include developing excellent clinicians who can deliver personalized patient care and who are health system savvy.



Work has been underway for a couple of years now to prepare for the arrival of our SELECT students. Faculty members from multiple clinical disciplines have been working with the Division of Education and the leadership of the Morsani College of Medicine at USF to develop curriculum and to facilitate small groups of students during their preclinical Doctoring and Professional Development courses. More recently, the SELECT Readiness Team has surveyed over 5,200 LVHN employees to get feedback about our clinical settings as learning environments. Many doctors and APC's can share stories about how their best or worst rotations were influenced by the behavior of their preceptor or the support they received from helpful nurses or staff. The survey will help us identify where we are strong and where we have opportunities to improve before the students arrive in May. This first cohort of students will also provide valuable feedback to us as they make their way through their first full year here.

What can we do to prepare for the arrival of the USF students? Think back to your student days – try to see things through those eyes. Take a critical look at the teams with whom you work – is there open communication? Do teammates display PRIDE behaviors? Do they make newcomers feel welcome and help orient them to the work? Think about the skills you use with students who work with you – do you offer encouragement? Is your feedback specific to what you observe? Ask others on your team about non-verbal behaviors you exhibit. Do you role model professional behavior, even when under stress?

SELECT will give our LVHN community a unique opportunity to help shape the next generation of clinicians – including some of those who will care for us! Dr. Otsuki shares some of this sentiment: "When I'm in the bed looking up, I want to see a caring, compassionate doctor there – one that knows what he or she is doing – one of our graduates." Indeed, one of the hopes of this program is to make our LVHN culture attractive to our USF students and have them join us as residents and future colleagues. There is no better way for us to share the best of our profession. Have a great month – and share a med student story or two about one of the "good times."

PCE PRESCRIPTION: CREATING A CLEAN CONNECTION

The goal of Lehigh Valley Health Network's Patient-Centered Experience (PCE) initiative is to give patients and their loved ones the best possible health care experience. Through PCE, the health network is continually looking for ways to enhance its environment of care, including the cleanliness of patient rooms.

PCE Outcomes: Through a new program at Lehigh Valley Hospital-Muhlenberg and Lehigh Valley Hospital-Cedar Crest, housekeepers are encouraged to engage patients to better understand their cleaning needs and preferences. Equally important is their ability to provide comfort and reassurance when patients are anxious or concerned. Performance on general cleaning tasks and priority areas is tracked on "patient expectations" boards. Why it's important to you: "Actively involving our patients in all aspects of their care pays dividends on many levels," says Bruce A. Ellsweig, MD, Vice Chair of Family Medicine for Community Practices. "Identifying and prioritizing a patient's cleaning preferences does more than create a safer, more comfortable room environment. It also demonstrates respect, builds trust and creates a closer connection with the entire care team."

PULMONARY REHABILITATION AT LVH

Pulmonary rehabilitation is offered at both Lehigh Valley Hospital-Cedar Crest and Lehigh Valley Hospital-Muhlenberg. It is a 12-week program in which participants meet two times per week for a time commitment of approximately three hours per week.

What is Pulmonary Rehabilitation?

Pulmonary rehabilitation, as defined by the American Thoracic Society and the European Respiratory Society, is an evidence-based, multidisciplinary, and comprehensive intervention for patients with chronic respiratory diseases. Pulmonary rehabilitation is integrated into the individualized treatment of the patient and designed to reduce symptoms, optimize functional status, increase participation, and reduce health care cost by stabilizing or reversing systemic manifestations of the disease¹.

The main areas of focus are lower and upper extremity exercise conditioning, breathing exercises, education and psychosocial support with additional focus on smoking sensation, oxygen therapy, bronchodilators, antibiotics, nutritional support, and respiratory muscle training and energy conservation.

What are the Goals and Benefits?

The goal of pulmonary rehabilitation is to decrease the cycle of dyspnea and deconditioning of patients with advanced lung disease. Benefits of pulmonary rehabilitation include decreased dyspnea, improved health related quality of life, fewer days of hospitalization, and decreased healthcare utilization².

Who can be enrolled?

Most of the patients referred to pulmonary rehabilitation have moderate to severe chronic obstructive pulmonary disease based on GOLD³ criteria with an FEV₁ less than 70 percent, however other patient populations such as those with interstitial lung disease have been demonstrated to have clinical improvements and can be evaluated for enrollment. Most insurance plans will cover up to 36 visits.

Who can refer patients?

Any physician can refer a patient. Consultation with a pulmonologist is not required. Patients should have had pulmonary function testing and an EKG within the last 12 months.

LMIC has also introduced its new website to better serve referring practices and patients. The website provides practices guidance in ordering the appropriate study and detailed information about insurance requirements (e.g., pre-certification) or restrictions for the major insurers. The website facilitates many activities for patients such as scheduling appointments and completing paperwork in advance and describes what to expect upon arrival and during the study. Meet the APC Staff

A member of the LVHN Allied Health Professional staff since June, 2009, **Jamie L. Reynolds, PA-C**, is this month's featured practitioner.

Cancer is a word that typically does not put a patient at ease. However, Jamie Reynolds, physician assistant with

Hematology-Oncology Associates, helps care for patients who love her and ask for her by name. It takes a special blend of warmth and intelligence to do what she does. It is no surprise that she was the recipient of the Friends of Nursing Award for the Promotion of Patient Care in 2012.

Jamie begins her day at 7 a.m., on the fifth floor at LVH-Muhlenberg rounding on a variety of patients who are undergoing intensive inpatient chemotherapy regimens for leukemia, lymphoma, and other cancer diagnoses. She replaces electrolytes, orders medications for symptom relief, and provides education to patients. Chemotherapy teaching is an important part of her job and affords time in which she can educate her patients regarding the process, expectations, and complications of chemotherapy. After rounds, Jamie attends to the patients on the consult service to provide recommendations for new cancer or hematologic diagnoses. Over time, she develops a repertoire with patients. In some situations, this relationship will require discussing difficult end of life decisions. By 10 a.m., she partakes in group rounding with her attending physicians. Jamie spends her afternoons completing initial consultations and oncology admissions or discharges. Jamie's favorite part of her job is spending "quality time" with her patients each day. She appreciates the ability to share in her patient's journey – a journey that at times brings reasons for celebration and at others, reasons for sadness. Nevertheless, these situations present times of need for her patients, and Jamie is grateful to provide the care and support necessary.

Jamie is a graduate of Columbia College where she earned a Bachelor of Science degree in Biology. She also earned a Master of Science in Physician Assistant Studies from DeSales University.

On a more personal note, Jamie is married to Shawn Reynolds, a physician assistant with LVPG-Emergency Medicine, who is currently serving in the U.S. Army. CHANGES TO MEDICAL STAFF RULES AND REGULATIONS

The following revisions to the Medical Staff Rules and Regulations received approval by the Medical Executive Committee on November 6, 2012, the General Medical Staff on December 10, 2012, and the Boards of Trustees of Lehigh Valley Hospital and Lehigh Valley Hospital-Muhlenberg on January 9, 2013.

RULES AND REGULATIONS - The following revisions were made to adhere to Act 68 of 2012, introduced to Senate Bill1351, amending the Vital Statistics Law to allow a certified registered nurse practitioner (CRNP) to certify the cause of death and sign a death certificate or fetal death certificate for a patient under the care of the CRNP.

K. DEATH CERTIFICATES AND AUTOPSIES

- 3. Death Certificates must be signed by the attending Medical Staff Member <u>or credentialed certified registered nurse</u> <u>practitioner</u> unless the Coroner assumes jurisdiction.

- 5. If the Emergency Department physician is unaware of the cause of death, the patient's personal physician or credentialed certified registered nurse practitioner whose care the patient was under, should be contacted to sign the death certificate. If neither the personal physician, certified registered nurse practitioner, nor the Emergency Department physician is are willing to sign the death certificate, the Coroner must be contacted.

PHYSICIAN DOCUMENTATION

Document According to Standard Definitions

Please consider the following evidence-based clinical definitions when documenting diagnoses in the medical record.

NEW Malnutrition Definition

New guidelines published in the May 2012 *Journal of the Academy of Nutrition and Dietetics* represent a consensus statement of the American Academy of Nutrition and Dietetics and the American Society for Parenteral and Enteral Nutrition (ASPEN). The Academy and ASPEN both advocate for use of a standard set of diagnostic criteria to identify and document adult malnutrition.

The Academy and ASPEN state that malnutrition should be diagnosed when providers identify/document **at least two or more** of the following six characteristics* *in the setting of an acute illness or injury, a chronic illness, or social or environmental circumstances*:

- Insufficient energy intake (expressed as a specific % of the estimated energy requirement over a specific time)
- Weight loss (specific % over specific time)
- Loss of muscle mass (mild, moderate, or severe)
- Loss of subcutaneous fat (mild, moderate, or severe)
- Localized or generalized fluid accumulation (mild, moderate, or severe)
- Diminished functional status as measured by hand grip strength

<u>Acute Kidney Injury (AKI)</u> = An abrupt reduction in kidney function defined by:

• Increase in serum creatinine of >/= 0.3 mg/dl within 48 hours

OR

• Increase in serum creatinine to >/= 1.5 x baseline Cr, known or presumed to have occurred within the prior seven days

<u>Accelerated Hypertension</u> = A rapid and sudden increase in blood pressure over the baseline level that, if untreated, poses a threat for damage to organs and tissues.

- Systolic pressure >180 and/or diastolic pressure >120.
- Symptoms may include headache, blurry vision and/ or nausea.

<u>Sepsis</u> = Any two SIRS criteria (Temp >100.4F or <96.8F, HR >90bpm, RR >20 breaths/min, WBC count >12,000/mL or <4000/mL or >10% bands) + source of infection.

<u>Severe Sepsis</u> = Sepsis + associated organ dysfunction, hypoperfusion or hypotension. Manifestations may include: lactic acidosis, oliguria, and encephalopathy.

<u>Septic Shock</u> = Severe Sepsis + Acute circulatory failure unexplained by other causes. SBP <90 or MAP <60, reduction in SBP 40 mmHg from baseline despite adequate volume resuscitation; patient requires inotropic or vasopressor support despite adequate fluid replacement.

Cardiogenic Shock:

- A sustained (>30 minutes) episode of systolic blood pressure <90 mmHg, and/or
- A cardiac index <2.2 L/min/m2 determined to be secondary to cardiac dysfunction, and/or
- The requirement for parenteral inotropic or vasopressor agents or mechanical support to maintain blood pressure and cardiac index above these specified levels (e.g., intra-aortic balloon pump (IABP), extracorporeal circulation, ventricular assist devices).
- Hemodynamic compromise (with or without extraordinary supportive therapy) must persist for <u>at least</u> 30 minutes.
 Exclusions:
- Transient episodes of hypotension reversed with IV fluid or atropine.
