The Probe Probes Medical Photography

Why do hospitals have photographers? Well, if anyone has ever attended one of Jack Dittbrenner's lectures in the past, or the lecture of any doctor who has had to use slides or photographs to help make his point, the answer is clear. Hospitals have a decided need for photographic and film records of a medical nature. Not only for legal purposes, but for the reference needs of the medical staff. After all, there's nothing like photo recall.

Jack Dittbrenner, who did much to revamp the photographic records department of Allentown Hospital, has now moved on to the new medical center. He is ably replaced by 22-year-old Scott Dornblaser, a graduate of the Rhode Island School of Design. Scott is a native son as well, having attended Catasauqua High School, class of '70.

Scott entered Rhode Island with a desire to pursue architectural studies, but gradually changed his major field of study to photography. Among his tutors were Harry Callahan and Aaron Siskind, both of whom should be well known to amateur and professional photographers alike for their published portfolios. Although he has a decided artistic bent with a strong interest in film-making, Scott's educational background has been varied enough to allow him to handle the widespread duties of the hospital photographer.



Those duties include visual aids and documentary photographs for doctors' lectures, public relation work, portraits, yearbook candids and photos for *THE PROBE*, just to mention the sociable angle of the position. He must also film and photograph operations when surgeons request the service, and take gross specimen photos for pathology records.

He also handles audio-visual duties. Impending here is the use and instruction in use of the student nurses' new video-tape equipment. Scott adds that video-tape will conceivably play a more important over-all role in medical photography in the near future, perhaps becoming more widespread in use than film for instruction and archival purposes.

For those who are interested in knowing, the photo lab's equipment is mainly Leica . . . or Leitz Optics. And the darkroom lab is cleverly hidden on the main floor behind some doors labeled "Nuclear Medicine." Perhaps with more space becoming available due to the closing of certain patient units in the Allentown Hospital, the cramped photo lab may be able to expand. Scott says this is a conceivable future move.

Morton Silverman, M.D.

Dr. Morton Silverman is a home town boy who made good. Born in Allentown, he attended public schools here, as well as Muhlenberg College. After graduating from University of Pennsylvania Medical School, he interned here. He studied post-graduate internal medicine, again at Penn, and in 1950 he began his practice in Cardiology and Internal Medicine.

Active in his native town, he is a past president of the trustees of Keneseth Israel Temple, and of B'nai B'rith. His present positions include president of the Pennsylvania Mid-eastern chapter of the Heart Association and vice-president of the Lehigh County Medical Society.

In 1964, Allentown Hospital opened its Coronary Care Unit, one of the first in the United States. Dr. Silverman was its director from then until its close in September, 1974. His other duties at this hospital have included president of the hospital staff 1967-69 and he has been a board of trustees member since 1969.



Charles A. Raab

For seven years, Charles Raab has been on our trustee board. In those seven years his life-style has changed. For 35 years he travelled around the East for Sears as a merchandising manager. 
Frederick Kalmbach, Jr.

The Patient's Bill of Rights

(Condensed from the American Hospital Association)

The patient has the right to:

- 1. Considerate and respectful care.
- Complete, understandable current information regarding diagnosis, treatment, prognosis, and to know his physician by name.
- 3. Information from his physician necessary to give informed consent to procedures or treatments.
- Refuse treatment to the extent permitted by law, and to be informed of the consequences.
- 5. Privacy concerning his health care program.
- Confidential communications pertaining to his care.
- Expect a hospital to respond, within its capacity, to reasonable requests for services.
- 8. Obtain information about professional relationships of individuals or institutions who are treating him.
- 9. Know if the hospital proposes to do any experimentation that may affect his care, and the right to refuse to participate.
- 10. Expect reasonable continuity of care including information about his case after discharge.
- 11. Examine and receive explanation of his bill regardless of payment source.
- 12. Know what hospital rules and regulation apply to his personal conduct while hospitalized.
