## LEHIGH VALLEY HOSPITAL CITED FOR THE 14TH CONSECUTIVE YEAR AMONG BEST IN U.S.

LVH named in two specialties by U.S. News & World Report for 2009

Lehigh Valley Hospital ranks as one of the nation's top hospitals in two specialty care delivery areas in the 2009 *U.S. News & World Report* guide to "America's Best Hospitals."

The 2009 list recognizes Lehigh Valley Hospital among the nation's leading hospitals for:

- Geriatrics
- Urology

The hospital has made the *U.S. News* rankings 14 consecutive years with a total of 30 specialty category listings in the past six years alone including heart care and heart surgery, cancer, gastrointestinal disorders, gynecology, orthopedics and respiratory disorders.

"This recognition is important because it reinforces what our community is telling us about the quality and safety of the care our physicians, nurses and staff provide everyday," said Elliot J. Sussman, MD, President and CEO, Lehigh Valley Health Network. Dr. Sussman said the health network treated more patients over the last year with inpatient bed use up 4.5 percent.

"As our community continues to rely on us for quality care, our team of caregivers continues to strive to consistently be the best at what they do, and this acknowledgement by *U.S. News & World Report* is evidence of that."



According to U.S. News & World Report, "America's Best Hospitals" assessed care in 16 specialties. Only 174 of 4,861 hospitals that were evaluated made the list in one or more specialties. In order to be considered, a hospital must meet one of three standards: be a teaching hospital, have at least 200 beds, or have at least 100 beds and at least four out of eight important medical technologies. In each specialty, a hospital must perform a certain number of specified procedures on Medicare inpatients, or be cited by at least one physician as among the best in that specialty in the past three years of *U.S. News* surveys. These hospitals received a score that equally weighed reputation, mortality, patient safety and certain care-related factors such as nursing and patient services.

## FROM THE PRESIDENT

## LVHN Department of Medicine and Our Community

As you may remember, at the beginning of my term as President of the Medical Staff of Lehigh Valley Health Network, I shared my desire to focus on highlighting physicians who are positively impacting and actively involved in our community. In February, I highlighted many Pediatricians and would like to continue this month with members from our Department of Medicine.



I asked the Chair of the Department of Medicine, **Debbie Salas-Lopez, MD, MPH,** to share information about some of her physicians and advanced practice clinicians who were actively involved in the community and, as you might imagine, the list was

extensive. Debbie herself supervises the Department of Medicine's involvement in Allentown's 6th Street Shelter where the department maintains an apartment at the shelter that is cleaned, painted, and supplied with furnishings on a yearly basis. Debbie also speaks several times a year in our community. For example, in November, she spoke at Lehigh Valley Project Blueprint on "Racial and Ethnic Diversity in Volunteer Leadership," and in May, she spoke along with one of our trauma surgeons, **Dale Dangleben, MD**, to the William Allen High School's Latino Leadership Club, sharing their life experiences.



About four years ago, **Gretchen Perilli, MD,** and **Deb Feden, CRNP,** realized a need to provide health care for the residents of the 6<sup>th</sup> Street Shelter and other members of our community who had no health insurance and difficulty accessing care. In

response, they established and staff a free clinic at the shelter on the second and fourth Wednesdays of each month. Since that time, they have been joined by **Cheryl Bloomfield, MD,** and **Karen Landis, CRNP**. Cheryl will often bring a resident or two with her. The clinic starts after their normal work day at 5:15 p.m., and goes until all the patients are seen. It is not


uncommon for patients to start lining up at 1 p.m. for the 5:15 p.m. start as the appointments are first come first serve. Some visits are for routine physical exams to facilitate employment and others are for acute and chronic medical problems. If any of the providers identifies a patient with a chronic health problem who will need daily medications and regular follow-up visits, the patient is referred to the 17th Street Internal Medicine Clinic where they are given appointments and access to **Fran Hnat** for medication assistance and **Maxine Rhode** and **Mayra Ramirez** for medical financial counseling and access to other services.


Two year ago, two of our physician assistants, **Brett Feldman**, **PA-C**, and **Corinne Feldman**, **PA-C**, played a vital role in starting the DeSales University Free Clinic at the Allentown Rescue Mission. To provide care to the men at the mission, they coordinate and work alongside faculty and students from the DeSales University Physician Assistant Program. Currently, they staff the rescue mission one day a week, but demand has been so great, they are considering expanding to twice weekly.



Other Department of Medicine members who I would like to highlight include **Marc Vengrove**, **DO**, who is actively involved in the Juvenile Diabetes Research Foundation (JDRF) and has run a 100-mile ultramarathon in Vermont to

raise money for the JDRF in an effort to find a cure for diabetes. **Mark Kender, MD,** has been coaching travel baseball for 15 years for the Lower





The volunteer efforts of the Nephrology Division include **Nelson Kopyt, DO,** who is actively involved in the Lehigh Valley Chapter of the National Kidney Foundation, chairs the local Kidney Walk, and arranged for KEEP (Kidney Early



Evaluation Program) to come to Allentown. KEEP allows the community to participate in a day-long program where people

### **SPPI 101**

## Freshen up on your efficiency knowledge to eliminate waste, manage costs and improve care

A year ago, Lehigh Valley Health Network (LVHN) colleagues learned a new acronym: SPPI (Systems for Partners in Performance Improvement). You likely knew it was about efficiency, but you may have thought it only affected people in management.

Then Rapid Improvement Events (RIE) started, and it may have appeared that SPPI was only for the areas affected by the selected "value streams" (series of actions required to fulfill customers' needs) — sterile processing/operating room (SP/OR), and specific departments that affect certain aspects of inhospital patient flow.

Neither is true. SPPI is about everyone, including physicians. SPPI is not an initiative, but rather a shift in thinking about how members of the network can work more leanly, more productively and more efficiently while enhancing patients' experiences.

Here's a look back on the initial SPPI intentions:

#### 1: Establish SPPI

More than a year ago, Lehigh Valley Health Network recognized changes were needed to survive and thrive. So LVHN initiated SPPI, created a strategic plan to improve our bottom line while enhancing our patient care — called the Transformational Plan of Care (TPOC) — and selected lean methodology and tools to enhance our continuous improvement efforts. Right now, the health network is working to clearly define roles and expectations with regard to SPPI for all of us.

## 2: Hold Senior Management Council (SMC) accountable for leading the way

When a major change happens within an organization, it is essential for senior leaders to be enthusiastic supporters. SPPI has sponsorship from President and Chief Executive Officer Elliot J. Sussman, MD; SMC members have participated in RIEs; and the network formed an SPPI advisory group. Moving forward, SMC members will have performance goals related to efficiency and managing costs in 2010. SMC leaders will be looking to all colleagues, including physicians, to gain more insight on how we can continue to improve.

## 3: Achieve \$3 million in productivity during year one

LVHN is beginning to see cost savings directly attributed to SPPI. This will be an important focus moving forward as the network develops methods to quantify productivity gains and cost savings.

#### 4: Reduce waste and work more efficiently

LVHN has given colleagues some lean tools which help us organize our workspaces for efficiency. The network also launched a Collaborative Leadership Learning Series and a Lean 101 workshop. Both provide all colleagues the basic understanding of lean thinking. As more colleagues learn these lean tools, the goal is for all colleagues, including physicians, to use them to identify and remove waste from daily work.

## 5: Create transparency in approach and results

Lehigh Valley Health Network wants everyone to understand and fully engage in SPPI. Originally, the network invited colleagues to RIE report-outs and placed "metric boards" (with RIE results) in RIE work areas. Throughout the next year, expect to hear more about SPPI as we continue to integrate lean thinking into our daily work.


### **News from CAPOE Central**

#### **Tube Feeds and Free Water**

There has been some confusion when ordering tube feedings and the need to order free water. We have made a slight change to the Tube Feeding order to facilitate communicating the free water portion of the order. The tube feeding order screen contains a field for "Free Water." This field is required, even if no free water is desired. Please choose from one of the entries or type in the volume of free water desired. If no free water is desired, please choose the "No Free Water" choice from the drop down menu. A second field containing the frequency for the free water is also required. Completing these fields will improve efficiency of care and reduce calls from Nutrition or Nursing regarding the need for free water.

#### Allergy Overrides - Time to make a choice

You will begin noticing a change in how allergies are handled when ordering medications. If you are presented with an allergy conflict screen, and choose to continue to order the medication, you will be <u>required</u> to enter a reason for the allergy "over-ride" on the medication detail screen. A drop-down menu will pop-up prompting the user to enter the reason. Choices are shown in the diagram below.

### MEDICAL ANIMATIONS AVAILABLE ONLINE

#### Library provides visual resources for explaining conditions and treatments to patients



In some instances, having visual aids to explain a condition or procedure to a patient is beneficial. But there are only so many posters you can display on a wall. Now you can go to *lvh.org/human\_atlas* to quickly access a library of animations depicting more than 275 conditions and treatments.

The Human Atlas shows the basics of

anatomy and physiology about various medical conditions and treatments including congestive heart failure, Alzheimer's disease, Lyme disease and chemotherapy. You can select from four methods of explanation for each topic:

- > Video, approximately one- to two-minutes in length
- Text which provides an exact script of the animation narration
- Models that rotate 360 degrees
- > Images (an average of six), labeled with definitions

If you have an iPhone, you can purchase a Human Atlas application, so it's conveniently available to you and your patients.

### FAQS ABOUT CLOSTRIDIUM DIFFICILE

#### A New Threat from an Old Enemy

#### Introduction

Clostridium difficile (C.diff) is a bacterium that is spreading rapidly in hospitals and elsewhere. It is a bacterial illness spread by fecal spores that is most commonly seen in people on antibiotics. C.diff causes diarrhea and can lead to a type of colitis. The prevalence of colitis caused by C.diff more than doubled among U.S. patients between 1993 and 2003 with the infections growing increasingly severe and even fatal.

#### Laboratory Tests

- Please use the new order code CDDNA which is a PCR assay.
- Duplicate stool specimens are no longer recommended as this assay is significantly more sensitive (96%) than the old technology.

#### **Prevention**

- Use antibiotics judiciously
- Order Contact Isolation for known or suspected patients with C.diff (private room or cohorted with another C.diff patient).

- A red dot is placed on the corner of the Contact Isolation sign which indicates a C.diff patient.
- Practice strict hand hygiene using an <u>antiseptic</u> <u>soap and water</u>. Soap and water is reportedly more effective than alcohol-based waterless hand sanitizer.
- Wear gloves and gowns for all contact with the patient and/or their environment.
- Disinfect all equipment that touches the patient (stethoscope).

#### **Environmental Sanitation**

It is critical that the room of a C.diff patient be disinfected with a hospital approved disinfectant that contains bleach.

#### **Treatment**

Oral Vancomycin is increasingly seen as the drug of choice for all relapse cases of C.diff, C.diff in the elderly, and for all patients other than mild cases of C.diff.

## PHYSICIAN DOCUMENTATION

#### **Request for Consultation (MRD 10) Format Update**

The generic Request for Consultation form (MRD 10), used by credentialed providers to document requested consultations, has been updated to meet the hospital and physician office needs. An order for the consult must be found in the medical record.

## Top Section: Request for Consultation and Contact Information

Service date changed to request date – include the date the consult is being requested.

#### **Bottom Section: Report of Consultation**

- Date of Consultation added
- Scribe Information added A 'scribe' documents exact dictation by the provider. Scribe documentation cannot include any observations by the scribe or any independent thought. Scribes assist physicians on a real-time basis with the clerical aspects of patient care, clinically, a scribe remains 'hands off'. No exam or questions of the patient can be performed by the scribe.

Co-signature added - Medical record standards require handwritten or electronic signatures on all medical orders and related medical documents, identifying who rendered the service.

The majority of providers utilize the Request for Consultation form to document a summary of findings for continuity of care. Dictated Reports of Consultations are strongly encouraged as they are legible and usually provide more thorough information. In addition, providers are able to view dictated consultations in the LastWord Clinical Repository both inside the organization and remotely, as well as copies auto-faxed to the provider requesting the consultation, the consultant, and the primary care physician.

## CHANGES TO THE ADMINISTRATIVE POLICY REGARDING CONSENT

The Pennsylvania MCARE Act, 40 P.S. Section 1303.504, places the duty to obtain a patient's informed consent on the physician. Under the Act, the requirement of obtaining informed consent (and concomitant liability for not obtaining it) applies to surgeries, related administration of anesthesia, radiation or chemotherapy, **blood transfusions**, insertion of surgical devices or appliances, and administration of experimental medication or devices. The patient must be given a description of the risks and alternatives that a reasonably prudent person would require to make an informed decision as to that procedure.

Since Physician Assistants and Certified Registered Nurse Practitioners may order a blood transfusion (if permitted by their license and credentialed to so), the current consent policy was amended to allow these credentialed allied health professionals to obtain the patient's signature on the consent for administration of blood. However, since Pennsylvania law is clear that it is a physician's responsibility to ensure the patient understands the procedure, the physician needs to sign the consent as well. A PA-C or CRNP may convey information to the patient regarding the risks, benefits and alternatives; however, the physician is liable for the quality and accuracy of the information imparted upon the patient by any designee.

The Division of Education (DOE) is pleased to announce the opening of the LVHN Interdisciplinary Simulation Center, located on the second floor of the 1247 building in the Cedar Crest Professional Park. The center includes burn, ICU, and medical/surgical rooms, as well as a large all-purpose room with multi-tasking trainer areas. This all-purpose room, used with much success for the central line training course, is also suitable as either a resuscitation bay or as an operating room. The separate debriefing area provides space for after-action review of recorded simulations. High fidelity mannequin-based simulations may be performed with a variety of manne-

quins ranging from neonatal to adult, and with standardized patient actors as primary or secondary players.

The principal mission of the center is to support patient care through interdisciplinary educational efforts involving care providers at all levels. Simulation programs that focus on patient safety, communication and teamwork will be actively promoted. The DOE plans to offer development courses to educate our faculty members in the simulation environment.

## **ELEARNING UPDATE**



The eLearning system contains an expanding number of courses with content that has been created by subject matter experts from clinical departments. Some of these courses include:

- New Organ and Tissue Donation
- New Advanced Directives for Healthcare
- 2009 Joint Commission NPSG

For improved efficiency, and to allow users an opportunity to develop more experience and comfort using the eLearning system, this year's required annual training has been separated into three bundles.

- The first OSHA 2009 (sponsored by the Department of Environmental Health & Safety) – was required to be completed by July 1.
- The second *The Joint Commission 2009* (sponsored by Regulatory Excellence) contains courses designed to meet regulations set by The Joint Commission. This bundle will be released on August 3, and must be completed by September 30. After August 3, staff will be able to access these courses by logging on to the home page of the eLearning system. After completing these courses, users will be asked to provide feedback. In addition to courses specified for non-clinical employees and those with patient contact, this bundle will contain courses specified for homecare workers.

The third bundle – Corporate Compliance 2009 (sponsored by Legal Services/Internal Audit) – will be released later this fall.

eLearning will also allow all users to track Continuing Education credits for activities offered at LVHN. Staff can access and print certificates for courses with continuing education credits. To do so:

- Select *Learn* from the Menu Bar on the home page of the eLearning system.
- Then select *Learning Activity Reports* and *Training Transcript*.
- Click on the name of the activity associated with the CE Credit.
- Then click on *the certificate icon* and click *Print*.

The self-reported training feature allows staff to track education and Continuing Education credits offered outside the eLearning System.

Please be advised that it *should not* be used for the treatment of respiratory infections. Levofloxacin will remain on the formulary for this indication.

## PHYSICIAN PATIENT SATISFACTION AWARD

## WINNERS SELECTED



John F. Campion, MD, Chief, Division of Child-Adolescent Psychiatry, and Prodromos (Prody) A. Ververeli, MD, Chief, Division of Orthopedic Surgery, were recently selected as the



latest winners of the *Physician Patient Satisfaction Award*.

This award was initiated by the Patient Satisfaction Improvement Council team at LVH-Muhlenberg in 2007. When Medical Staff Leadership learned about the initiative, it was decided to expand the idea across the Network. Beginning in 2008, all physicians, dentists, and podiatrists have been eligible for the award, which is presented every six months to two Medical Staff members who excel at promoting patient satisfaction.

The selection of winners is based, in part, on the results of the Press Ganey surveys, in which discharged patients rate their experience, including their experience with their doctors. Many doctors do pay extra attention to those areas that lead to high levels of patient satisfaction, such as spending time talking with patients and their families, listening well, and working collaboratively with nurses, advanced practice clinicians and others to ensure that patients have the best possible experience and the best possible outcomes. Through this award, the exemplary efforts of our colleagues can be recognized. The recipients of the award will each receive a \$500 check for their efforts.
