## FROM THE PRESIDENT



## **The Seventh Triennial Physician Recognition Dinner**

aturday night, March 27, was a very special night for Lehigh Valley Health Network. This was the night of the Seventh Triennial LVHN Physician Recognition Dinner held at Bear Creek Mountain Resort and Conference Center. Almost 300 of our friends and colleagues were in attendance on this beautiful spring night. It was a chance to honor some very deserving people, a chance to celebrate some successful and remarkable careers, and also a chance for us all to relax, get caught up with friends who we haven't seen in a while, and to have some fun.

On this night, we honored all 1,217 members of our Medical Staff. We thanked our spouses and families for their patience and understanding as we put in long hours away from home serving the members of our community. It was also a night to thank countless others who support doctors and make our work possible.

We recognized 48 doctors who have actively served on the Medical Staff for 25 years and six doctors who have served for 50 years.

Twenty five years ago, when many of our colleagues joined the Medical Staff of Lehigh Valley Hospital, the cost of a first class stamp was 20 cents. The Medical Staff at LVH had only 442 members as opposed to 1,217 today. President Ronald Reagan was sworn in for his second term and met with Mikhail Gorbachev for the first time. The FDA approved the first blood test for AIDS. The song "We Are the World" was recorded for the first time and along with the Live Aid concerts in London and Philadelphia, \$50 million was raised for Ethiopian famine relief. The top song was "Careless Whisper" by Wham, "Back to the Future" with Michael J. Fox was the top movie, and lots of little girls were trying to get their hands on a Cabbage Patch doll.

It is amazing to think back 50 years ago, when six of our colleagues were joining the staff at Allentown Hospital. At that time, 180 million people lived in the United States, and the price of a new home was \$16,500.



The Academy Award for best picture in 1960 went to "The Apartment" starring Jack Lemmon and Shirley MacLaine. The top song was "The Twist" by Chubby Checker, and in November, John F. Kennedy was elected president.

In addition to recognizing our doctors for 25 and 50 years of service, we gave out five special awards and honored Linda Lapos as our most recent past president. (Please see Pages 8-10 for photos and a full listing of award recipients.)

It was a great night and I was then, and continue to be, so very proud to be President of this fine Medical Staff.

## GENEROUS GIFT TO HELP BUILD FAMILY SUPPORT AND LODGING CENTER



As Lehigh Valley Health Network's expertise in trauma, burn, heart and children's care receives further recognition, more and more people are traveling greater distances for our services. As a result, 30 to 40 family members of patients stay at LVH-Cedar Crest on any given night. "Having a family member in the hospital with a serious illness or injury is stressful and disruptive, especially when you must be away from home and family," said Elliot J. Sussman, MD, LVHN President and Chief Executive Officer.

Thanks to a recent generous gift, LVHN will build a Family Support and Lodging Center to give family members a comfortable place to stay. The extremely generous \$2 million gift was provided by Willard Hackerman and his wife, Lillian Patz Hackerman, of Baltimore, Md. Mr. Hackerman is president and CEO of Whiting-Turner Contracting, the company that managed several of LVHN's past construction projects. The center will cost \$2.9 million. The remainder will be funded through donations.

The Family Support and Lodging Center will be built south of the helipad outside of the hospital's emergency department. The two-story building will contain 20 private rooms, each with a private bath. The center also will include a common lounge area, kitchenette, playroom for children, library and laundry facilities. Groundbreaking is tentatively planned for June, with construction expected to take about a year.

The center, which will be operated and staffed by LVHN, will serve as a home away from home for families of patients requiring a longer hospital stay or ongoing treatment that could require daily visits to the hospital. Families will be charged an affordable daily rate – about half the discounted lodging rate in the area. Fees will be used solely to cover operating costs. The Hackerman-Patz House will complement the services offered by Jenn's House, a nearby hospitality house that currently services some families of patients.

In keeping with our mission, we must do everything possible to make our patients and their family members comfortable during stressful times. "Finding a convenient, inexpensive place to stay can help ease some of the burden for families who have to travel," Dr. Sussman said. "Thanks to the generosity of Mr. Hackerman and his wife, Lillian, the center will help with the healing process for our patients and their families."

## **UPDATE FROM THE TEST UTILIZATION COUNCIL**

#### **Blood Bank Transfusion Protocol**

Blood samples submitted to the Blood Bank can be used for three days to crossmatch red cell units requested for transfusion. Effective immediately, when unexpired samples are available, the blood bank technologists will be authorized to correct unnecessary orders for patient blood draws based on the physician's obvious intent, thereby eliminating unnecessary patient sticks and telephone calls to the units.

#### **Hemoglobin A1C**

In contrast to blood glucose, a patient's glycated hemoglobin (HbA1c) has a half life of 60 days and reflects glycemic control

over the previous two to three months. Repeat HbA1c testing within this time frame is therefore often inappropriate. Effective April 19, in order to avoid unnecessary testing, an advisory window now appears when ordering HbA1c in CAPOE if this had been resulted in the previous 90 days. The advisory will include the date and value of the previous HbA1c result as well as if there is a currently pending order and suggest that this test need not be repeated without specific clinical indication.


### **News from Health Information Management**

#### **Improved Transcription Turnaround Time**

For many years, the Transcription Department consistently achieved a goal of an average 24 hour turnaround time of all medical reports. However, about a year ago, the Medical Record Committee challenged the Transcription Department to reduce turnaround time in order to provide quicker access to medical reports. Delays in access to medical reports negatively impacts clinical decision making, inpatient hospital flow and hospital efficiency. Although this seemed like a monumental task, the Transcription Department accepted the following challenge:

- Decrease turnaround time for consultations and histories and physicals from 24 hours to 12 hours from the time of dictation
- Change the reporting measure from an average turnaround time to the % of reports transcribed within the target times
- Achieve a goal of 95% of reports transcribed within target times

After months of reviewing dictation and Transcription Department staffing patterns, the staffing schedules were reorganized to successfully meet the demands of dictation patterns as well as achieve a goal of 95 % of histories and physicals and consultations transcribed within 12 hours of dictation. This was accomplished without adding any additional staff. The chart below demonstrates the dramatic success achieved from May 2009 to January 2010. The department continues to achieve greater than 95% of histories and physicals transcribed within 12 hours, as well as targeted transcription times on *all* medical reports, seven days a week.

## **News from CAPOE CENTRAL**

#### How much CSF do you really need?

When obtaining and submitting cerebral spinal fluid for analysis, please utilize the CSF order set. The order set contains a complete set of the appropriate orders and the Order Set Reference lists the required volumes and tubes required for each test. Please remember to refer to this order set PRIOR to obtaining specimens.

#### Comment Lines – Use with Caution

The "Communication to Nurse" order should NOT be used for medication dosing or route changes, or other medication specific instructions that may be required by pharmacy. The actual medication order should be discontinued and re-entered with the appropriate information. Instructions regarding rate changes for IV fluids or drips should not be entered using this order. Please use the appropriate orders and fields to complete these orders. Please do not enter dose changes or stop dates into the comment fields of medication orders. There are specific fields for this data. If the medication is to be stopped on a specific date or time, that can be entered into the 'End Date' and 'End Time' fields, or by using the Max Doses field.

## PHYSICIAN DOCUMENTATION

#### **Improve Predicted Mortality Rates through Documentation**

Case: 88-year-old female admitted from home with an STEMI. She also has CKD stage 3 and refuses cath due to risk of dialysis. She enacts a living will and appropriate medical care is given. However, Saturday at 3 a.m., her MI extends suddenly. She passes away by 4 a.m. The house officer pronounces her death and lists AMI as the sole diagnosis. The chart is then processed by the Coding Staff of Health Information Management.

Does this sound familiar? The above case is an example of how the mortality of a predictably moribund patient damages another physician's profile. These deaths often occur overnight or on weekends, have sparse documentation, and are not reviewed by our CDI team.

Is it reasonable to ask why a patient without a co-morbidity or major co-morbidity would expire? Yes, absolutely! Are these patients any less sick than others who passed away? Will this event translate into a publicly available profile indicating mortalities are higher than predicted? **Do physicians know how easy it is to ruin a profile?** 

Everyone needs to realize it is unreasonable to believe any patient would die without a major co-morbidity (see examples). In fact, they don't. They have respiratory failure and cardiac arrest. They have hypotension. Most go into a coma.

In particular, DRGs associated with a higher mortality, yet which are frequently under-documented by a physician in regard to severity of illness, include CHF, Pneumonias, UTIs and malignancies.

Solely documenting the cause of death in these cases is not enough under the MS-DRG system. In addition, we need to focus on documenting the dying process better.

When appropriate, in addition to the principal diagnosis, please consider documenting:

- 1) Cardiac arrest
- 2) Acute respiratory failure
- 3) Hypotensive shock
- 4) Coma

Simply adding "acute respiratory failure" in addition to "Acute MI" would significantly and appropriately change the MS-DRG and improve predicted mortality measures. This helps explain the mortality and can appropriately improve the physician's profile.

**Take home point:** It is important to document the comorbidities involved in the dying process, not just the cause of death.

### **ETHICS CORNER**

#### Communication - Installment 4: What's Your Goal?



Goals of care discussions are among the most frequent reasons for Ethics consultations. It is sometimes shocking how long patients are in the hospital before this discussion is undertaken. It is also not a once-and-done phenomenon. Treatment goals need to be frequently reviewed and revised. Treatment goals should be evaluated in:

- Inpatients who have new serious or life-threatening illnesses or major changes in clinical status
- 2. Inpatients who have an exacerbation of a chronic illness
- 3. Outpatients who have chronic disease
- 4. Healthy outpatients as part of advance directive discussion

As in the family conferences installment, these discussions should include the decisional patient, the physician of record, nurse, and any family, friends, social workers, chaplain or others per patient wishes.

Prior to the meeting, decide in your own mind what, if any, treatments are inappropriate or futile. Remember, you have **no obligation** to offer treatment that "in your best judgment" is futile. You **are** obligated to continue supportive care and treat suffering.

First, determine what the patient already knows, i.e., "What is your understanding of your present condition?" Review with the patient his/her current medical condition and expected prognosis. Invite questions and discussion about medical condition and prognosis.

There are three broad potential treatment goals: Cure – to eliminate disease; Rehabilitation – to restore function, maintain function, minimize loss of function, and Comfort care (palliative care) – to maintain comfort, treat symptoms, promote quality of life.

For a patient who is currently receiving curative treatment who has received new diagnostic information indicating a poor prognosis, the range of options might include:

- Continue curative therapy
- Withdraw selected or all aspects of existing curative interventions
- Vigorous palliative care and rehabilitation with the goals of maintaining comfort, maintaining functional capacity and providing maximal symptom control.

Ask the patient what treatment strategies are most consistent with his/her current personal and life goals. Goals can be short, medium and long term. Patients may want some time to consider changes in treatment goals, so agree on a follow-up plan. As always, document this discussion in the medical record. Remember, Medical Records has a Goals of Treatment Dictation, number 58, for this purpose.

When discussing treatment withdrawal, remember that the phrase "withdrawing treatment" can have a powerful emotional impact upon a patient and family because it may suggest abandonment. Also, the provision or discontinuation of certain treatments, such as non-oral hydration and nutrition, can have strong emotional meaning. Be aware that cultural beliefs and attitudes will influence decision-making. Determine what current diagnostics and therapeutics do not match the patient's treatment goals and review these with the patient/ family. Provide leadership and guidance when there is research indicating that a treatment will provide no benefit (e.g., CPR in the setting of multi-organ failure). When discussing the discontinuation of one treatment, always discuss those treatments that will continue to be offered. This will limit thoughts of abandonment. DNR discussions should always be conducted within the context of a larger discussion reviewing overall patient condition, prognosis and goals.

In closing, remember you are not alone. Both OACIS and the Ethics Committee can assist you with these difficult discussions.

## **Getting to Full Text from PubMed or PubMed Single Citation Matcher**

When you are doing a PubMed search, finding a citation is only half of the goal. Once you have identified the article, you may want the full text.

You can get to PubMed in two ways – through the internet or through the Digital Library homepage from the Network's intranet. When you access PubMed through the internet, the blue icons that link to the content to which Library Services subscribes may not display so you will not always be able to click right into the full text of articles. You would have to go to the Digital Library and look up the article in the Journal List. To be sure that the icons which enable you to click into the full text are displayed, your best bet is to enter PubMed through the Digital Library homepage.

#### **Access Surgery**

Access Surgery is an online resource that provides medical students, surgical residents, and practicing surgeons with quick answers to surgical questions from a variety of full-text sources. The content is organized around the ACGME's mandate for a core curriculum. In addition to textbooks, the program also offers surgical animations and videos, board review materials, drug information and differential diagnosis. Users need to complete a free registration to access the board review section and to save images. The images may be used for personal or education use in classroom teaching, lectures, presentations, rounds and other instructional activities.

To use Access Surgery from the intranet, click on Find Fast/ Library Services and then click on Access Surgery.


