Medical Records -Retention Requirements*

According to the April 1998 edition of Laws and Regulations Affecting Medical Practice, a physician must retain a patient's medical records for at least seven years from the date of the last medical service for which a record entry is required. In the case of a minor, the regulations only require that the records must be retained until one year after the minor reaches age 18. However, because the statute of limitations for a negligence action extends until two years after a minor reaches the age of 18, it is prudent to retain the records one year longer than the regulations require. Thus, minors' records often may have to be retained beyond seven years. For example, if a physician treats an infant one week after birth and never treats that patient again, he is required to maintain that record for 19 years (age 18 plus one year), and it would be a good practice to maintain those records for 20 years.

A problem arises frequently when the successor to a physician's practice, whether another physician or a

surviving spouse, tries to conclude the physician's affairs. Three areas which pose frequent record retention problems are: 1) the sale of an ongoing practice, 2) winding down an active practice upon retirement, and 3) transferring or concluding a practice following a physician's death. In all three of these situations, a physician should make sure that his successor is aware of the guidelines set forth above.

In addition to the record retention issue, the sale, winding down, or transfer of a practice raises other concerns about patient notification. Pennsylvania does not regulate this aspect of record retention. However, the American Medical Association (AMA) has issued an opinion which suggests that upon retirement or death, the physician's patients should be notified and urged to find a new physician. In addition, the patients should be told that upon receipt of an appropriate authorization, their records will be forwarded to their new physician. The AMA has recommended the same sort of notification procedures when a practice is sold either by a physician or his estate.


