

THOMAS WHALEN, MD, NAMED CHIEF MEDICAL OFFICER



Thomas V. Whalen, MD, MMM, who has served as Lehigh Valley Health Network's Chair of the Department of Surgery for almost five years, was recently appointed to the position of Chief Medical Officer. Dr. Whalen's rich experience with LVHN began in the Fall of 2006 when he joined us as a pediatric surgeon, the chair of surgery and holder of the Anne and Carl Anderson Distinguished Chair of Surgery.

Dr. Whalen's outstanding leadership earned him an Associate Chief Medical Officer position a year ago, additionally overseeing the chairs of the Departments of Obstetrics and Gynecology, Emergency Medicine and Dental Medicine.

Dr. Whalen has built relationships and guided our team through many priorities that have contributed to our network growth, including the development of our pediatric surgery and specialty care, and neurosurgery programs. He has also served as a designated institutional officer to the Division of Education, advising on medical education policies and training programs.

He came to LVHN from Robert Wood Johnson Medical School in New Jersey, where he molded and mentored physicians as a faculty member of its medical school for 17 years. He was also Robert Wood Johnson's chief of pediatric surgery and general surgery residency program director. Dr. Whalen also honorably served patients, and our country, as a commissioned officer in the medical corps of the regular and reserve Navy for 28 years.

Additionally, Dr. Whalen is a trustee and vice chair of the American College of Surgeons, and a board member and president-designee of the National Resident Matching program. He has also served on the National Institutes of Health advisory committee and chaired the surgery residency review committee of the Accreditation Council for Graduate Medical Education (ACGME). Dr. Whalen has earned several awards through the years, including being named to the "Best Doctors in America" list for the last 12 years.

LVHN Receives MagnetTM Re-designation Again

Lehigh Valley Health Network has been re-designated as a Magnet Hospital – receiving for the third time the highest honor for nursing excellence from the American Nurses Credentialing Center. The MagnetTM seal of approval helps identify hospitals where community members can expect to receive outstanding nursing care. Less than seven percent of hospitals in the country hold this honor, and Lehigh Valley Health Network is the only Magnet hospital in the region. The announcement was made during the health network's 24th Annual Friends of Nursing Awards Celebration on April 28.

PHYSICIAN DOCUMENTATION

Sequencing of Diagnosis in the Outpatient Setting



Outpatient coding and documentation rules differ significantly from the inpatient rules. In order to establish medical necessity and ensure proper reimbursement in the office setting, please keep in mind the following information.

Primary diagnosis describes the condition or problem chiefly responsible for the services provided. It is the reason the patient presents to the provider. The reason may either be a definitive diagnosis or it may be a

symptom if no definitive diagnosis has been made. (This differs from the inpatient setting, where the use of "probable," "suspected," or "likely" are acceptable qualifiers for unclear diagnoses.) Diagnosis codes must accurately reflect precisely how sick patients are or there is a risk of losing reimbursement or claim denial.

Secondary diagnoses describe any coexisting conditions that exist at the time of the office visit that require or affect patient care. (Do not document conditions which no longer exist.) Include secondary or tertiary diagnoses and certain chronic diagnoses, (even if they are not the focus of the patient encounter), if they require clinical evaluation or monitoring and impact your decision-making.

A good rule of thumb for secondary diagnoses: only those conditions that affect the *risk level* (i.e., medical decision-making) of the current visit. Secondary diagnoses should help show medical necessity for services and explain increased risk levels.

Question: When it comes to listing current and/or chronic/status conditions, where do you draw the line?

Answer: Document/code the current condition that prompted the visit (*Principal diagnosis*) and also document/code chronic conditions only when the patient receives treatment for the condition or it affects the current decision-making (*Secondary Diagnoses*).

Example: If a patient with COPD presents with a UTI, you do not need to document or code "COPD," since the COPD in no way influences your decision-making or treatment of the UTI. However, if the same patient were to present with chief complaint of shortness of breath, you would certainly document and code "COPD", since this diagnosis plays a part in your decision-making and patient treatment.

Important Notes:

In the *office setting*, avoid using a diagnosis with the words "*suspected*," or "rule-out" – these words are allowed only for inpatients, not outpatients.

In the *office setting*, diagnosis coding guidelines state you must report the reason the patient incurred services for that day (*Principal Diagnosis*). Unlike the inpatient setting, outpatient documentation rules advise using signs and symptoms if a diagnosis is unclear. While these are not true diagnoses, the signs and symptoms illustrate why a patient sought care, and they can show medical necessity for services a physician rendered.

Proper Location Now Requires Isolation

Sometime in June, the Isolation field on the Admitting Orders will become a required field. Providing isolation information will facilitate more accurate/efficient bed placement and will reduce patients returning to the Emergency Department for re-assignment. The reference text on the right side of the order lists the various types of isolation. If no specific isolation is required, please enter "Standard Precautions." If you are unsure of the isolation, choose the closest choice.

Pre-Op EKG? Tell us Why!

When ordering an EKG for cardiac clearance, it is now required to enter the procedure or surgery in comment line of the order. The reason for the EKG can remain "Pre-Op CV Exam," however, for appropriate documentation and coding, the actual procedure is required. Please use the comment line to provide the additional information.

ETHICS CORNER

Ethical Dilemmas Near the End of Life

"Should the treatment be started?"

"Should the treatment be stopped?"

"Who is the decision maker?"

"Am I honoring the patient's wishes?"

"I don't know if I agree with the family's decision."

"I am not comfortable with performing this procedure on this patient."

These are just a few of the ethical dilemmas that are faced when caring for patients near the end of life. We want to respect patient autonomy, but the patient cannot always tell us their wishes. We then refer to the surrogate or designated healthcare POA for decisions.

We all come to this time in our lives with certain values, traditions, personal ethics, spirituality, religious beliefs, and social relationships. When we are discussing procedures and treatments, we must remain objective in presentation and yet be aware of the learning needs of our audience, be aware of their values, beliefs, cultural issues, and any other factors that may influence decision making.



When possible, we may need to educate ourselves on cultural or religious beliefs regarding withdrawal or withholding of treatment and also ask if the family has a faith community and would like a representative to be present so that we may also understand their values. Another resource is to talk with someone from the Ethics Committee who also may be able to provide insight and suggestions that will assist with decision making.

LVHN DIGITAL LIBRARY

Free CME through DynaMed

DynaMed, the premier evidence-based clinical reference tool for health professionals, now provides free CME through Tufts University School of Medicine (TUSM). Physicians may claim .5 *AMA PRA Category 1 Credit*TM for conducting a single structured online search on a clinical topic. TUSM designates the educational activity for a maximum of 20 *AMA PRA Category 1 Credit*TM per year (40 searches).

Once you have read the topic you are interested in, click on **Get CME for this Search**. Enter your **LHVN computer user ID**, complete the required information and submit your CME form. You will receive an email confirmation of your submission. The email will contain the instructions on how to print out your certificate. Your certificate will be available for only six months on the Tufts University website. A confirmation of your search will also be stored in your LVHN eLearning portfolio.

Updated daily, DynaMed contains clinical summaries for over 3,200 topics pulled from the content of over 500 medical journals and evidence-based databases synthesized into a one-stop resource.

The full version of DynaMed, available through the Digital Library, contains links to over 500 clinical calculators. In addition, the content is integrated with the electronic subscriptions of Library Services so you can get to the full text of the articles cited in the references to a topic.

APPROVED CHANGES TO THE MEDICAL STAFF RULES AND REGULATIONS

The following revision to the Medical Staff Rules and Regulations were approved at the General Medical Staff meeting on March 14, 2011, and by the Boards of Trustees of Lehigh Valley Hospital and Lehigh Valley Hospital-Muhlenberg on May 4, 2011.

Part II – Medical Staff Rules and Regulations

E. Drugs

2. Drugs shall be prescribed and administered by an appropriately credentialed Medical Staff Member, nurse practitioner, <u>nurse midwife</u>, and physician assistant. Additionally, drugs shall be administered directly by a registered nurse or a licensed practical nurse with pharmacy training. Eligible Pharmacists may *only* administer immunizations in accordance with LVHN Pharmacy Policy.

Regional Burn Center Earns Reverification


