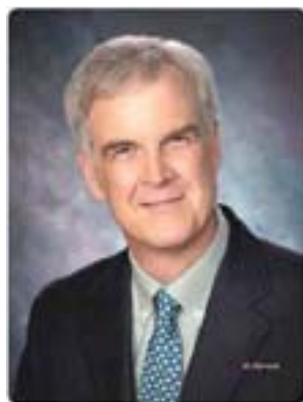

GET YOUR FLU SHOT!

Beginning this flu season, all colleagues who have routine or intermittent patient contact are required to get a flu shot. Those who do not wish to be vaccinated because of a valid medical or religious reason can request an exemption by visiting any Employee Health Services office by **November 12**. These individuals must be granted an exemption or be vaccinated by **December 1**. Failure to comply with the immunization policy will result in a written warning. **All Medical and Allied Health Professional Staff and other staff with patient contact who are not vaccinated or granted an exemption within two weeks of the warning will be subject to termination.**

NEW LOCATION AND NEW SERVICES AT THE LVHN SLEEP DISORDERS CENTERS



The LVHN Sleep Disorders Centers continue to transform with the addition of new locations and new services. The new Sleep Center at the Health Center at Bethlehem Township (HCBT) is now open and accepting new patients. There is no wait time to get your patient in for a sleep study. The new Center serves ages 15 and above. It is a state-of-the-art facility with six beautifully decorated, spacious and comfortable testing

rooms. The Sleep Center at LVH-17th continues to serve both adults and pediatrics, and LVH-M continues to serve pediatric patients.

Patients can be directly referred to the Centers by completing a *Polysomnography Order Form* and faxing it directly to the Center. Based on the level of service you choose when completing the form, a post-study consultation will be scheduled for your patient.

In addition, home-based sleep testing services are currently being provided at the LVH-17th site and will soon expand to the new Sleep Center at the Health Center at Bethlehem Township.

"Admit" It - You Should be Using the Admit Orders

Please remember to use the "Admit" and "Transfer" order sets when admitting or transferring any patient. This includes patients being admitted from the ED, home or another facility (nursing home, SNF), or direct admits. Transfer order sets should be used for all patient transfers from one unit to another, patients transferred from PACU or SSA, and other transfer situations.

These orders are required for several reasons. The Admit/Transfer order sets trigger specific protocols (MRSA screening, VTE prophylaxis), and are used by Patient Logistics for appropriate bed placement and for reimbursement purposes.

ICD-10 Update

October 1, 2014 has been mandated as the official ICD-10 compliance date in the Centers for Medicare & Medicaid Services Final Rule on August 24, 2012.

What is the significance of this date?

ICD-10 will revolutionize the healthcare industry and will drastically change the way you do business. All U.S. healthcare organizations must begin submitting claims using the ICD-10-CM and ICD-10-PCS (International Classification of Diseases, 10th Edition, Clinical Modification/Procedure Coding System), instead of our currently used ICD-9-CM code sets, or else claims will be rejected.

Why the change?

- 1) ICD-9-CM is outdated (used since 1979) and obsolete. ICD-9-CM is over 33 years old!
- 2) ICD-9-CM lacks the specificity to accurately report the diagnoses, treatment and technology used in patient care in the 21st century. It uses outdated terminology and codes that produce inaccurate and limited data. ICD-10 provides notable improvements through greater detailed information and the ability to expand to accommodate additional advancements in clinical medicine.

3) The U.S. is out of sync with the rest of the world. Many other countries have already moved to ICD-10: UK (1995), Nordic countries (1994-1997), France (1997), Australia (1998), Germany (2000), and Canada (2001). This discrepancy makes worldwide standardized reporting very difficult in cases of pandemics or other world health issues.

4) ICD-10 coding system consists of up to seven alpha or numeric digits (versus just three to five digits in ICD-9), allowing much greater specificity in coding diagnoses and procedures. The number of codes available in ICD-9 is only about 18,000, whereas in ICD-10 it is about 150,000!

What are we doing here at LVHN to prepare?

We have a multidisciplinary ICD-10 Steering Committee that meets regularly, and we have already begun implementing plans to be ready for the conversion to ICD-10 on October 1, 2014.

While this article serves to introduce you to this landmark change in national healthcare, you can expect to hear much more on this in months and years to come.

TEST UTILIZATION COUNCIL UPDATE

Beginning November 1, you will notice a Fluorescent Pink sticker on the front of End Stage Renal Disease/Chronic Kidney Disease patients' medical charts as an alert for "Anemia Risk." This Test Utilization Council project to identify End Stage Renal Disease patients was requested by the Division of Nephrology.

Chronic Kidney Disease patients are highly susceptible to anemia because of the kidney's inability to produce erythropoietin as well as machine losses during the dialysis treatments. The goal of this project is to decrease iatrogenic blood loss due to phlebotomy for lab tests.

The Division of Nephrology suggests:

- 1) Minimize blood tests to those that are absolutely necessary for inpatient management of the patient
- 2) Order lab tests on the same days as dialysis treatment, if needed

THE RETAIL PHARMACY VIEW

Warn Your Patients about using Mail Order Pharmacies

In conjunction with international regulatory and law enforcement agencies, the Food and Drug Administration (FDA) has taken action against more than 4,100 Internet pharmacies that illegally sell unapproved drugs. Between September 25 and October 2, the FDA shut down more than 18,000 illegal Pharmacy websites and seized about \$10.5 million worth of pharmaceuticals worldwide. In order to help consumers, the FDA has put a BeSafeRx website to educate the public about online pharmacies.

Big Pharma on the Patent Cliff

With so many big name medications becoming available in generic form, the major drug companies are looking at a drop in sales. Over 80 percent of sales of a brand name drug are lost within six months of introducing a generic form of that drug. In 2011, biggies like Lipitor, Plavix and Seroquel went generic, and that coupled with a slowdown in research and development due to a sluggish economy dropped the total brand name prescriptions filled by more than 14 percent. Generics now count for 86 percent of all dollar growth in the industry. Four years ago, it was 70 percent, quite a change and a scary thought to Big Pharma! According to an industry spokesman, there will be a slower generic trend in 2013, and with the aging of the baby boomers and new drug therapies underway, there will be a resumption of top-line growth the following year. Despite the lackluster economic growth, Rx volume overall increased from 2010 to 2011 as the population aged.

Ads for OTC Products underplay harm compared to Prescription Drugs

With prescription drugs, the advertisements are under the purview of the FDA while non-Rx product ads come under the Federal Trade Commission's scrutiny. When reviewing the advertising of prescription drugs, 70 percent of ads for prescription items presented information on the health benefits, descriptive characteristics and potential health harms of the medications. However, once these drugs are available over the counter, only 11 percent of ads gave complete information, meaning consumers are not being informed well enough about their over the counter purchases. Take a minute to remind your patients to "Talk to the Pharmacist" or a member of your staff before taking over the counter medications.

New Generics

In a strange twist of FDA rules, Diovan/HCTZ went generic (*Valsartan/HCTZ*) in October – but standard Diovan (*Valsartan*) will not be available generically until sometime in November.

ETHICS CORNER

Shopping for Surrogates

The patient is not competent to make decisions. There is no proxy designated, no health care agent. The healthcare team needs decisions to be made. They need to find a surrogate. How do they do that? Well, the American Medical Association basically says to check the state law that may specify surrogate decision makers. Pennsylvania does have such a hierarchy as part of Act 169. As per the Pennsylvania Medical Society website fact sheet, unless a patient designated otherwise, the patient's health care representative will be determined by a statutory list that generally gives priority in the following order:

- spouse and adult child who is not the child of the spouse
- adult child
- parent
- adult sibling
- adult grandchild
- close friend

In contrast to a health care agent, a health care representative or surrogate may direct the withholding or withdrawal of care necessary to preserve life only when the patient is permanently unconscious or has an end-stage medical condition. Physicians must document in the patient's medical record (1) when they determine that a patient is incompetent, and (2) when they determine that a patient is permanently unconscious or has an end-stage medical condition. In Pennsylvania, the definition of end-stage medical condition does not contain an estimate of life expectancy.



It all seems very clear, doesn't it? So, the team calls the spouse. They get a decision. Later in the hospitalization, the spouse is not immediately available. What now? Is the need emergent, such as an emergent procedure? If so, no consent is needed if truly life-saving and emergent and attendings agree to document such. If there is time, then the spouse should be the decision maker. We should not simply seek a name to put on a consent form. Neither should we shop for a surrogate that agrees with us. However, the American Medical Association Opinion 8.081 states it well. "In cases where there is a dispute among family members, physicians should work to resolve the conflict through mediation. Physicians or an ethics committee should try to uncover the reasons that underlie the disagreement and present information that will facilitate decision-making. When a physician believes that a decision is clearly not what the patient would have decided, could not be reasonably judged to be within the patient's best interests, or primarily serves the interest of a surrogate or a third party, an ethics committee should be consulted before requesting court intervention." If the surrogate is truly inaccessible to the point of detracting from the patient's care, then the surrogate may be inappropriate. A legal opinion and/or ethics consult should be obtained.

CHANGES TO MEDICAL STAFF BYLAWS AND RULES AND REGULATIONS

The following revisions to the Medical Staff Rules and Regulations received approval by the Medical Executive Committee on June 5, 2012, the General Medical Staff on June 11, 2012, and the Boards of Trustees of Lehigh Valley Hospital and Lehigh Valley Hospital–Muhlenberg on October 3, 2012.

RULES AND REGULATIONS - The following addition was made to accommodate the Medical Executive Committee approved policy – *Pennsylvania Orders for Life-Sustaining Treatment (POLST)*

D. ORDERS

3. Pennsylvania Orders for Life-Sustaining Treatment (POLST)

- (a) Acceptance of POLST orders shall be governed by Hospital Policy currently in effect.

The following revisions to the Medical Staff Bylaws received approval by the Medical Executive Committee on August 7, 2012, the General Medical Staff on September 10, 2012, and the Boards of Trustees of Lehigh Valley Hospital and Lehigh Valley Hospital–Muhlenberg on October 3, 2012.

MEDICAL STAFF BYLAWS – The following revisions were made to adhere to The Joint Commission Standard MS 01.01.01.

ARTICLE II - PURPOSES AND RESPONSIBILITIES

SECTION A – PURPOSES

- 2. The Medical Staff may act through the Medical Executive Committee of the Medical Staff and delegate authority to the Medical Executive Committee. The Medical Staff shall define the purposes, composition and authority of the Medical Executive Committee as set forth in these Bylaws and the Medical Staff shall periodically review these Bylaws to modify any such delegated authority.

ARTICLE XI – OFFICERS AND COMMITTEES

SECTION B – COMMITTEES

3. Purposes, Duties, and Membership:

a. Medical Executive Committee

- (i) Purpose: The Medical Executive Committee acts as the organizational body which oversees the functions and duties of the Medical Staff. The Medical Executive Committee acts on behalf of the Medical Staff strictly and solely within the scope of the Medical Executive Committee’s duties and responsibilities as set forth in this Article. The Medical Executive Committee is empowered to act for the Staff and to coordinate all activities and policies of the Staff, its Departments and Committees.

(ii) Duties:

- L. Report to the Medical Staff at each General Staff meeting on its activities during the period between each meeting of the Medical Staff.
