FROM THE PRESIDENT



AIDS Activity Office of LVHN

y mom is a long distance runner and has completed eight marathons. Some of my earliest memories as a four year old are being placed in the center of a track with my baby sister while my mom took her daily run. I began running with her when I was about 10 and have been running ever since. Now that I am in my forties, I run both to stay in shape and to clear my head. On my morning runs, I think about everything and nothing at the same time. My mind wanders from my wife and kids, to what I have to do later in the day, to waffles, and often to my patients, both old and new. Recently, I spoke to Tim Friel, MD, about the AIDS Activity Office, and on this morning's run, my mind wandered back 18 years to 1992 and one of my patients named Pat.

Pat, a 32-year old mother of three young children, was infected with AIDS from her husband. She was one of my first patients during my internship at Walter Reed Army Medical Center in Washington D.C. Pat had PCP with associated bilateral pneumothoraxes and three chest tubes on the right and two on the left. She also had cryptococcal meningitis and CMV colitis. Hopelessly chronically ill from her disease, there was little I could do to change her ultimate outcome. One month later, with her three children at her side, she succumbed to her disease.

So much has changed with respect to AIDS since first cases were described in 1981. During my internship and residency in the early 1990's, HIV remained largely untreatable. However, during the first year of my fellowship in 1996, with the addition of protease-base highly active antiretroviral therapy by David Ho, MD, and his team at the Aaron Diamond AIDS Research Center, those of us in the medical community finally had an effective treatment for this devastating disease.



Here in the Lehigh Valley, the LVHN AIDS Activity Office (AAO) was established in 1989 and was originally conceived as a case management provider for the almost 100 HIV-infected patients then living in the Allentown area. Initial responsibilities focused on facilitating referral of newly diagnosed patients to willing medical providers, providing social support, and facilitating end-of-life discussions and access to hospice care. In 1991, following the successful acquisition of federal HIV/AIDS funding from the Health Resources and Services Administration (HRSA) Ryan White Care Act, the AAO expanded its program to include on-site early intervention primary care for its patients.

There has been an extensive evolution at the AAO over the last 20 years. Along with Tim Friel, MD, there are three other LVHN physicians serving our HIV/AIDS patient population – Marcelo Gareca, MD, Margaret Hoffman-Terry, MD, and Joseph Yozviak, DO. These physicians, along with their team of more than 20, treat 720 patients with HIV/AIDS and rank as the largest clinic providing comprehensive multidisciplinary care for patients living in northeastern Pennsylvania.

Statistically, of the 720 active HIV infected patients, 72 percent are from the Allentown-Bethlehem-Easton area and 28 percent from other regional areas, with the largest group being from the growing Pocono region. Last year, the AAO saw 101 new patients representing a nine percent increase over the prior year. In addition, new and existing patients were seen in 3,656 visits, a 25 percent increase over the previous year.

Of the current AAO patients, 61 percent are male and 39 percent are female, with 52 percent between the ages of 45 and 64 (a statistic which reflects that patients are living much longer with HIV). In addition, 47 percent of these patients are Caucasian and 40 percent are of Latino decent. To help care for our AAO patient population, 47 percent of the staff is bilingual and bicultural.

In addition to excellent patient care, the LVHN AAO is a Pennsylvania Department of Health sponsored HIV testing site and one of three pilot sites in the state for Rapid HIV testing. In 2009, the AAO tested 872 patients and 19 were newly identified as being positive for HIV for a 2.18 percent HIV seropositivity rate.

To help fund this service to the community, the AAO receives more than \$1.2 million in grant funding and \$10,000 from the Trexler Trust to support the AAO Food Bank which provided 586 adults and 306 children with a total of 915 bags of groceries last year. The AAO also raised more than \$20,000 in their Haute in the Valley, BlackOut III, Ladies Affair, and Dining Out for Life fundraisers.

Although not conquered, so much progress has been made since the discovery of HIV in 1981, both nationally and locally at the LVHN AAO. Our providers and their team at the LVHN AAO are simply the best of the best.

LEHIGH VALLEY HOSPITAL CITED FOR THE 15TH CONSECUTIVE YEAR AMONG BEST IN U.S.

LVH Named Again by U.S. News & World Report for 2010-11

Lehigh Valley Hospital (LVH) ranks as one of the nation's top hospitals in U.S. News & World Report's 2010-11 Best Hospitals list.

The 2010-11 list recognizes Lehigh Valley Hospital among the nation's leading hospitals for geriatrics, the seventh time the hospital has made the list in this category.

LVH has made the *U.S. News* rankings for 15 consecutive years with a total of 31 specialty category listings in the past seven years alone including heart care and heart surgery, cancer, gastrointestinal disorders, gynecology, orthopedics and respiratory disorders.

"We are pleased to be named for the 15th consecutive year. We strive every day to exceed the expectations of our patients and their family members," said Elliot J. Sussman, MD, LVHN's President and CEO. Dr. Sussman said the health network treated more patients over the last year with inpatient bed use up 2.3 percent.

"I am extremely proud of our clinicians, educators, researchers and staff for their dedication and commitment. They provide our community with the outstanding care they expect and deserve, which in turn is recognized nationally by others like U.S. News."

According to U.S. News & World Report, Best Hospitals 2010-11 includes rankings of 152 medical centers nationwide in 16 specialties. Another 1,740 hospitals qualified for ranking but did not score high enough to be ranked.



In order to be considered, a hospital must meet at least one of four standards: be a teaching hospital, be affiliated with a medical school, have at least 200 beds, or have 100 or more beds and the availability of four or more types of medical technology considered important in a high-quality medical facility, such as a PET/CT scanner and certain precision radiation therapies.

In each specialty, a hospital must perform a certain number of specified procedures on Medicare inpatients, or be cited by at least one physician as among the best in that specialty in the past three years of *U.S. News* surveys.

"SHOULD THERE BE A SUDDEN LOSS OF CABIN PRESSURE . . ."

When we take our places on an airplane, we expect to arrive at our destination for vacation or to carry on with business as planned. The flight attendant then suggests another possible course: "Should there be a sudden loss of cabin pressure ..." She goes on to describe how oxygen masks will fall magically from the ceiling. She emphatically instructs us to place the masks on FIRST, before assisting the children.

Now, this strikes me as totally counterintuitive. I am a mother before I am anything else and the children's safety always comes first!

I am then reminded of my role as a physician. Day in and day out, we look after the needs of our patients and our team, dealing every day with the planned and unplanned events. It is our job to respond to other persons' challenges, both critical and mundane.

Not infrequently, I feel overwhelmed: The demands of others are too many. They come too quickly. And I know I don't have all the answers. Some challenges are very complex. For others, there appear to be no solutions. Home life can be equally confounding as one balances the disparate and often conflicting needs of spouse and children. In all this confusion, often there is very little time for meeting my own needs. Relaxation is often on the bottom of a long list. More often than not, relaxation doesn't take place at all.

I know that this describes the circumstances for many of you. Some of us have developed stress-related symptoms and problems worsened by poor health choices. Many are burned out: experience emotional exhaustion, feel disconnected from patients and feel much of our work has lost its meaning.

I have realized that self-care is **not** something that can be postponed indefinitely. Look to your left and look to your right. Although all of us are aging, can you distinguish those among us who take time to nurture

their own health and well being? Do you notice who among us appears worn and depleted and those who maintain their vitality in spite of ongoing challenges?

'Mindfulness' is a special way of taking care of yourself that many are not familiar with. It is the capacity to pay attention to what is happening, without the usual thoughts of worry, rumination and judgment. 'Mindfulness' is a quality of on-going awareness achieved by paying attention on purpose with an attitude of openness and acceptance. 'Mindfulness' can open a space in which one can relax, even while concurrently facing life's challenges.

Mindfulness' is an innate capacity that we all have. However, it is a capacity that can diminish as we hone our professional skills for multitasking, anticipation, rehearsal and analysis. The capacity to simply be at ease with life as it unfolds – aware, observant, focused, patient – can wither with the steady flow of demands upon us. Mindfulness training is one way in which we can learn to find a way to rest, amid unexpected pressure or chaos, even when there is a "sudden loss of cabin pressure."

Formal research has shown Mindfulness to be helpful in improving resiliency to stress. Hypertension, glucose dysregulation and other stress-mediated disorders have been demonstrated to respond favorably to mindfulness training. It has also been shown to improve the capacity to be present in an active, special way for loved ones and patients. Research has demonstrated reductions in physician burn out and improvements in physician empathy during and after mindfulness training. A physician participant has remarked about the program, "I have found the meditation practices very helpful in managing stress at home and at work. Things just seem to flow more easily. I don't know how I would manage without it."

The Center for Mindfulness

The Center for Mindfulness at LVHN is now in its 10th year. Co-founded by Susan D. Wiley, MD, Vice Chair, Department of Psychiatry (LVH), and Joanne Cohen-Katz, PhD, psychologist, the Center for Mindfulness has been providing mindfulness training to patients, nurses, residents and other health professionals. The Center offers quarterly groups for patients and hospital personnel. The team has now trained over 500 people in LVHN.

With the support of Medical Staff leadership, two new programs will be available to physicians and others. The first is a three-part eLearning series called "Mindfulness & Medicine" that will be available this August. This program is free and available to all hospital staff. Continuing education credits will be offered. This program reviews the relationship between stress and health, defines mindfulness and reviews the literature of its benefits for patients and health professionals.

In addition, "Mindfulness Training for Medical Professionals," a new program designed exclusively for physicians and advanced practice clinicians, will be offered this Fall. The purpose of this program is to offer physicians and advanced practice clinicians an opportunity to cultivate their innate capacity for mindfulness. The class will build on the information presented in the eLearning series and learn to practice meditation. The meditation will be supported by related discussion on topics such as mindful communication and the cultivation of compassion. Participants will be asked to practice mindfulness daily and will be supported in developing their own mindfulness practice. Rather than the usual eight-week format, this program will run for six weeks beginning Thursday, October 7, 2010. The program will be co-led by Susan D. Wiley, MD, and Larry Silberstein, PhD. The class will meet for two and one-half hours weekly. Participants will also be invited to attend a four and one-half hour retreat on Saturday, November 6. The cost of the program is \$450 and you will be able to earn CME credits for participation. As a demonstration of Medical Staff leadership support, participants who attend at least five of the six sessions will be reimbursed \$100 toward the cost of the program.

Because our lives are so demanding, it actually makes sense to "place the oxygen mask over your own nose and mouth" before attending to others. With mindfulness training, you will be able to find a way to rest, even during the flow of your complex and demanding life, and feel prepared for any "sudden loss of cabin pressure." Is the Micro List Bugging You?

Sometime in August, you will notice a change to the Lab and Micro listings in LastWord. In collaboration with the Antibiotic Stewardship Committee, the Clinical Decision Support Committee, and a cast of thousands, the lists have been reorganized to be more intuitive and user-friendly. The Micro list will be renamed "Pathogens/ Micro" and will contain all diagnostic studies (culture, PCR, rapid testing, etc.) that pertain to any form of pathogen (bacterial, viral, fungal, etc.). The list was cleaned up and non-standard abbreviations (i.e., BIP, BIT) were removed. Please note that the list will NOT contain any lab tests related to antibiotic levels or other medication related orders. Those orders will be found in the main Laboratory list.

It's 11 o'clock – do you know what facility you are at?

Please remember to choose the correct facility when entering orders from lists that break out the facilities. These lists include the Consults, Endoscopy Lab and Pulmonary Function buttons. LVH-Cedar Crest and LVH-17 sites are grouped together; and LVH-M is listed by itself. The Pulmonary Function button lists all three sites separately. If the incorrect site is chosen, the appropriate department is not contacted and the consult, service, or procedure may be delayed. Please remember to pay attention to the facility when choosing orders from these buttons.

LVHN PRIMARY CARE PRACTICES RECOGNIZED BY NCQA AS PATIENT CENTERED MEDICAL HOMESTM

Although definitions of "medical home" vary, the National Committee for Quality Assurance (NCQA) offers the most widely accepted national standard. In the Pennsylvania Chronic Care Initiative/PCMH pilot, NCQA recognition means that practices can qualify for enhanced reimbursement. Becoming an NCQA-recognized PCMH is very difficult, both the application and – more importantly – the practice transformation require leadership, teamwork and real commitment to patient care.

Congratulations to LVPG-General Internal Medicine for achieving the highest level of recognition – Level III, and to Fogelsville Family Medicine – the first practice in the Lehigh Valley to become NCQA recognized.

Strengthening our primary care base, through the creation of medical homes, is a goal of the Primary Care Initiative at LVHN. Strong primary care supports high value care in our network and supports the health of our community.

PHYSICIAN DOCUMENTATION

Post-operative Complications

It is very important to note that NOT all conditions that occur during or following surgery are classified as complications. In order for a condition to be coded and tracked as an operative complication, it must meet the following criteria:

- It must be more than a routinely expected condition or occurrence.
- There must be a cause and effect relationship between the care provided and the condition.
- There must be an indication in the documentation that it is a complication:
 - Sometimes this is straight-forward as in an operative wound dehiscence.
 - Other times the complication may not be obviously apparent and must be documented as a complication of surgery.
- It must modify the course of the patient's illness or the medical care required.

Only a physician can diagnose a condition (not a coder). If it is not clearly documented, a coder will query the physician for clarification.

Take Home Documentation Tips:

- Refrain from routinely using the phrase "POST-OP ______" (except perhaps "post-op day"). In coding terminology, the word "post-op" may give a false impression that a condition is a complication.
- Only state "Post-op _____" if you truly mean to link a complication with your surgery.
- Please state whether conditions occurring in the post-operative period are integral to the surgery or not.

ETHICS CORNER

You Are Not Alone . . . Ethics Resources at LVHN and Beyond

Often, healthcare providers are uncertain where to turn for advice or answers to ethical dilemmas. They often do not even know if the circumstances they are faced with are ethical dilemmas. Where do we turn for education in ethics?

First and foremost, the Ethics Committee is the main internal resource to assist with potential ethical dilemmas in patient care. Ethics consultations can be initiated by any hospital staff or patient/family member. An ethics consult does not need a physician order! Even if you are uncertain whether you should call a consult, contact the Ethics Committee at 610-402-6000. One of the Ethics "scouts" will discuss your concerns and help you decide the appropriate means of handling the situation. The goal is to more quickly identify those cases that need full consultation and those cases that are either not really appropriate for the Ethics Committee or that can be handled without using the resources of a full consult team. If a full consult is needed, the appropriate individuals will be brought together for a discussion followed by a recommendation to the staff caring for the patient. Scouts are available Monday through Friday from 8a.m. to 4 p.m.

The next internal source for education is the annual Ethics Symposium held every April during Ethics Week. In 2011, the Symposium will take place on April 5. In addition to regionally and nationally known keynote speakers, members of the LVHN staff will participate in breakout sessions along pre-hospital and hospital tracks. Continuing education credit for Medical Staff was offered this past year and will continue in the future. In addition to the symposium, a topic related to Ethics is usually presented at Grand Rounds in or around Ethics Week.

Other sources within the network include the Teaching Leader Series. Again, this program has an Ethics offering concerning Professionalism. The Department of Surgery has received a grant from the American College of Surgeons in the form of the Kamangar Ethics Award for resident instruction in Ethics. Only 15 programs per year are given this award which both recognizes commitment to Surgical Ethics Education and helps fund that education.



There has been a dramatic increase in Ethics Resources on the internet. 
