# Lehigh Valley Hospital Cited for the 13th Consecutive Year Among Best in U.S.



Lehigh Valley Hospital (LVH) ranks as one of the nation's top hospitals in three specialty care delivery areas in the 2008 *U.S. News & World Report* guide to

"America's Best Hospitals."

The 2008 list recognizes LVH among the nation's leading hospitals for:

LVH has made the *U.S. News* rankings 13 consecutive years – eight times for heart care and heart surgery – with a total of 28 specialty category listings in the past five years alone.

"All of us strive to consistently be the best at what we do," said Elliot J. Sussman, MD, Lehigh Valley Hospital and Health Network's (LVHHN) President and CEO. "At Lehigh Valley Hospital, our community has entrusted us with providing the highest quality care while ensuring the safety of our patients. This recognition by *U.S. News & World Report* demonstrates the commitment made every day by our physicians, nurses and staff to care for our community's health care needs." According to U.S. News & World Report, "America's Best Hospitals" assessed care in 16 specialties. Only 170 of 5,453 hospitals that were evaluated made the list in one or more specialties. In order to be considered, a hospital must meet one of three standards: membership in the Council of Teaching Hospitals (COTH), affiliation with a medical school, or availability of specific technology-related services. In each specialty, a hospital must perform a certain number of specified procedures on Medicare inpatients, or be cited by at least one physician as among the best in that specialty in the past three years of *U.S. News* surveys. These hospitals received a score that equally weighed reputation, mortality and certain care-related factors such as nursing and advanced services.

"I'm extremely proud of my colleagues, our nurses and our staff because their expertise, commitment and teamwork in caring for our patients have earned this distinction," said Linda Lapos, MD, President of LVHHN's medical staff of almost 1,200 physicians. # **From the President**

Patient safety, a common buzzword these days, means avoiding errors in patient care, and ensuring that our patients don't have bad things happen to them like falls, bedsores and hospital-acquired infections.

When the Pennsylvania Department of Health or The Joint Commission comes to inspect the hospital, they look for adherence to standards of patient safety. LVHN spends countless person-hours and dollars every year to make sure we meet and exceed these safety standards.

On the front lines of this effort, though, are the people in our organization who take care of patients every day. They know what works and what doesn't, and they know the day-to-day barriers to achieving the excellence to which we aspire. Tapping into this vast reservoir of knowledge and experience is the premise behind Patient Safety Walk Rounds – a process designed to make everyone a partner in patient safety. In Patient Safety Walk Rounds, Kristie Lowery, LVHN's Patient Safety Officer, and other members of the Quality and Patient Safety Department – often accompanied by a member of senior management – visit patient care areas and meet with nurses, technicians and other caregivers.

I recently had the opportunity to participate in Patient Safety Walk Rounds on MICU and SICU on 2K at the Cedar Crest campus. Nurses and other caregivers who attended were engaged and enthusiastic, offering their concerns and suggestions on patient safety issues in areas such as facilities, medications, communication, and equipment.

The hour went very fast. The mood was positive and professional, with a feeling of team spirit and a shared concern for excellence. Following the meeting, Kristie Lowery documented the concerns and followed up in writing on each issue. Some issues are already being addressed, and others will be addressed soon. Occasionally there's one that can't be solved immediately (such as installing an MRI in the Kasych Pavilion to make patient transport easier). Physicians and Advanced Practice Clinicians can play a major role in promoting patient safety. We should take seriously the concerns of our colleagues in nursing and other patient care disciplines. The more we encourage open communication and respect for their viewpoints, the more our colleagues will feel free to express their concerns.

Often, physicians are in the position to be most aware of patient safety issues. We should report these concerns to our division chiefs or department chairs, or to Patient Safety. Anyone in the Network can call the Patient Safety Hotline at 610-402-2830.

Patient safety is everyone's responsibility. As a team, we can continue to improve on LVHN's excellent record of providing a safe environment for our patients.

# **Medication Reconciliation on Discharge**

The hospital is developing a new electronic discharge instruction (DCI) process and began utilizing this system on TTU at Cedar Crest & I-78 and 6T at LVH-Muhlenberg in June. In order to accommodate the areas that have not begun using the new DCI product and to create a paper downtime system, a new discharge medication reconciliation document has been created. For those areas using the new automated DCI on discharge, discharge requirements are met when physicians use this product. For those areas still using paper, the old discharge/transfer sheets have been changed and will no longer have a place to list the medications.

Form # NSG-293 is now the official paper discharge form for medication reconciliation. This form is a duplicate copy form with the patient taking home the bottom copy. Physicians are responsible to reconcile a complete list of the patient's current medications on this form and provide a signature if DCI is not used at the time of discharge. Documentation needed by the physician on this form includes: Allergies and Reactions, Check boxes (New, Same or Changed), Name of Drug, Dose, Route, Frequency, Ending Date/Special Instructions, Script given check box as well as signature/date. Nurses will fill in Next Dose due and Leaflet given. Abbreviations for route and frequency should be avoided on this form for greater patient understanding and compliance in taking their medication.

# **News from Health Information Management**

#### History and Physical (H&P) Update

Effective July 1, 2008, podiatrists are eligible to perform History and Physical **updates** for operative procedures and admissions. The format of the history and physical document (MRD 03 Inpatient H&P and MRD 60 Ambulatory/Outpatient H&P) contain minor changes to accommodate the change in practice:

#### 1. Revisions to the signature line:

PA/Resident/CRNP\_\_\_\_\_Date\_\_\_\_

Credentialed Practitioner\_\_\_\_\_Date\_\_\_\_

#### 2. Revisions to the H&P Update box:

\_\_\_\_Pt Reports No Changes \_\_\_\_Changes Made Credentialed Practitioner\_\_\_\_\_Date\_\_\_\_ (required, if performed up to 30 days prior to admission/outpatient procedure)

#### **Dictation/Transcription**

A poorly dictated report requires greater attention and more time to decipher. It usually goes through multiple levels of review, which increases turnaround time. Even then, the end product is not as good, may contain blanks and require additional provider editing/correcting. Over the past several months, HIM TRX has maintained transcription turnaround time of <24 hours on all dictated medical reports. The following general dictation and speech tips are provided to assist with continually providing a quality medical document in a short period of time.

#### **General Dictation/Speech Recognition Tips**

- ... Try to *dictate in a quiet area* (away from machines, radios, fans, crowds); noises distort the clarity of your speech, making it difficult for the transcriptionist to interpret.
- ... Do not use cell phones for dictation.
- ... *Organize thoughts* before speaking, giving instructions at the end of the report.
- ... *Keep the phone at a consistent distance from mouth*, do not put mouth on phone.
- ... At beginning of report, *indicate date of service* (admission, discharge, etc.), *patient name.*
- ... Speak clearly and in a normal voice—does not have to be slow, just clear.

- ... Clearly *indicate the report type* you will be dictating.
- ... If you are a Physician Assistant, Resident or Certified Registered Nurse Practitioner dictating for a physician, please *indicate which physician you are dictating for* in the beginning of the report.
- ... Always state your name and the name of the patient you are documenting care for. Include at least one other identifier (e.g., birth date). Take care to spell the patient's name correctly (especially important with common names or unusual names).
- ... Speak sentences and phrases as close to possible as to how they should appear in the final document.
- ... Add punctuation (period, comma, colon, parenthesis, etc.), format (numbered lists, paragraphs, report headings, etc.), numbers, dates, etc., to the dictation.
- ... Follow the order of the format for each report type.
- ... Give *hints in areas that could be misunderstood*, such as ABduction or ADduction, hyPERtension and hyPOtension, one-five for 15, five-zero for 50.
- ... When listing medications, never abbreviate. Spell any uncommon drugs. Many drugs sound alike, so be very clear (e.g., Endal, Inderal, MiraSept, Mircette). Try to dictate dosage instructions consistently (in the same sequence) throughout.
- ... If you should require a carbon copy to be sent to another doctor, please say their first and last name as well as address if they are not on the LVH Medical Staff.

# **Physician Documentation**

#### Pneumonia

For coding purposes, documentation of pneumonia must be as specific as clinically possible. "CAP" or "communityacquired pneumonia" unfortunately is not sufficient to capture the usage of antibiotics and prolonged lengths of stay.

The Centers for Medicare and Medicaid Services (CMS) <u>require</u> our clinical opinion as to the most likely cause of the pneumonia. Example: aspiration, bacterial or viral.

If bacterial or viral is most likely, the clinician will be asked to identify a probable organism in order to capture the severity of illness.

Some cases of bacterial pneumonia may have an associated pleural effusion. If clinically appropriate, please specify the pleural effusion as bacterial.

Please consider documenting "communityacquired pneumonia likely due to <u>(organism)</u> with bacterial pleural effusion."

# **Bloodborne Pathogen Training for Physician/Dental Office Practices**

OSHA requires annual bloodborne pathogen training for all personnel who have risk of exposure to blood or other potentially hazardous materials while working in a medical or dental office. The LVHHN Infection Control Department is offering a training program for **physicians, dentists, nurses, office managers or other personnel** who are responsible for providing annual OSHA Bloodborne Pathogen Standard training to their staff. Other topics discussed will be the CDC Guidelines for Hand Hygiene, Community-acquired MRSA, Pandemic Preparedness Recommendations for the Office and Home, and Preventing and Controlling Multi-drug Resistant Organisms.

# Look What's New at LVH for Glucose Control

A new IV insulin protocol to be used for hyperglycemic control\* is being phased in across the Network. The new order set is a result of the Diabetes Management Quality Improvement Team's initiative to improve the glucose control of hyperglycemic patients consistent with the evidence based inpatient glucose management targets recommended by the American Diabetes Association (ADA).

IV insulin provides the most reliable and predictable means to control glucose in hospitalized patients. The literature is replete with studies supporting improved medical and surgical outcomes and reduced mortality when glucose control is maintained during the acute hospital stay.

The expanded use of the new order set is a result of a successful year-long pilot in trauma. Besides TTU and TNICU, presently the new order set is available for use in the following units at the Cedar Crest site: ACU, PCU, MICU, SICU, and NSICU. Over the course of the next 6-12 months, use will expand to include all critical care and med/surg units at all sites. (The old IV insulin infusion protocol still exists for use in all units not mentioned above.)

To locate the IV insulin order sets, both the new set being used in the select critical care units noted above and the existent order set available for use in all other units, click CAPOE ORDER SETS. Scroll to INSULIN ORDER SETS and select one of the two order sets for hyperglycemic control based on the location of your patient. Currently, the new IV insulin order set ("Insulin IV Infusion for Hyperglycemia") listed under "Pilot" <u>must</u> be used for patients on TNICU, TTU, ACU, PCU, MICU, SICU, and NSICU in order to standardize workflow. Want to avoid a call back from the nurse after ordering an IV insulin infusion? Remember to:

- ... Specify infusion start time
- ... Discontinue all previous diabetes medications
- ... Order a primary IV solution

Specific points to remember when ordering the <u>new</u> IV insulin order set include:

- ... Select one of two target blood glucose ranges for insulin titration
  - 80-110 mg/dl target range-suggested for all ICU settings OR
  - 90-140 mg/dl target range-optional range for ICU settings and all other non-critical care areas
- ... Select the appropriate nutritional status-NPO, tube fed, or eating. If the patient will be eating, a rapid acting, meal-based subcutaneous bolus must be ordered in addition to the IV insulin infusion. (A fed patient requires rapid acting bolus insulin to curtail post-prandial BG elevations not adequately addressed with IV insulin alone. The new order set provides this option.)

# Who's New
