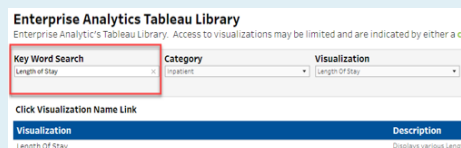

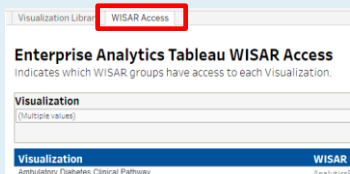
## Reporting Tips for Tableau

### Tableau Library

The **Tableau Library** is a search aid for identifying all available Tableau Dashboards currently available. Dashboards can be searched by category, specific visualization, or by the **Key Word Search** which will look for words featured in the name of the visualization, the description, and by tags added on the back end by the developers.

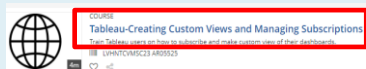


A WISAR group is needed to gain access to the Analytics Portal as well as a specific dashboard. The **Wisar Access** tab of this dashboard allows users to identify what WISAR groups are needed for access once a user has identified a Tableau they wish to view.



### New Video in TLC on creating and managing custom views in Tableau

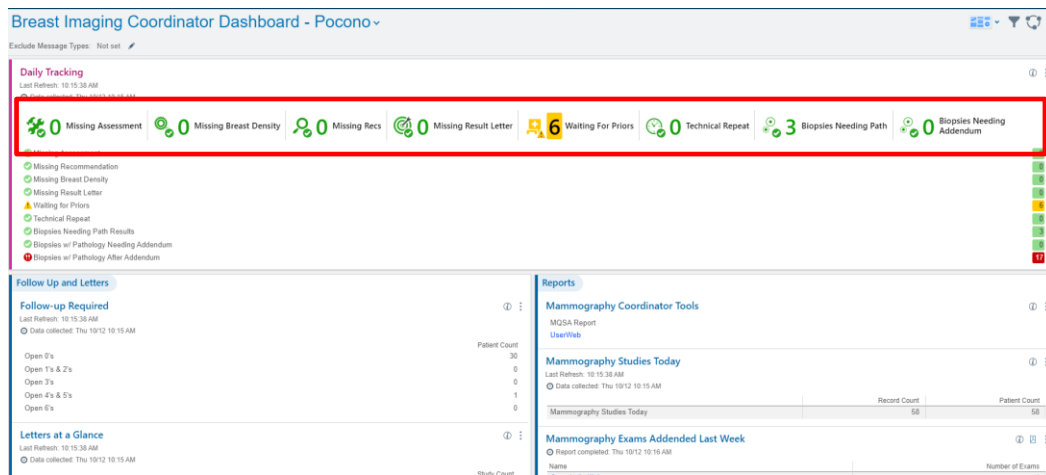

## Breast Imaging Module

The implementation of the Breast Imaging module (replacing Magview) has been a long time coming for our Imaging departments. The Enterprise Analytics team was part of this implementation process by designing custom dashboards for each of the Breast Health Service areas (Hazleton, LVHN, Pocono, Schuylkill, and Steamtown). In each of these dashboards, we created area specific reports that look at Exams Added, Exams not final, and Technologist productivity. Also included is Daily Tracking, which is used to track daily activities. Although the amount of analytics is minimal to support this implementation, the ability to collect and report data in the future will be invaluable.

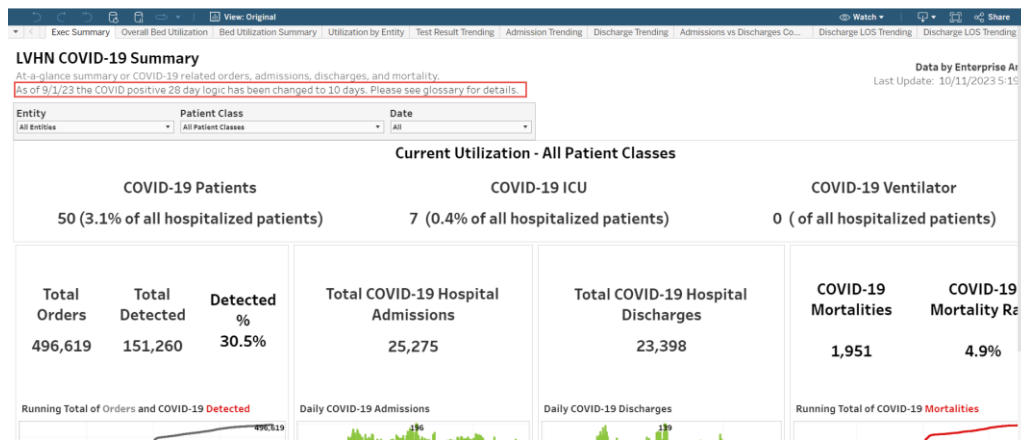
### Epic Dashboard: Breast Imaging Coordinator Dashboard-Pocono



## Covid Updates

There has been an update to the logic behind the **COVID-19 Bed Management dashboard** as to the days a patient is considered Covid positive. When we initially went live with this dashboard, a rule was created that a patient was considered Covid positive, 28 days before and after a positive COVID test result. This has been updated to 10 days. This now referred to as the 10-day rule. This change has been implemented as of 9/1/23. This logic change only impacts the Bed Management dashboard. Other Covid dashboards utilize just a positive test or vaccine date as data triggers.

Please note the reference in the Glossary has been updated to reflect this change.

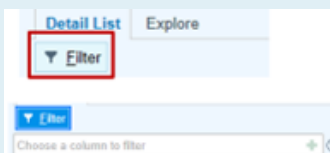




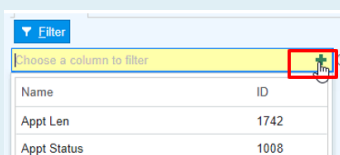
## Reporting Workbench

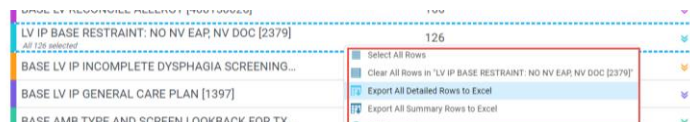

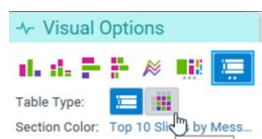
## Epic Upgrade

On **November 05**, there will be a quarterly Epic Upgrade. With this upgrade, there will be more intuitive workflows for viewing and filtering reports, new features to SlicerDicer, and updates to Epic Radar Dashboards. Here are some upgrade highlights.

**Export Summarized SlicerDicer Data to Excel**-Users can now explore summarized data from SlicerDicer's detail table visual option in Excel. To do so, select Export Summary to Excel from the right-click menu in the detail table. **\*\*Note: This is only for users who have exporting access.**



**See Relationships with the Crosstab Visualization in SlicerDicer**-The crosstab visualization, which is like a pivot table, introduces the ability to group columns, slicing data both vertically and horizontally.



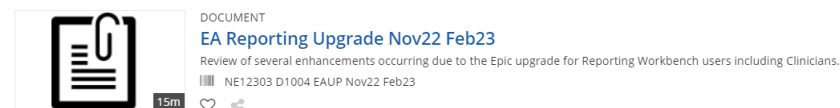
**Put a Face to a Name with Provider and User Photos**-Photos now appear in scorecards, metric components, and Epic dashboard headers to help you put a face to a name.

## Crystal Report Transition

As part of the Crystal report transition project, the LV Visits Per Provider (and Location or Department) per Day crystal report has been replaced with the **LV Completed Visits per Provider per Day** and **LV Completed Visits per Provider per day-Face to Face** reporting workbench reports. As with other workbench reports, these can be customized and modified for your specific needs. The link on Ambulatory Manager Dashboard also has been updated with the new Face to Face report to match the parameters set on the Crystal report being retired. There are also three other crystal reports that are being retired. The LV Average Encounter Times, LV Average Encounter Times by Login Department, and LV Average Encounter Times by Provider Breakdown, which have been replaced with the **LV Average Encounter Times** reporting work bench report.
