# Progress Notes: Financial Planning 101

Starting your residency or your first job as an attending can be among the most exciting moments in your career. You did it! You graduated from medical school! You finished your residency or fellowship! You started your first "real job!" You may be well trained to make medical decisions, but you may not feel as prepared to manage your finances. How will you repay your loans? Are you living within your means? Do you need to buy life and disability insurance policies? When should you buy a home? Should you send your children to public or private school? What are the best strategies for saving for retirement?

Getting your finances in order early in your career can give you the freedom to focus on what really matters to you: Taking care of your patients and enjoying the company of family and friends. Warren Buffett makes financial planning sound so simple. "You only have to do a very few things right in your life as long as you don't do too many things wrong." Getting things right can be daunting if you are not financially literate.

If you do not have the knowledge or the inclination to come up with a financial plan, perhaps you should consider getting a financial consult. Below are several resources LVHN provides to help you plan your

future.

### Restructuring student loans

According to the American Association of Medical Colleges, the average debt of medical school graduates in 2019 was \$196,520. After eight years of school, many young physicians have to continue to put their lives on hold so they can repay their student loans. Even their choice of specialty may be affected by how much they owe.

Practicing medicine is difficult enough without the additional stress of managing this crushing debt. There are three main strategies to reduce your student debt:

- 1. Switching repayment plans
- Seeking forgiveness
- 3. Reducing your interest rate by refinancing.

Choosing the right strategy is complicated because there are so many variables to consider. Are your loans federal and/or private? What is your current income? Marital status? Future earning potential? Do you qualify for the Public Service Loan Forgiveness Program? Should you choose the Income Based Repayment or Pay-As-You Earn Repayment plans? These options can be baffling.

In 2017, LVHN contracted the company Navigate to provide free consultations to employed physicians and APCs on how to reduce their student debt. # Lehigh Valley Heart Institute Partners With Colleges on Clinical Education Program

A new agreement between two
Pennsylvania colleges will result in
students receiving clinical education at
Lehigh Valley Heart Institute. The
agreement allows Northampton
Community College (NCC) students to
transfer to Harrisburg Area Community
College (HACC) to obtain an associates
degree in cardiovascular technology.
Students will then apply to a 15-month
clinical program offered at Lehigh Valley
Heart Institute.

Heart disease is the leading cause of death nationally and in the state of Pennsylvania. "As the health needs of the greater Lehigh Valley area continue to grow, this program will equip students with the knowledge they need to care for



patients," says Vincent Tallarico, Lehigh Valley Heart Institute Vice President. "We are excited to have this partnership to address the local need associated with this important profession and the prevalence of heart disease."

Starting in fall 2019, NCC students interested in cardiac sonography or invasive cardiovascular technology can take their general education requirements at NCC and then apply to HACC to take the final coursework to earn their degree. Through HACC, the NCC students will complete one online class and two classes at HACC's Lancaster campus. Students will then apply to the clinical program at Lehigh Valley Heart Institute.

# **CARES Program Provides Bountiful Benefits**

The Continuous Ambulatory Remote Engage Services (CARES) program provides patients the opportunity to manage their chronic diseases from home.

## **Program overview**

- Patients are given devices to test biometric data and trained how to test properly.
- Patients enter daily vital signs and answer screening questions on their personal computer or smartphone.
- A centralized team of nurses reviews the patient's self-reported data and intervenes as necessary with the patient's LVPG provider.
- Nurses educate patients on importance of daily testing, medications, nutrition, chronic illness selfcare and chronic disease management.

#### Who can enroll

- Patients who are newly diagnosed with a chronic health condition or have an existing chronic health condition
- Patients who are high risk for admission or readmission to the hospital
- Patients who would benefit from daily support in management of their chronic condition

### **Patient benefits**

- Reduce inpatient admissions for chronic diseases by monitoring patient's vital signs from home
- Patients can monitor and trend their own vitals, giving them a better understanding of their health status
- Patients enrolled in the COPD program reported feeling more involved in their care because of remote monitoring

### **Provider benefits**

- Peace of mind that your patients are being cared for in between office visits
- Access to track and trend patient-entered vital signs
- Potential to reduce number of office visits for patients who are regularly entering vitals
