On any given day at Lehigh Valley Hospital, talking about ethics usually brings one person to mind — **Joseph E. Vincent, MD.**

In 1982, with the help of some outside consultants, a number of medical staff and the hospital attorney, Dr. Vincent began discussions of an ethics process in the hospital. With assistance from Stephen E. Lammers, PhD, the hospital formed the Ethics Committee in 1983 with Dr. Vincent serving as its first Chair.

In the 25 years since the ethics process began, Dr. Vincent has served off and on as Chair of the Ethics Committee. Most recently he has served in this capacity since July, 2003 through June, 2007, when he stepped down as Chair. A number of other physicians have also served as Chair of the Ethics Committee — John E. Castaldo, MD, Alexander D. Rae-Grant, MD, Gerald P. Sherwin, MD, Gina M. Karess, MD, and Glenn A. Mackin, MD.

According to Dr. Lammers, who has worked closely with Dr. Vincent since 1982 and who joined the hospital's staff in 1987 as an Ethics Consultant, Dr. Vincent has been at the forefront of issues in medicine closely related to ethics. These include pain control and palliative care. In addition to educating himself through seminars in ethics in this country and abroad, he went to EPEC (Educating Physicians about End of Life Care) training sessions and brought EPEC to the hospital. He also obtained grants to help in this area and arranged for speakers to talk about ethics and related issues. As a result, LVH has hosted many of the major figures in bioethics in this country.

On July 1, Robert D. Barraco, MD, MPH, began his term as the new Chair of the Ethics Committee. According to Dr. Barraco, "The Ethics Committee is essential to the continued growth of Lehigh Valley Hospital and Health Network. It is a

From the President

Dr. Ron Swinfard, Chief Medical Officer, made some interesting points in two "Fireside Chats" with physician-fellows of the Institute for Physician Leadership recently, and they're worth repeating here.

The Institute is a two-year program of lectures, discussions and seminars designed to develop leadership skills in members of the Medical Staff, both private and employed.

There's been a tremendous amount of change in our organization, Ron acknowledged, including growth of the hospital and the network, and also including changes in top management. These management changes include the departure of Lou Liebhaber, the retirement of Michael Weinstock as Chair of Emergency Medicine, and the departure of Wayne Hess, Chair of OB-GYN, for a similar job at a new medical school in Roanoke, Va.

These management changes, combined with the recent attention to length of stay and the fact that admissions were below expectations, have led to rumors, Ron said, of financial problems, a management shakeup, and even impending staff layoffs. He dispelled those rumors and gave his view of the issues.

The management departures were coincidence, he said, nothing more. The network's financial status is good, he said. The lower-than-expected admissions were probably due to a combination of the construction project at Cedar Crest, the increased lengths of stay, and a need for more attention to throughput issues.

The length-of-stay and admission issues were ably addressed by the Turn Around Team with cooperation from the Medical Staff. This has led to increased patient access and new efficiencies at our Muhlenberg, Cedar Crest and 17th & Chew campuses. There will be ongoing efforts to enhance administrative efficiency.

During this period of change and growth, with many new members of the Medical Staff, Ron said one of his main priorities is to help ensure that we maintain the culture of the organization as one that is collegial and cooperative, and that remains focused on excellence.

He acknowledged the concerns of physician-attendees about the challenges of maintaining standards of clinical excellence while increasing admissions, and

pledged to remain focused on that issue.

On the topic of financial performance, the LVHN Board of Trustees recently approved the network's Fiscal Year 2008 budget. Dr. Elliot Sussman, President and CEO, reviewed financial performance for the year just ending and provided a look ahead, at the June meetings of the Medical Executive Committee and the General Medical Staff.

The bottom line on financial performance: While the surplus of earnings over expenses for Fiscal Year 2007 was somewhat lower than expected, the network remains in very good financial shape, and another substantial surplus is expected in Fiscal Year 2008.

This surplus, he told the Medical Staff, will ensure that the network continues to be able to make substantial investments in community service and in projects to benefit patients and the community in and around our Cedar Crest, 17th & Chew, and Muhlenberg campuses.

ROC DOCs Moving Along!

As the summer of 2007 rolls in, the ROC DOC group continues to meet, with the fourth ROC DOC meeting occurring Monday, June 18. Edward M. Mullin, Jr., MD, welcomed the group and performed a “pulse check” of the ROC DOC group. He posed some questions to the group to help generate some ideas about what life will be like in the new Kasych tower:

- ... Knowing what you know right now, what ONE THING would be unacceptable if this was found to be true when you care for patients in Kasych?
- ... In a realistic world, what ONE THING would make you ecstatically happy when you begin to see patients in Kasych?
- ... What single process improvement do you think should be made when Kasych opens for business? In other words...what would you like to see us NOT do in Kasych that we're doing now? (“out with the bad...in with the good”)
- ... It's June 2008. What would you like to hear your patients say to you about their experience as a patient at LVH in Kasych?

One of ROC DOC's own, Ralph A. Primelo, MD, Division of Consultation-Liaison Psychiatry/Psychiatric Ambulatory Care, provided a presentation on some techniques to battle stress and change, a well embraced topic. Here are some highlights from Dr. Primelo's presentation:

- ... Identify the stress in yourself.
- ... If you have something planned away from work, just knowing you have it planned will help reduce stress levels.
- ... Bust stress – extreme measures are not mandatory!!
- ... Problem-solve – solicit someone to assist you.



Brian Hardner, Vice President for Facilities & Construction, provided an update on the campus construction activity. During June and July, they will be opening the first major clinical component of the Kasych Expansion project: two new operating rooms will be coming online.

Molly Sebastian, Vice President of Patient Care Services, updated the ROC DOC group on the Staffing Committee's progress. The committee started meeting in October 2006. So far, every position in the Kasych tower has been filled with the exception of 2-3 night shift positions that are still vacant. A cost center has been set-up to capture the cost of these new hires.

Cytology and Flow Cytometry Now On-Line

The paper order sheets that have been used for Cytology (Gyn and Non-Gyn) and Flow Cytometry have been converted to online orders. All of the required fields have been included, and there are drop-down menus to facilitate data entry. The orders are located in the main Lab list and also in the Micro List. The order will print on the unit (to attach to the specimen) and will also print in the cytology lab. Please remember to use these on-line orders as the paper order sheets will eventually be removed from the in-patient units.

Ordering Potassium? Now you can see the latest level

A new expert rule has been added to the system. When ordering potassium supplements, an alert will pop up IF there is a recent abnormal potassium level, or IF a recent potassium level is not found in the system. If the recent potassium level was normal, no popup will appear. The same alert will appear when pharmacy verifies the order. This rule should improve patient safety regarding use of this medication. Please provide feedback to the CAPOE team regarding the usefulness of this rule. The Clinical Decision Support Team is considering applying this rule to other high-risk medications (i.e., anti-coagulants).

Exiting out of LastWord

Although I don't understand why anyone would ever want to or need to get out of LastWord, there are times when users must close the application. When doing so, please remember to click on the "Logoff" button with the STOP sign icon. Do NOT click on the X in the upper right hand corner of the screen. Clicking on the X could lead to problems when you try to log on again.

New Lab Priority = "L"

A new priority for lab tests has been created. The "L" priority is to be used for labs that should be drawn right away, but that could be run routine. This priority could be used when ordering blood cultures or time related tests (vancomycin levels, etc.).

Physician Assistant Regulations Revised by State

The Pennsylvania State Board of Medicine revised the regulations for Physician Assistants (PAs) effective November 18, 2006. These revisions, which apply only to PAs supervised by allopathic physicians and allow for an expanded scope of practice, were approved at the Medical Executive Committee meeting on April 3, 2007.

Highlights of these revisions are as follows:

Pronouncement of Death

The final regulations allow a Physician Assistant to pronounce death. However, they may only pronounce those patients of their supervising physician or the group to which their supervising physician is associated. This must be expressly set forth in the written agreement. The attending physician is responsible for notifying the family, asking for autopsy consent, and documenting the cause of death on the death certificate.

Order and/or Administer Blood and Blood Products

The final regulations allow a Physician Assistant to order and/or administer whole blood and blood components if the authority to order and administer these fluids is expressly set forth in the written agreement.

Order and/or Administer Schedule 2 Drugs

The final regulations allow a Physician Assistant to order and/or administer controlled substances including Schedule 2 drugs if the authority to order and administer these medications is expressly set forth in the written agreement and their current DEA includes Schedule 2.

Physician Assistants interested in requesting/exercising the new privileges listed above will need to amend their written agreement with the State. In addition, a "Request for Additional Privileges" form must be obtained, completed, and returned to the Office of Medical Staff Services along with the amended written agreement. All requests for additional privileges require approval by the Credentials Committee, the Medical Executive Committee, and the Boards of Trustees before they may be exercised.

Construction Update

With the ongoing construction at Lehigh Valley Hospital, the following information may be helpful for you and your patients when visiting the Cedar Crest & I-78 campus:

Highway Improvement Project

- ... Road widening and earthwork continue on both sides of Cedar Crest Blvd. and Fish Hatchery Rd.
- ... Storm line crossing beneath Fish Hatchery west of Cedar Crest Blvd continues.
- ... PPL crews will install overhead utilities.

PennDOT Project

- ... Beginning the week of July 9, PennDOT will be repairing the drive lanes on Cedar Crest Blvd. at the hospital entrance intersection. Lane shifting will be necessary. Work will be done from 7 p.m. to 5 a.m. to reduce disruption (weather permitting).
- ... Overlay paving of Cedar Crest Blvd. from Chestnut Street (Emmaus) to Fish Hatchery Road continues.

Site Renovations on Campus

Parking Lot 4 (South of the 1230 Building)

- ... Demolition has started in preparation for the new Emergency Department access road.
- ... Night-shift colleagues who regularly park in Lot 4 should park on either level of the parking deck in front of the hospital.
- ... Patients are directed to park in the five-story deck along Cedar Crest Blvd. A patient drop-off area is available on the side of the 1230 building.

- ... The front detention basin is completed.

- ... Grading for the parking expansion in Lot 11 continues.

- ... The installation of the foundation walls and interior column footings continue.
- ... Installation of precast concrete has begun.

LVH Echocardiography Laboratories Earn Accreditation

The Heart Station/Echocardiography Laboratories at Lehigh Valley Hospital-Muhlenberg and Lehigh Valley Hospital-Cedar Crest were accredited by the Intersocietal Commission for the Accreditation of Echocardiography Laboratories (ICAEL). These laboratories join only 21 hospitals in Pennsylvania to earn this recognition and are among two of the first 1,000 echocardiography laboratories in the United States, Canada and Puerto Rico.

This accreditation recognizes the labs' commitment to high quality patient care and the provision of quality diagnostic testing. To receive accreditation, a facility is reviewed by an independent agency to gauge the lab's commitment to quality testing for the diagnosis of heart disease.

The ICAEL was established with the support of the American Society of Echocardiography (ASE), the

American College of Cardiology (ACC) and the Society of Pediatric Echocardiography (SOPE) to provide a peer review mechanism to encourage and recognize the provision of quality echocardiographic diagnostic evaluations by a process of voluntary accreditation. The ICAEL is dedicated to ensuring high quality patient care and to promoting health care.

New Database: AnthroSource as a Source for Qualitative Research Methods

Research in medicine has often focused on strictly quantitative methods - those that rely heavily on compiling numerical data. Qualitative research relies on data collection through methods such as interviews, focus groups or observation. Techniques from both forms of research are being applied more frequently in biomedical research because many health issues involve social and cultural aspects that may be better assessed via qualitative methods.

With the increased emphasis on evidence-based research, cultural diversity, and the combination of qualitative with quantitative study methods, anthropological literature has become increasingly important in the medical and nursing fields.

Produced by the American Anthropological Association, **AnthroSource** covers literature dealing with research, teaching and the profession of anthropology. AnthroSource can provide articles that detail various methods of performing qualitative research. The database includes **Medical Anthropology Quarterly**, an international journal encompassing ethnomedicine, epidemiology, nutrition, health care providers and services, health policy, public health, and the language of healthcare. There are over 40,000 full text articles available through AnthroSource.

Dr. Keblish spoke on the contributions of the LCS Mobile Bearing Knee regarding design, surgical technique and patella management to the development of understanding knee replacement since 1977.

Lehigh Valley Hospital-Cedar Crest & I-78 was one of 17 learning centers (under Dr. Keblish's supervision) that participated in the FDA-IDE Evaluation of the Mobile Bearing Total Knee Concept from 1981-1993. During that time, LVH hosted learning centers and surgical visitations dedicated to teaching new aspects and approaches in total knee replacement. The moveable bearing knee has been the only total knee (to date) that required a full FDA-IDE clearance. The rotating Platform Knee is now an accepted, proven design that is utilized world wide.



Vadim A. Levin, MD, Division of Cardiology, presented his research project – "Interatrial Conduction Measured During Biventricular Pacemaker Implantation Accurately Predicts Optimal Paced Atrioventricular Intervals" – at the American College of Cardiology 56th Annual Scientific Session, held March 26, in New Orleans, La. Results of this study were published in Volume 18, Number 3, March 2007 issue of the *Journal of Cardiovascular Electrophysiology*.



Daniel D. Lozano, MD, Chief, Division of Burn, was a clinical investigator in a multi-center study and co-author of the paper that was published in the May/June issue of the *Journal of Burn Care Research* (2007;28:401-408). The paper is titled "Comparison of fibrin sealant and staples for attaching split-thickness autologous sheet grafts in patients with deep partial- or full-thickness burn wounds: a phase 1/2 clinical study."
