From the President

s anyone feeling a little more stressed these days?

I don't know about you, but the needle on my personal stress meter is up, not down.

Taking care of patients is a stressful job by its very nature. And then you tack on added stresses like reduced reimbursements, competition from other physicians, intensified monitoring of quality performance, pressure to adopt new technologies, and the difficulty of recruiting new colleagues Something else I've noticed lately is a little more impatience and lack of consideration in personal interactions. When people are stressed, they sometimes don't treat their fellow physicians – and other coworkers – with the respect they deserve.

A related factor, I think, is reduced communication. Sure, we all have our hightech communications devices, but the more cell phones and pagers and laptops and Treos people use, the less time they seem to spend in good old-fashioned personal conversation. We don't hang out with each other. We don't ask about the kids and the dog as much as before. We don't talk.

Since Ron Swinfard, MD, Chief Medical Officer, mentioned his observation of physicians' uncivil behavior to each other at the last General Medical Staff meeting, several physicians have shared with me their own examples, as well as their feelings of dismay and even their fear that the traditional collegiality among physicians is disappearing.

I think it's time for each of us on the Medical Staff to have a personal goal of

not letting the stresses and busy schedules of our day get in the way of polite and friendly conversations with other doctors, with allied health professionals, with nurses, with case managers, with patients, and yes, even with administrators.

Our Network and Medical Staff members are dedicated to high standards of quality patient care and professionalism, and I think we owe it to ourselves and to our colleagues to have the same dedication to polite personal interactions. We also owe it to the medical students and residents who learn from our example.

What should you do when you encounter a colleague who is not on the top of his politeness game? Start off by taking a step back and cutting him a break. Consider his stresses and hectic schedule before you respond in kind.

There's one final reason we should focus on this new personal politeness goal: Being nice to people makes you feel good. And it reduces stress, too!

Lehigh Valley Health Network to Accept Aetna Insurance

Lehigh Valley Health Network (LVHN) and Aetna have reached agreement under which LVHN hospitals, primary care and specialist physicians and other health care providers will participate in the Aetna network, effective December 1, 2007.

Under this agreement, Aetna subscribers will have in-network access to all LVHN locations including: Lehigh Valley Hospital – Cedar Crest & I-78, Lehigh Valley Hospital – 17th & Chew, Lehigh Valley Hospital – Muhlenberg, and the 360-member Lehigh Valley Physician Group (LVPG). Physicians who are on staff at the LVHN hospitals but not members of LVPG also were given an opportunity to participate during an enrollment period.

"This agreement gives Aetna's 50,000 members in our community access to LVHN services," said Elliot J. Sussman, MD, LVHN's President and CEO. "At the end of the day, it is about providing our community with greater access to high quality and safe care."

Dr. Sussman said the demand for care continues to grow and that makes the timing of the partnership with Aetna even more critical for the community. He said bed use at LVHN grew by about 2,000 over the past year to more than 54,000 inpatients. Emergency department visits increased to more than 129,400, up 10,000 compared to the previous year.

"Our new seven-story Kasych Family Pavilion patient tower will open at the start of the new year and that will ensure greater access to better meet that demand, not only for those who subscribe to Aetna, but for our entire community," Dr. Sussman said.

Aetna subscribers in the Lehigh Valley can contact their physician beginning November 1, once physician credentialing has been completed, to determine if he or she is part of the Aetna network.

LVHN was last part of the Aetna network in 2004, when a previous agreement with Lehigh Valley Hospital-Muhlenberg expired and was not renewed. The LVH sites at Cedar Crest & I-78 and 17th & Chew have not been part of the Aetna network since 2001.

LVHHN Named a "Top Hospital" by The Leapfrog Group



Lehigh Valley Hospital and Health Network has been named a "Top Hospital" for 2007 by The Leapfrog Group. Leapfrog represents many of the nation's largest companies and public agencies that

buy health benefits for their employees and in doing so, aims to initiate improvements in the safety, quality and affordability of health care.

This is the first time LVH has made the list, which includes just 41 hospitals nationwide out of 1,285 that responded to the Leapfrog Hospital Quality and Safety Survey. LVHHN is the only local hospital designated, and one of only three in Pennsylvania to make the list.

The designation is significant for our patients and our community because the hospitals included are considered by Leapfrog to offer the highest quality and patient safety through the implementation of key practices. Leapfrog emphasizes the implementation of quality and safety practices like:

- ... The use of computer physician order entry (CPOE)
- ... ICU physician staffing with tele-intensivists
- ... How well hospitals perform seven high-risk procedures and care for three high-risk neonatal conditions
- ... How hospitals are progressing with a specified series of nationally-endorsed safe practices, including compliance with hand-washing guidelines, preventing catheter-related infections and timely communication for caregivers and patients

This recognition is another example of the hard work, dedication and commitment of the physicians and employees of Lehigh Valley Hospital and Health Network.

AHRQ Award Granted to EPICnet

The Eastern Pennsylvania Inquiry Collaborative/ Network (EPICnet), in collaboration with CNA Corporation of Washington, DC, and Thomas Jefferson University in Philadelphia, will participate in a \$250,000 Task Award from the Agency for Healthcare Research and Quality. The task award is to study screening for patients at risk for colorectal cancer and demonstrate increased screening rates.

EPICnet will work with the Lehigh Valley Physician Hospital Organization (LVPHO) to identify Valley Preferred patients at risk by age for colorectal cancer. Unscreened patients will be identified and offered screening consistent with the current guidelines of the U.S. Preventive Services Task Force and American Cancer Society. LVPHO support was crucial in winning the task award.

Patient Safety

2007 National Patient Safety Goal 15A – The Organization Identifies Patients at Risk for Suicide

One of the new National Patient Safety Goals for 2007 focuses on patients who may want to harm themselves. The goal states that the organization identifies patients at risk for suicide. Why would Joint Commission choose this goal as one of the National Patient Safety Goals? Their rationale is that:

- ... Suicide ranks as the 11th most frequent cause of death (third most frequent in young people) in the United States, with one person dying from suicide every 16.6 minutes.
- ... Suicide of a care recipient while in a staffed, roundthe-clock care setting has been the #1 most frequently reported type of sentinel event since the inception of the Joint Commission's Sentinel Event Policy in 1996.
- ... Identification of individuals at risk for suicide while under the care of or following discharge from a health care organization is an important first step in protecting and planning the care of these at risk individuals.

Not only is there evidence that *medical* providers may encounter possibly depressed or suicidal patients, but there is also a clear link between depression and medical illnesses themselves, which should heighten awareness of the possible risk of suicide. Research has shown that heart disease, stroke, Parkinson's, diabetes and cancer can cause depression, which may in turn prompt a risk for suicide.

For the past year, a multidisciplinary committee has worked on a process to meet this safety goal. The process is as follows:

- ... All patients with a *primary diagnosis* of emotional or behavioral health disorders, as well as substance abuse, will be screened for suicide risk. Screening will be done in the Emergency Department, inpatient units, Behavioral Health, and outpatient clinics.
- ... Patients will be asked "Do you currently have thoughts of hurting yourself?"
 - A negative response will end the screening process. Documentation on the record needs to indicate the screening was completed.

- A positive response will prompt a risk assessment by Psychiatric Evaluation Services in the Emergency Department and a Psychiatry Consult on inpatient areas. (Behavioral Health programs follow a formal risk assessment process for each patient as the evaluation indicates).
 - × Appropriate treatment and interventions are provided to the patient and include providing a safe environment and assignment of a 1:1 caregiver.
 - Documentation of screening/ assessment and appropriate interventions needs to be included in the progress notes.

Monitoring of the process implemented confirms that Lehigh Valley Hospital is in compliance and that staff are identifying patients at risk for suicide.

Prevention of Wrong Site Procedures

Wrong site surgery is the second most reported sentinel event reviewed by the Joint Commission since 1995. It is important that all providers and staff comply with the universal protocol which involves three steps:

- ... Pre-operative verification process
- ... Marking operative site
- ... Performing a "time out" before starting the procedure

This needs to be completed for *ALL* invasive procedures regardless of where they occur (i.e., operating room, bedside, nursery, cardiac cath lab, radiology, etc.). Before any invasive procedure begins, the team must verify that it is the correct

patient, procedure, site, position, and implants or equipment that may be needed for the procedure. There are **NO EXCEPTIONS** to this process. For the safety of patients, all staff are responsible to perform the identification of the patient and perform the time out process before any invasive *procedure.* Please refer to the list of bedside procedures that require a "time out."

Who Really is the Attending for this Patient?

In December, you will notice a change to the Discharge Patient orders in the system. A new field has been added -"Attending of Record." This is a required field that will be used by Medical Records and other departments to assist in assigning the patient to the appropriate attending. Consequently, whoever is entering the Discharge Order will be responsible for completing this field. This should decrease the confusion over responsibility for the chart, etc. The idea for this change came through discussions at the Chairs/Troika meeting, and was approved by the Medical Executive Committee on October 2, 2007.

New Expert Rule - Knowing the Hgb When Ordering Epogen

In light of recent research data, the FDA has issued the following warning regarding Epogen, Procrit and other Erythropoetin Stimulating Agents: Patients in the clinical trials with hemoglobin > 12 gm/dL who have been given ESA's have experienced increased mortality and cardiovascular events, potential for tumor growth progression and higher rates of hypertension. For this reason, the system will institute an expert rule\pop-up warning for any patient with a hemoglobin > 12 gm/dL and being initiated on an ESA therapy. Regional Heart Center Plans Heart Failure Unit

The Regional Heart Center is addressing the region's increase in patients with congestive heart failure with the

creation of the Center for Advanced Heart Failure, which is scheduled to open in January.

The 12-bed inpatient Center for Advanced Heart Failure, which will be located within PCU on the third floor at LVH — Cedar Crest & I-78, will increase adherence to the current heart failure guidelines, resulting in the highest quality of patient care. Patients will receive disease-specific monitoring, frequent assessment, optimized drug therapies and individualized education. The Center will feature standardized care and evidence-based clinical practice, and offer opportunities for participation in clinical trials.

The nursing staff in the Center for Advanced Heart Failure will have advanced expertise, making them better qualified to treat the complexities of the disease and to prepare patients for the self-management of their illness at home.



Ronald S. Freudenberger, MD, who joined the Medical Staff in August, will serve as medical director of the Center for Advanced Heart Failure. He brings more than 11 years experience in treating advanced heart failure, having previously

served as director of heart failure and transplantation for the Robert Wood Johnson Hospital and Medical School in New Jersey and director of transplant cardiology at the University of Maryland. He will work closely with Donna Petruccelli, MSN, CRNP, heart failure nurse specialist and coordinator of the Center, to design and operate the program and treat its patients.

Dr. Freudenberger and Ms. Petruccelli will lead collaborative rounds on the unit and be available for consultation in the management of patients with advanced heart failure. This service will ensure that evidence-based medications are initiated and that optimal target dosages are achieved.

ment of Family Medicine, has received Recognition from the Heart/Stroke Recognition Program for providing quality care to his patients with cardiovascular disease or who have had a stroke.

The Heart/Stroke Recognition Program was designed to improve the quality of care that patients with cardiovascular disease or who have had a stroke receive by recognizing physicians who deliver quality cardiovascular and stroke care, and by motivating other physicians to document and improve their delivery of cardiovascular and stroke care. To receive recognition, which is valid for three years, Dr. Katz submitted data that demonstrates performance that meets the Program's key cardiovascular and stroke care measures. These measures include blood pressure and cholesterol control, among others. When people with cardiovascular disease or who have had a stroke receive quality care as outlined by these measures, they are less likely to suffer additional complications, such as a second heart attack or stroke.

Dr. Katz has been a member of the Medical Staff since February 2000, and is in practice with West End Medical Group.



Bryan W. Kluck, DO, and Prasant S.
Pandey, MD, Division of Cardiology, recently received Certificates of Completion for Level II Certification in Coronary CT Angiography from Princeton Longevity Center in

Dublin, Ohio. The course is an intensive, handson opportunity designed to teach cardiologists and radiologists how to perform and interpret Cardiac CT Angiography (CTA).

CTA is a non-invasive heart-imaging test currently undergoing rapid development and evaluation. High-resolution, 3-dimensional pictures of the moving heart and vessels are produced during a coronary CTA to determine if either fatty or calcium deposits have built up in the coronary arteries.

Dr. Kluck has been a member of the Medical Staff since June, 1987, and Dr. Pandey joined the staff in October, 2004. Both are in practice with The Heart Care Group, PC.



On October 2, **Daniel D. Lozano, MD**, Chief, Division of Burn, was the recipient of the John C. Thirion Distinguished Service Award which was presented at the Spirit of Courage Award Celebration, sponsored by Lehigh Valley Hospital and Health Network, Valley Preferred, and

the Burn Prevention Foundation. This award is presented in memory of one of the founders and most active supporters of the Burn Prevention Foundation to recognize an individual who has distinguished himself for extraordinary effort and dedication to the cause of burn prevention.

Robert X. Murphy, Jr., MD, Medical Director, LVH-M, was elected the 25th President of the Northeastern Society of Plastic Surgeons (NESPS) at its annual meeting held in early October in Bermuda. The NESPS provides a regional forum in which highly-qualified surgeons

discuss surgical, educational, ethical and other professional issues in the forefront of plastic and reconstructive surgery.

Dr. Murphy has been a member of the Medical Staff since July 1989. He is in practice with Cosmetic & Reconstructive Specialists of the Lehigh Valley.



Ultrasound in Regional Anesthesia: "Seeing is Believing?"

Principal investigators Nanette M. Schwann, MD, Department of Anesthesiology Vice Chair for Research, and Joseph W. Galassi, Jr., MD, Department of Anesthesiology, received a grant from Sonosite Corporation supporting their study examining the use of ultrasound in regional anesthesia. Dr. Galassi's personal interest in peripheral nerve blocks prompted Dr. Schwann to design the scientific study. In turn, Dr. Schwann collaborated with investigators from the Division of Regional Anesthesia at Duke University to answer discrete questions about the effectiveness, safety, and patient perception of nerve block procedures.

Patients undergoing surgery on the upper extremity will be randomized to nerve blocks using either nerve stimulation or ultrasound visualization techniques.



Nerve stimulation is the "traditional" technique and the method most anesthesiologists learned in their training. Ultrasound visualization of nerve plexuses utilizes hand-

held high resolution imaging to identify the precise location of nervous and vascular structures previously identified by anatomic landmarks alone. Ultrasound allows the operator to "see" the anatomy of the nerve plexus and the proximity of the injecting needle to the relevant structures. Most importantly, the anesthesiologist can visualize the spread of the local anesthetic solution as it is injected in real time. The investigators hope to demonstrate that real time visualization will reduce procedure time and the incidence of intravascular or direct neural injection, thereby making the procedure more comfortable and safe for the patient. The researchers postulate that adoption of ultrasound technology is like "opening a window" on a 30 year old "closed door" technique, and, depending on the results, may revolutionize Regional Anesthesia.

The *Ultrasound in Regional Anesthesia* trial is also a first for LVH from the research



regulatory perspective. For the first time, Lehigh Valley Hospital will serve as the Coordinating Site for a multi-center trial and will be responsible for coordinating a clinical investigation at another institution. Our researchers and the coordinators from the Department of Anesthesiology and the Office of Surgical Research will assume regulatory oversight of the study at Duke University. Additionally, LVH will be responsible for implementing the Data Safety Monitoring plan (DSMp), an interim analysis and run a randomization sequence for the sites. Approximately 400 patients undergoing surgery on the upper extremity will be enrolled over the course of two years at both sites.

A Study of Risk Factors for Cancer in Northeast Pennsylvania

This peer reviewed \$4.5 million competitive grant was awarded by the Pennsylvania Department of Health to the Penn State Cancer Institute (PSCI), which is coordinating with the Northeast Regional Cancer Institute (NRCI), Lehigh Valley Hospital, Geisinger Medical Center, and St. Luke's Hospital to identify environmental and genetic risk factors for developing colorectal cancer in northeast Pennsylvania. The grant will support a case controlled study of 1,000 incident cases of newly diagnosed colorectal cancer from the tumor registries that serve nine contiguous counties in northeast Pennsylvania (Lehigh, Carbon, Lackawanna, Luzerne, Northampton, Pike, Susquehanna, Wayne, and Wyoming). Consenting participants will be asked to respond to a questionnaire about life style factors, and submit a cheek scraping for genetic haplotype analysis.

The tumor registry at Lehigh Valley Hospital will identify cases, and Paul J. Mosca, MD, PhD, Vice Chair, Research, Department of Surgery, and the surgical oncology laboratory will facilitate specimen transfer to the Penn State College of Medicine where the actual gene analysis will take place. Gregory R. Harper, MD, PhD, Senior Medical Director, Academic Oncology Program, will serve as Medical Director of the study.




Construction Update


With the ongoing construction at Lehigh Valley Hospital, the following information may be helpful for you and your patients when visiting the Cedar Crest & I-78 campus:

Physician Parking

... Beginning **Saturday, November 3**, for approximately one month, parking for Medical Staff and Residents will be available on the upper and lower levels of the new West Parking Deck in front of the hospital. The entrance to the upper level of the West Parking Deck is accessible from the main driveway directly in front of the hospital (see map below.)



- ... During this time, the Physician Parking Lots (Lots 5 and 6) behind the hospital will be closed to allow for construction to be completed on the new Entrance Road where it joins to the Ring Road which leads to the Physician Parking Lots. These lots will be reconfigured and resurfaced, a new double-gated entrance and three exits will be installed, and additional spaces from Lot 4 will be added to Lots 5 and 6 to create a new Physician/Resident Parking Lot with a total of 368 spaces.
- ... When renovations to the new lot are completed, Physicians and Residents will again park behind the hospital. However, to gain access to the new Physician/Resident Lot, Physicians and Residents must enter through the new Entrance from Fish Hatchery Road (see map on Page 11).
- ... Parking updates will be communicated in next month's issue of *Medical Staff Progress Notes* and through email. Stay tuned!

Cedar Crest & I-78 Site Renovations

- ... The new emergency drive is open for all traffic, including ambulances. Flagmen will assist with final paving in the next few weeks.
- ... Reconstruction of the parking lot directly outside the new Emergency Department entrance has started. Patient drop-off is available at the new entrance.

Emergency Department Project

- ... The new Emergency Department waiting room is open.
- ... Seven new exam rooms and a new Express Care waiting room will be complete by late November.

Lobby and Anderson Wing

- ... The ATM machine (near the cafeteria) is back in service.
- ... Terrazzo floor work continues in front of the Auditorium.
- ... Work continues on the new public restrooms located near the Cedar Crest & I-78 lobby Gift Shop.
