# Hazleton, Pocono and Schuylkill Colleagues: Register for LEAP Epic Training

Registration for training is now available through our learning management system called, The Learning Curve (TLC). You can access TLC from your Single Sign On (SSO) application. Super user training will be held July 15-31. End user training as well as Revenue Cycle Education (RCE) training will be held Aug. 5-Sept. 13.

RCE training is required for all colleagues who register patients and work with insurance. Colleagues must complete an entry level course (for example, Front Desk 100) prior to attending RCE education classes. See the Epic Training Wheels Course Catalogue for other acceptable prerequisites.



Please work with your direct manager to ensure you understand the training track(s) that you should complete as well as who is responsible for registering you for training. Due to shift schedules and ensuring staff coverage, it is recommended that your direct manager register you for training. Providers or non-LVHN employees who do not have access to TLC or need assistance to register for class may call 484-884-0247 or email LEAP\_Training@lvhn.org for assistance.

The Department of Education will be available to assist you with training registration at the below locations on June 20 and June 21 from 9 a.m. to 4:30 p.m.:

- LVH-Hazleton, ETC Building, 3rd Floor Education Center
- LVH–Pocono, Brodhead Room
- LVH–Schuylkill S. Jackson Street, conference rooms A and B (lobby level)

Many training opportunities have been scheduled at each site to lessen the burden of travel. For those courses only offered at LVHN–Mack Blvd. in Allentown, transportation will be provided daily. All hourly staff will be paid for their time in training.



# Getting New LVHN Badges for LEAP in Hazleton and Schuylkill

Another cool thing about using Epic is something called "Tap and Go." Tap and Go is the process that allows you to "tap" the workstation with your LVHN badge and "go" – in this case, launch the Epic application. This feature only works at Epic workstations locations in most patient rooms and selected patient care areas (e.g. radiology). Tap and Go will open the Epic application in seconds, enabling quick access to the patient's chart and the tools you will need to document.

# Service Star of the Month - June 2019

# Anna Fernandez, Certified Nursing Assistant. LVH–17<sup>th</sup> Street

A patient diagnosed with stage 4 lung cancer was receiving inpatient hospice care to control his symptoms of terminal restlessness, anxiety and agitation. The family – which included the patient's wife, adult sons and daughter - never left their loved one's side in the days leading to his passing. During that time, they appreciated the care provided by Certified Nursing Assistant Anna Fernandez. "Annie was an angel to our family," the patient's daughter says. "We all meet people who do their job well, but then there's that one special person who shows us all how it should be done." To provide comfort and support. Fernandez



spent time with the patient singing his favorite oldies, even though he was sedated and could barely respond. Fernandez remained pleasant, upbeat and happy around the family the entire time, providing a little levity and guidance in an otherwise sad and distressing situation. She gave the family what they needed most: A sense of relief, knowing their loved one was in good hands. "While watching the person we love pass away, there was nothing we could do but cry," the patient's daughter says. "Annie came in and folded his hands on his stomach, rubbed his face and spoke comforting words to him as he was taking his last breaths." It was what we as a family wanted to do, but were too distraught to carry out in that moment." This family remembers Fernandez as a true blessing for everything she did and recognizes her for fitting the definition of what it means to be "LVHN Proud."

## Mayra Elias, Office Coordinator, Burn Outpatient Program, LVH-Cedar Crest

Elias typically goes above and beyond her job title in service to colleagues and patients. Most recently, she investigated ways to get an insurance company to provide additional support to a 10-year-old burn survivor. Multiple barriers made it hard for the parents to get what they needed in an affordable way. But Elias dug up more resources from the insurance provider, enabling the parents to get much-needed care for their child.

## Jessica Meier, Social Worker, and Ashley Georgevic, ALS Program Coordinator, LVPG Neurology

A patient diagnosed with ALS was very scared. Meier and Georgevic took it upon themselves to go to LVH–Muhlenberg and talk to the patient's family about the diagnosis, hospice and LVHN's ALS clinic. They also organized a birthday party for another patient with ALS who was in the hospital at the same time. Their can-do attitude is evident in all the extra things they do for our patients.

### Sandra Gentile, RN, Cancer Center Infusion, LVH-Pocono

After leaving work, Gentile delivered a prescription to a pharmacy for a patient who needed medication for severe pain. As a result, the patient's caregiver was able to pick the prescription up that evening on their way home from work and deliver the medication to the relieved patient.

# Nicole Spess, Care Manager, Population Health, LVHN-One City Center

When Spess contacted a patient to complete a post-discharge phone call, she learned that the patient was having a difficult time understanding discharge instructions. Spess also discovered that the patient had no primary care physician and had been self-purchasing medication and self-prescribing doses. Without hesitation, she got this patient connected to services in our health network. As a result, his medical status improved dramatically.

# Bernadetta McLaughlin, Nurse Aide, Adult Psychiatric Unit, LVH-Schuylkill

On a busy day, McLaughlin assisted a patient with bathing and dressing, and contributed to administrative duties, all while performing her job duties on the floor. McLaughlin juggled these tasks throughout the day with a pleasant, positive attitude to the amazement of her colleagues.

# Financial Services Changes Position LVHN for Growth

# Return to Roots

In some ways, Steven Lewis, MD, had come full circle as he stepped to the podium at the 2019 American Academy of Neurology (AAN) annual meeting in Philadelphia.

The AAN was honoring Lewis – who had recently accepted his position as Chief of Lehigh Valley Health Network's (LVHN) Division of Neurology – with its nationally prestigious A.B. Baker Award for Lifetime Achievement in Neurologic Education. It is awarded to only one neurologist in the country annually. Lewis had spent most of his career at Rush University Medical Center in Chicago. In his keynote address, however, Lewis harkened back to an early LVHN-related influence.



Lewis asked his colleague audience how many of them knew the slender book *Neurology for the House Officer*. "A lot of people from my era raised their hands," Lewis says. "This incredible pocket book – part of a series by a major medical publisher – taught many neurologists the essentials of their specialty and helped shape my approach to thinking about neurology problems as well as how to teach others." The book's co-author: Lawrence P. Levitt, MD, the first Chief of Neurology for what became LVHN.

"From the time I was in training, I knew Allentown had someone who clearly was a great neurologist and great teacher," Lewis says. "Thirty years later, I got to meet him in his retirement and receive some mentorship as I followed in his footsteps."

While Levitt's work inspired Lewis, experience guided Lewis's development as a clinician educator. "To be honest, early in my career I was not a very good teacher," Lewis says.

But he was driven to improve, especially after becoming Rush's Program Director of Neurology Residency Training. "In that position you have to be an outstanding neurology educator or you will fail generations of neurology residents," Lewis says. "I really grew in that job. Education has been a major

part of my career."

Lewis served as Associate Chair of the Department of Neurological Sciences and head of the Section of General Neurology at Rush. He's also shaped neurology standards nationally and worldwide as Past Chair of the Residency Review Committee of the Accreditation Council for Medical Education, a Director of the American Board of Psychiatry and Neurology, a current elected Trustee of the World Federation of Neurology and Chair of their Education Committee, Editor-in-chief of the journal Continuum: Lifelong Learning in Neurology, and a writer or editor of several medical textbooks.

"The patient comes first over education," Lewis says. "It may sound obvious, but some people try to separate education and clinical care. Outstanding care *is* outstanding neurology education."

By building relationships of trust, mutual respect and mutual benefit, Epting led her team through the process of accreditation. Epting's leadership shines through her interactions with colleagues and nurse residents alike, as she offers compassion and attentiveness to those who seek advice.

# LVH–Pocono Announces Re-opening of Monroe County Hospice House

The Pennsylvania Department of Health (DOH) will be surveying the facility for approval of occupancy. This process must occur before Monroe County Hospice House can accept patients.

"We have been able to come together with the community and form a partnership to keep the Monroe County Hospice House open for years to come," says Elizabeth Wise, President, LVH –Pocono. "It's more than a facility – it's a home and one that we will continue to



use to provide end-of-life comfort and care right here in the heart of the Poconos."

George McCracken, Administrator, Lehigh Valley Health Network (LVHN) Home Health Services, told those gathered for the announcement that the rooms are fully equipped with new beds in each of the six private bedrooms. Each room has a private bathroom and a view of a garden patio. "Our goal is to provide a tranquil and relaxing environment for you and your loved one," McCracken says. "Our clinical staff is made up of some of the most compassionate and seasoned nurses, volunteers, chaplains, aides, and physicians, all of whom have considerable experience with end-of-life care to provide peace, comfort, courage and dignity on life's final passage."


