Approval of Minutes: The minutes of the meeting held October 20, 1983, were approved as written.

Secretarial Coverage for Committee: Secretarial coverage will be handled by the Secretary to the Director of Educational Development at the Lehigh Valley Hospital Center.

Administrative Re-routing of Funds for Departmental Libraries at LVHC: Departments at LVHC will be notified that they are to make requests for books and periodicals through the Library. These requests will come to the Library Committee to insure that there is not duplication. It was felt that an annual inventory of what departmental libraries have is needed.

Journal Endowment Fund: Specific methods of marketing were discussed. Dr. Gordon reviewed his letter which will be distributed to the medical staff. In addition to his letter, physicians will receive a list of journals arranged by subject with the letter. It was suggested that a form for donation be included form would be distributed to the medical staff and the physicians would be allowed to contribute to the library of their choice.

Security at The Allentown Hospital Library: A book security system, video camera and door security system have been installed in the Library at AH. The committee approved, with recommended changes, the following policies regarding this system: 1. Policies for the Use of the Library by Cardholders (Exhibit A), 2. Regulations Regarding the Use of the Library by Authorized Personnel during Nonlibrary Hours (Exhibit B). (Disciplinary action will be addressed at a future meeting.) 3. Operation of the Book Security System (Exhibit C). These will be taken to the medical staff of the AH for their approval.
