

NEW PRECERTIFICATION PROGRAM FOR MACK TRUCKS

Effective October 1, 1990, Mack Trucks, Inc., has implemented the Cost Care Health Care Management Program for certain employees, retirees, and their dependents.

The program, which will be administered by Cost Care, Inc., Huntington Beach. consists of: pre-certification of non-emergency admissions/major diagnostic procedures. continued psychiatric/substance review. treatment. abuse focused surgical review, home health care management, and case management.

The program will <u>only</u> apply to non-bargaining active employees and retirees under the age of 65. UAW and other bargaining unit employees and retirees are specifically excluded from this program. Participants covered under this program will receive special stickers for the I.D. cards.

The participant is responsible for checking that the required phone calls are made to Cost Care: however, some patients may look to their physicians for assistance in initiating the call. Physician cooperation in working assistance with patients and Cost Care will be greatly appreciated. Failure to make the required phone calls or comply with the program will result in increased out-of-pocket expenses for the patient.

The Puncture Wound Task Force has recommended the use of disposable scalpels in the procedure trays supplied by CPD and SPD. These have been placed in the additives dust covers that accompany the procedure trays.

LABORATORY UPDATE

Bleeding Time

An extensive review was recently published concerning the bleeding time. A summary of that assessment includes:

- * there is a lack of data to support the use of the bleeding time to predict a bleeding tendency;
- * there is no evidence that the bleeding time is useful for the monitoring of platelet transfusions or hemodialysis; and
- * there is no correlation as to the operative blood loss when the bleeding time was used alone as a predictor or hemorrhagic tendency.

The template bleeding time is of value in predicting excessive operative blood loss or indicating the presence of a bleeding tendency when there is a clinical history suggestive of von Willebrand's disorder or congenital and/or acquired platelet defects.

Tested alone, without a specific history, the bleeding time lacks both sensitivity and specificity as a routine preoperative screening test. The template bleeding time does not tell who will bleed, but it may reveal who may bleed under certain circumstances.

With this information in mind, the template bleeding time should not be performed as a routine preoperative screen without any significant clinical history (such as CABG surgery), or as a sole test to determine platelet function.

Since the TBT lacks sensitivity, specificity, and is very time consuming, please consider not requesting a template bleeding time without specific clinical indications for such (as stated above).

Clotted Hematology Specimens

The Hematology Department performed a quality assurance audit over a three-month period. The audit revealed the following statistics:

Threshold: 0 clotted samples

Audit: 66 clotted specimens

Location Breakdown:

29% ER specimens 61% nursing floors/units 10% outpatients

Specimen Type Breakdown:

48% 4 ml lavender pediatric tubes

32% 7 ml lavender standard tubes

20% fingerstick lavender microtainer tubes

All of the above specimens were unacceptable and had to be recollected. The price of non-conformance is \$2,640 per year.

To prevent these specimens from clotting, please invert the lavender top tube several times IMMEDIATELY after removing the tube from the vacutainer adapter. All tubes with anticoagulant should be handled in this same way. If the tube is not inverted immediately, the anticoagulant does not mix thoroughly with the blood, causing a clotted unacceptable sample.

For fingerstick hematology tests using the lavender when microtainer tubes, the blood should be tapped down to the bottom after each drop is This allows the collected. anticoagulant coated on the sides of the microtainer to mix adequately with the blood. After the blood is filled to the appropriate line, cap the microtainer and invert it several times.

By following the above specimen collection instructions, it is hoped that the number of clotted specimens received in the lab will be reduced.

Drug Screening on Expectant Mothers and Neonates

The laboratory is instituting a new drug screening policy on either expectant mothers before delivery or newborns. testing protocol will include only the three abused street drugs -cocaine. opiates, amphetamines. If the quantity of the urine specimen sufficient, all positive findings will be automatically confirmed by GC/MS. We will report either negative or unconfirmed positive drug ASAP upon receipt of specimen with confirmation to follow within two to three days. An unconfirmed positive drug finding will probably not withstand a legal challenge. This is the same protocol followed at the University of Pennsylvania.

Single Donor Platelet - Blood Component

Effective September 26, 1990, Miller Memorial Blood Center began a platelet pheresis program to procure platelets from single donors using a specialized machine called a cell separator.

These units have an average vield equivalent to 6-10 units obtained from random donations (as has been the practice in the past). infusion process is the same as would be if 6-10 units of platelets from random donors The major were infused. advantage of this component is limitation of donor exposure.

Currently, only a limited number of these units (maximum two per day) would be available to the hospitals in the Lehigh Valley. A priority will be given to using these units in patients who are transfused with platelets frequently, e.g., with hematological patients malignancies, in an attempt to minimize the induction of a refractory state in these patients.
