

### **KePRO Korner**

KePRO has recently implemented a change in their communication process for cases undergoing quality review.

- \* Non-physician reviewers screen cases using HCFA-mandated generic quality screens.
- \* If a potential quality problem may exist, a board-certified physician advisor (PA) reviews the case.
- \* If the PA determines that additional information is needed, a request is sent to the appropriate party.
- \* The request allows 30 days (from the request letter date) for a response/additional information to be sent to KePRO.

- If additional information is NOT received, a "determination letter" is issued based on the initial PA's decision.
- If a response/additional information IS received, a second review is conducted by the initial physician reviewer whenever possible.
- Based on this second review, the respondent is notified of KePRO's review determination.
- \* If the "determination letter" indicates that a confirmed quality problem exists, the responsible party may request one more physician review of the case. The request:
  - Must be in writing
  - Must be postmarked within 15 days of the "determination letter" date
  - Should be made by the responsible party.
- \* If a request is submitted as described above:
  - A second board-certified PA conducts an independent review of the case and any new information supplied.
  - A final determination letter is then issued, either confirming or nonconfirming the problem.

- No further appeal of the quality concern is allowe:
- \* For cases involving a related denial (e.g., premature discharge or invasive procedure denials):
  - The denial determination will be finalized ONLY after the completion of third review, or the expiration of the timeframe for requesting third review (whichever occurs).

In summary, the major changes include:

- 1. Request for information allowing 30 days for physicians to respond to potential quality concerns.
- 2. A determination letter will be issued. The determination letter will indicate whether or not a quality concern was felt to be present. This letter will have been issued based on the additional information submitted by the physician and the review will be conducted by the same physician who requested additional information.
- 3. Physicians may request an additional review following receipt of the determination letter within 15 days of receipt of that letter. This physician review will be conducted by a new board certified physician.

### Telephone Hotlist Now Available

In order to provide physicians and their office staff with a quick reference of the most commonly used hospital telephone numbers, Physician Office Practice Services (POPS) recently developed a telephone hotlist. Copies of the hotlist have been distributed to members of the Medical Staff and office managers with their copy of the newsletter. Additional copies of the telephone hotlist are available in the Medical Staff Lounge at both sites or by calling the POPS Office at 778-2780.



Lab Facts - Autologous Transfusion

Lab Facts regarding Autologous Transfusions are now available in the Medical Staff Lounge at either site.

Autologous Transfusion is defined as the collection and reinfusion of a patient's own blood. It is the "safest" form of blood transfusion. In addition to eliminating transfusion-transmitted viral diseases, the use of autologous blood transfusion prevents antibody formation which may occur when a patient is transfused with homologous red blood cells.

Illegible handwriting will become a part of the generic screening process which the Medical Record Department will be introducing in May. Continued exhibits of illegible handwriting may need to be addressed by the Medical Staff Rules and Regulations.

When transferring patients to another facility, the transferring orders must be documented on a separate Doctors' Order Sheet and not on an Order Sheet which lists orders prior to the transfer. The original transferring orders are sent to the receiving hospital.

Physicians are encouraged to visit Medical Records on a weekly basis and complete all records at that time. This will enhance the quality of patient care through follow-up and improve cash flow to the hospital.

### News from Nuclear Medicine

The Nuclear Medicine Department has found that orders for certain scans are not being properly ordered through the HIS In order to avoid computer. further delay in the completion of inpatient studies, Nuclear Medicine recommends the following orders for the following indications:

- 1. "NM gallbladder scan" (instead of DISIDA, HIDA, DECEDA, etc.) to rule out acute cholecystitis and/or biliary obstruction.
- 2. "NM gallbladder scan" "with CCK" (enter in text area) to rule out chronic aculculous cholecystitis.
- 3. "NM GI bleed scan" (instead of blood loss) to rule out an active GI bleed.
- 4. "NM gated MIBI scan" for assessment of myocardial viability at rest. This scan should be discussed with the Nuclear Medicine physician prior to ordering.

- 5. "RNA rest" for evaluation of wall motion and ejection fraction at rest at the LVHC site. Please specify LV, RV, or both LV and RV.
- 6. "RNA stress" for evaluation of wall motion and ejection fraction after exercise at the LVHC site.
- 7. "Gated blood pool scan" for evaluation of well motion and ejection fraction at rest at TAH site. Please specify LV, RV, or both.

Regarding item #4, MIBI (Tc-99m-hexakis 2-methoxyisobutylisonitril) is the newly Technetium approved based isotope to image the myocardium. At this time, however, its use is being limited for the determination myocardial of infarction. In the future, Nuclear Medicine hopes to expand the use MIBI for stress/rest tomographic scans to rule out ischemia, however, stress thallium currently scans are being performed to determine areas of mvocardial ischemia.

In addition, please note that Medical Records is now typing Nuclear Medicine reports at the LVHC site. Turnaround time, in most instances, will be one day. The only exception will be cases that are dictated on Friday will not be distributed to the floors until Monday. Wet readings of inpatients will be called either directly to the doctor or to the floor on Fridays.



Due to a quality control problem by the manufacturer, Iron Dextra Injection (Imferon) for intravenous use has become temporarily unavailable.

This policy went into effective March 15, 1991, when the Pharmacy stopped adding iron to Parenteral Nutrition Solutions. This practice will not be resumed until a supply is reestablished.

During this unavailability, the Pharmacy has increased its supply of the intramuscular formulation which contains the equivalent of 50mg of elemental iron per ml. The intramuscular formulation can be used when the oral route is unacceptable.

## Lehigh Valley Diagnostic Imaging Improves Services

Lehigh Valley Diagnostic Imaging (LVDI) currently receives copies of the hospital admissions and operating room lists (LVHC site), Monday through Friday. It is the practice of the LVDI staff to review these lists and if any patients on either list were previously seen at LVDI, their files are pulled and taken to the hospital Radiology file room.

In order to maintain smooth continuation of patient care, LVDI now receives from the Emergency Department a list of Friday night emergency admissions. If any of these patients were previously seen at LVDI, their files are pulled and taken to the file room on Saturday morning. Films usually remain in the file room for approximately three days.

Additionally, in mid to late April, a computer terminal from Lehigh Valley Diagnostic Imaging will be installed in the File Room of the Radiology Department at the LVHC site. This will allow the staff in the File Room access to reports on a screen; however, in order to maintain patient privacy, a printer will not be installed.

# Free Speech and Language Screenings to be Offered

### Publications, Papers and Presentations

# P & T HIGHLIGHTS

The following actions were taken at the March 11, 1991 Pharmacy and Therapeutics Committee meeting.

### FORMULARY ADDITIONS

Ethanolamine Oleate (Ethamolin, Glaxo) - a mild sclerosing agent indicated for the treatment of esophageal varices which have recently bled. The committee approved this agent for a 6 month evaluation by the Gastroenterology Division. Ethanolamine is injected locally in a dose of 1.5-5ml per varix. The maximum recommended dose per treatment session is 20ml. Dosage reduction is recommended in patients with significant liver dysfunction or concomitant cardiopulmonary disease. The most common adverse reactions include pleural effusion, esophageal ulcer, pyrexia, retrosternal pain, esophageal stricture, and pneumonia.

Tetracaine 0.5%, Adrenalin 1:4000, Cocaine 4% Topical Solution (TAC, Pharmacy Compound) - The Committee approved the addition of this extemporaneously compounded product for non-injectable anesthesia in patients (esp. Pediatrics) with minor lacerations requiring surgical repair. It is contraindicated in patients with lacerations to mucosal surfaces, digits, foot, hand, wrist, penis, nasal alae, or ear lobe. It is also contraindicated in patients with seizure disorders or cardiac dysrhythmias, allergies to any of its ingredients, or age < 1 yr. The dose ranges from 0.5 - 1ml per cm of wound not to exceed 4ml. Criteria for appropriate use, contraindications, critical indicators, complications and outcome measures were also approved.

#### FORMULARY REJECTIONS

Doxazosin Mesylate (Cardura, Roerig) - a long acting selective alpha-1-adrenergic inhibitor indicated for the treatment of mild to moderate hypertension. The committee rejected this request at this time given the limited inpatient use of the current formulary agents (Prazosin and Terazosin) in this class.

#### DRUG USE EVALUATION

<u>Dezocine</u> - Anesthesia submitted a report of 53 patients who received Dezocine in PACU following surgery. The drug was confirmed to be an adequate analgesic which appeared to offer no substantial advantage over current formulary agents given its potency, sedative effects and cost.

Alteplase (TPA) - 29 patients received Alteplase for acute MI between September and December. 23 cases appeared to meet existing guidelines with one adverse event (gum bleed) noted. Six cases were forwarded to the Cardiology Division for review and follow-up, if necessary.

#### **HUMAN INSULIN STANDARD**

The Committee approved a proposal to make human insulin the standard for all inpatient insulin orders which do not have a species source (i.e. purified pork, or purified beef) ordered for a patient or where documented allergy exists.

The purpose behind this substitution is to minimize the potential for patients getting an inappropriate species source of insulin with the antigenic potential of conventional insulin. Implementation will occur on May 1, 1991.

- 1) Human insulin types (Regular, NPH, Lente, Ultralente) will be used for all insulin orders which don't have the species source (Purified Pork or Beef) indicated on the order. The only exceptions will be for documented allergy to human insulin or where no human type is available (See table below).
- 2) Conventional Regular, NPH, Lente and Ultralente insulin will be eliminated from the formulary.
- 3) Human Regular and NPH will be the only insulin types maintained on floor stock. All other types and species will be dispensed on a physician order and will be returned to pharmacy at time of patient discharge.
- 4) At discharge, the Physician and/or Nurse should inform the patient to resume the insulin used at home, unless otherwise specified in writing by the physician.
