Although we were eventually able to reach a resolution in a reasonably amicable manner, it is most important for us all to give some thought toward how we deal with important yet controversial issues such as this. The goal should be to ensure that we have an orderly difficult way of evaluating problems without engendering acrimony and divisiveness.

We will certainly need to hone these skills as a collective Medical Staff if we are to be successful in dealing with the ever-widening array of third party payors, regulators, and other "players" who are seeking to become increasingly involved with the direction and control of medical care. As always, I welcome your thoughts and constructive comments.

The Clinical Planning Committee has begun to meet again. Its current focus, of course, is to facilitate the new Clinical Plan itself. The committee specifically is looking at implementation of a transitional plan with several task forces appointed to help with this. In addition, the issue of Ambulatory Care is receiving immediate attention from this committee.

As previously mentioned, we are making plans to establish a litigation support service for physicians involved in malpractice actions. This is to consist of a group of interested individuals who may have experience with malpractice problems, and are willing to provide information, counseling and support to their colleagues going through this often painful process. This will be a loosely structured network rather than a group with formal regular meetings. Please indicate your interest through the Medical Staff Services Office.

National Association of Medical Staff Services Week Celebrated

The week of November 4-10 was celebrated as National Association of Medical Staff Services Week. The association is organized in 40 states with more than 2,000 members representing hospitals and other healthcare organizations.

Medical Staff Services is responsible for ensuring compliance with federal, JCAHO, and state mandates concerning various aspects of medical staff activities, including medical staff credentialing, appointment, and reappointment.

Deadline for Mandatory Eye Exams Extended

The Laser Safety Committee has extended the date for all laser credentialed attending physicians and residents for mandatory eye examinations, as required by Laser Policy #7101.00. The deadline has been extended from Friday, November 29, 1991 to Tuesday, December 31, 1991.

Eye exams are at the physician's own expense, and a report of the ophthalmologic exam should be forwarded to the Medical Staff Office upon completion.

Echo Lab On-Call Coverage

Effective October 28. the Echocardiogram Department within the Heart Station at both sites will extend their on-call coverage to include weekdays. This will provide coverage for all STAT echo requests during nonscheduled staffing periods. Weekday call coverage begins each day at 5 p.m. and extends until 7 a.m. the following morning. Weekend call coverage begins Friday at 5 p.m. and continues until Monday morning at 7 a.m.

All requests for a STAT call-in echo must be arranged through a cardiologist who will be available upon completion of the echo to give a STAT interpretation. This does not represent a consultation on the patient.

Pre-Admission Testing Requests at LVHC

The Pre-Admission Testing Department at the LVHC site has been working with the Admitting Department to better utilize resources while simultaneously improving customer service with physician offices.

Effective November 11, 1991, when calling in an elective or Short Stay Unit reservation at LVHC, the Admitting Department will take requests for all preadmission testing information and requirements. This information will be transmitted to the Pre-Admission Department, decreasing the calls currently required by physicians' offices.

Post-Hospital Patient Care

In order that a patient may be transferred to a rehabilitation hospital, skilled nursing facility. or receive home health services post hospital discharge, physicians must complete the appropriate diagnosis, form noting treatment. medications. These forms must also be signed and dated by the attending physician. If this is not done, the services mentioned cannot be provided. This is a requirement of Medicare, Medicaid, and other Third Party payors.

Physician cooperation is necessary in order to provide patients with the appropriate continuum of care upon discharge from the hospital.

Transcranial Doppler

Effective November 1, 1991, the Vascular Laboratory at the LVHC site will be performing all Transcranial Doppler studies.

Inpatient referrals will be scheduled through physician orders on charts. Outpatient studies will be scheduled by appointment only and will be performed at the LVHC site. Appointments may be scheduled by calling 776-8824 or 776-8825.

There is no preparation for this procedure which takes approximately one hour.

Blood Transfusion Consent/ Refusal Form

Recently, Administrative Policy #6301.00 - Transfusion Consent, was distributed to all physicians. At the November 5, 1991 Medical Executive Committee meeting, a revision regarding when to obtain consent was recommended and approved. Consent for transfusion is only required when ordering a type and crossmatch. Consent is not required when vou are requesting a type and screen be done.

A memo outlining the changes to the policy, which was distributed to the nursing staff, will be distributed to all physicians under separate cover.

STAT Chem 20 Orders

A two-week audit of the Chem 20 test indicated that it is ordered

inappropriately STAT 23% of the time. A Chem 20 is a routine laboratory test and should never be ordered STAT. When a Chem 20 is ordered as STAT, it delays result reporting and contributes to increased laboratory costs due to special specimen handling and duplicate testing. If a STAT is required, a Chem 7 should be ordered along with other individual tests as required.

For your information, the laboratory large volume instrument is now the Technicon DAX which replaced the SMAC in September. The DAX is in operation from 6 a.m. to 11:30 p.m., Monday through Friday, and from 6 a.m. to 1 p.m. on Saturday and Sunday.

Telefax Update

P & T HIGHLIGHTS

The following actions were taken at the October 14, 1991 Pharmacy and Therapeutics Committee meeting.

PARENTERAL ANTIBIOTIC ACTIVITY

Following several months of work, the P & T Committee approved a new Parenteral Antibiotic ordering and evaluation program. The program was developed by a task force from Medicine, Surgery, OB/GYN, Pediatrics and P & T with support from Pharmacy. The essential components are a separate check off style parenteral antibiotic order sheet together with suggested guidelines for major agents printed on the reverse side. To assist the prescriber, a copy of the antibiogram and an interpretation of the data with recommended agents for common pathogens will be included in each patient chart. P & T will review usage which falls outside the guidelines for selected agents. More details will follow.

FORMULARY REQUESTS

Bepridil (Vascor, McNeil) a calcium channel blocker with local anesthetic properties indicated as a second line agent for chronic stable angina patients. This agent has serious side effects i.e. proarrhythmias, agranulocytosis, therefore, the request was tabled until the Cardiology Division submits usage guidelines. In the meantime, a Pharmacist will inform all non-cardiologist ordering physicians that their patients should meet the manufacturer recommended patient selection criteria before dispensing bepredil.

Pipecuronium (Arduan, Organon) and Doxacurium (Nuromax, B-W) both are long acting nondepolarizing neuromuscular blocking agents indicated as adjuncts to general anesthesia. Both have an improved cardiovascular side effect profile over pancuronium. Anesthesia will select one of these agents and use if preferentially.

DRUG USE EVALUATION

Clozapine - Criteria to review this drug's usage in schizophrenia, dosage regimen, monitoring requirements, and adverse events were approved.

Tetracaine, Adrenalin, Cocaine (TAC) - Data from 39 patients who received this topical anesthetic combination were reviewed.

Major conclusions were 4 patients (10%) had it applied to contraindicated surfaces, 2 patients (5%) had reapplication, 20 patients (51%) had no documentation of dose or efficacy, 17 patients (44%) received supplemental lidocaine. Results will be sent to Chairman of Emergency Medicine and Pediatrics and Nursing Administrator, Ambulatory Services for review, comment and

CENTOXIN PRE-MARKETING DISCUSSIONS

Centoxin is a human IgM monoclonal antibody, which will be marketed in the next several months. It has received a significant amount of publicity both in the Medical and Financial literature because of its indications for treatment of gram negative bacteremic sepsis and high cost (Approximate—\$4,000/dose). In fiscal year 1991, there were 167 confirmed cases of gram negative Septicemia at our institution. The committee agreed that a task force be appointed by the Chairman to review the potential role for this agent in our formulary.

KETOROLAC (TORODAL) AVAILABILITY AND RESTRICTION

This article is an update on the availability of Ketorolac (Toradol) and the P & T Committee's action on the issue. First, Ketorolac distribution will continue to be limited thru December because of the manufacturer's inability to supply. Second, we are able to get only 100 doses of `30mg/week, and the 15mg strength is not being produced. Third, continued restrictions are necessary since unlimited usage would exhaust supply. Hence, the P & T Committee approved that distribution should be allowed to all Prescribers who document on the order sheet at least one of the following in patients who are NPO.

- a) Respiratory Depression (PCO2 > 50 torr or PO2 < 60 torr) is present.
- b) Sedation is potentially harmful to patient.
- c) Opioids are contraindicated (allergy, etc), side effects are intolerable (urinary retention in prostate hypertrophy, etc) patient has adynamic bowel (Ogilvie's Syndrome, etc), or pancreatic/biliary disorders which preclude opioid use.

To obtain Ketorolac physicians are asked to write an order on the Doctor's Order Sheet and indicate the reason within the order. You are also asked to review usage against the above criteria and convert to oral or parenteral opioid therapy as soon as possible to conserve this limited supply.

TWO IS NOT BETTER THAN ONE

Occasionally, patients receive sucralfate together with an H2 Receptor Antagonist (PO or IV). There is no demonstrated benefit to this combination therapy. Duodenal ulcers heal equally well with sucralfate monotherapy as with combination therapy. As for gastric ulcer prophylaxis, combination therapy may be more effective than a H2 Blocker alone but no more effective than Sucralfate alone. Physicians will be advised of these facts and urged to change to monotherapy through a non-permanent chart note.
