More steam, more savings!

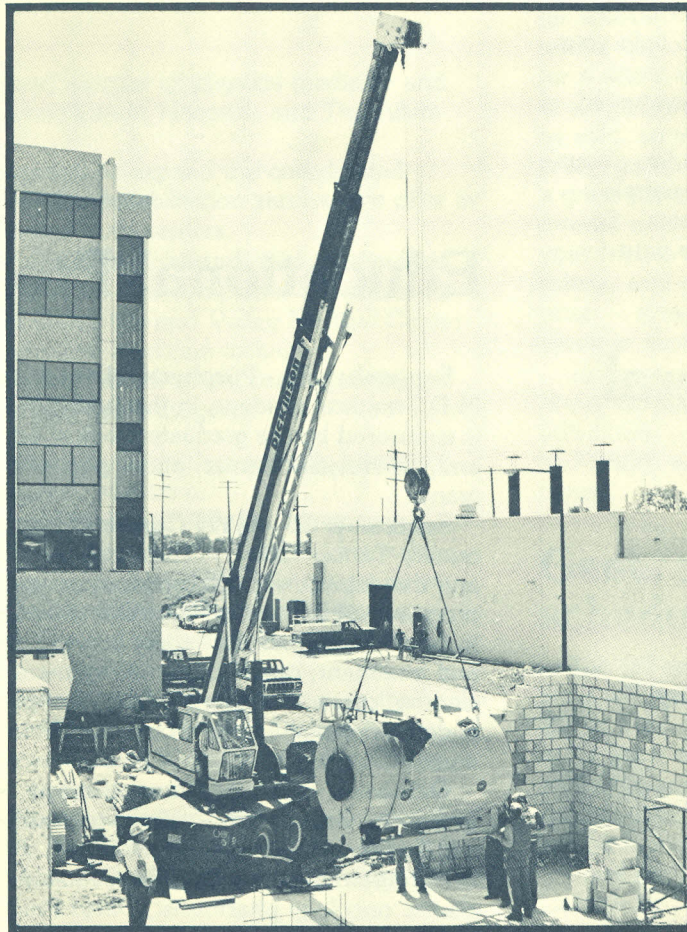
Although it may not be pretty, or look like a technological marvel, there is a piece of equipment in the General Services Building that is worth its weight in gold, as the saying goes.

After nearly four months of construction, the waste/heat recovery system has been put into use, burning paper products, wood, etc. — everything but biological specimens and converting that energy into usable steam heat for the hospital and bringing along a \$100,000 a year savings as a major benefit.

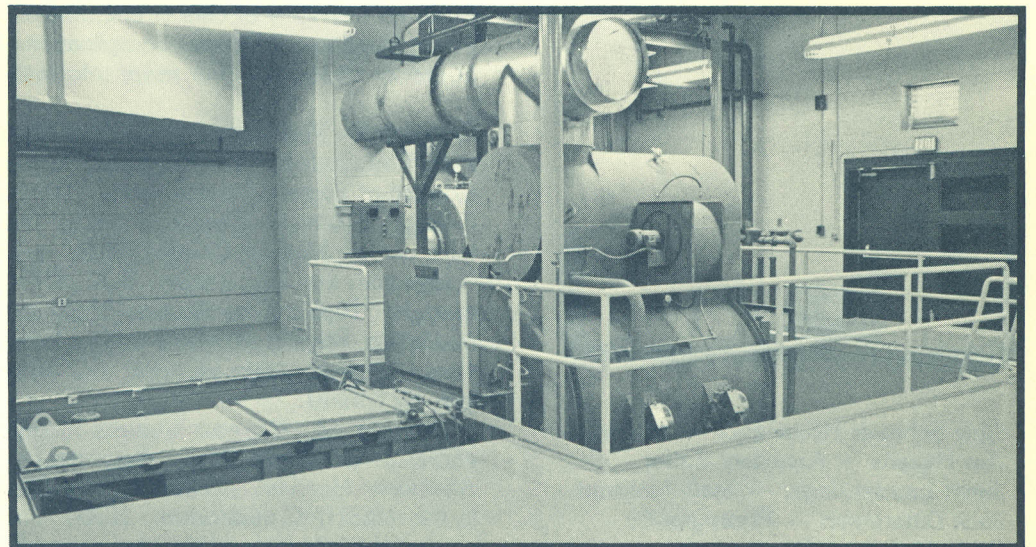
According to Leonard Farkas, director of engineering, a feasibility study was done to determine if an alternate energy source would provide a worthwhile gain, not only in monetary terms, but in expected utility. The answer was yes. Plans were drawn, a contractor selected, and the result is now operational.

Here's how it works: In a new section of the General Services Building, a dual chamber trash incinerator, fired by natural gas and environmentally clean (in compliance with Environmental Protection Agency Standards), burns all types of trash produced by the hospital. The first chamber fires up to 2000°C, the second chamber burns the remaining gases and waste at 1800°C. The resulting "flu gases," or what would be going up the chimney, passes through a "fire tube" type boiler and steam is produced, which then provides auxiliary heat and hot water for various areas in the hospital.

Farkas says that for now, the incinerator will be utilized from 8:00 A.M.-5:00 P.M., daily, but this unit has the capabilities of burning 600 lbs. of trash per hour, 24 hours a day. The housekeeping department will be in charge of collecting and burning the trash, and maintenance of the system will be performed by the hospital's boilermen.

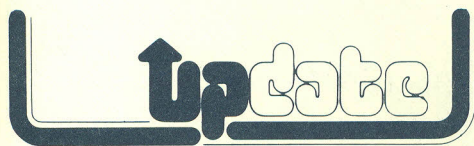

Award competition underway

A research and publication award, in memory of the late Paul Bosanac, M.D., staff internist, has been initiated by the Dorothy Rider Pool Health Care Trust. The purpose of the award is to encourage and recognize excellence in scientific investigations by interns, residents, and fellows in medical and dental programs sponsored by The Allentown Hospital, A&SHHC, Allentown Osteopathic Hospital, and Sacred Heart Hospital.

These individuals are eligible to submit published or unpublished research papers for consideration; research papers prepared through joint authorship are acceptable if all authors are eligible candidates. The competition provides for an award of \$1,000.

Research papers may be submitted for consideration by the selection committee at any time. To be eligible for the award in a given academic year, the paper must be received by May 1. The author(s) submitting the best paper will be announced on or about June 1. In making the selection, the committee will give due consideration to originality, contribution to the scientific method and design, and clarity and completeness of presentation.

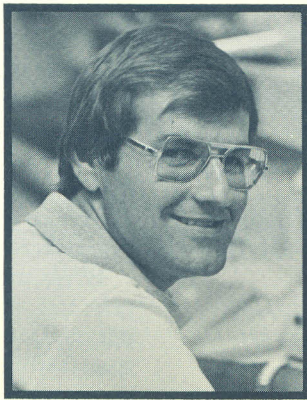

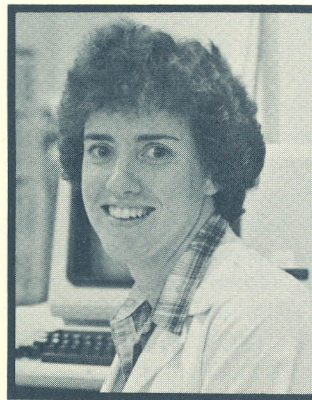
