

FROM THE PRESIDENT



LVHN Welcomes New Acting CEO -Brian A. Nester, DO

s you know by now, Dr. Ron Swinfard announced his retirement last month, effective July 1 (see related article on page 4.) We are fortunate to have one of our own and a doctor who has been heavily involved in the strategic planning of Lehigh Valley Health Network - as our new leader. Please welcome our new Acting CEO, Brian Nester, DO.



Dr. Nester came to Lehigh Valley Health Network (LVHN) in August, 1998, from an academic post in **Emergency Medicine** at Albert Einstein Medical Center in

Philadelphia. Shortly after he arrived, Dr. Nester served as the Associate Vice Chair of the Department of Emergency Medicine as both the Research Director and the Director of the LVH-Muhlenberg Emergency Department. He was one of the founders of the LVHN Emergency Medicine Residency Program and served as the first Director of Medical Education for the LVH-Muhlenberg campus from 2001 to 2008. While at LVHN, Dr. Nester has served as a Co-Investigator on a NIH-funded trial in his area of clinical research interest: "sudden death" and heart rate variability.

In 2003, Dr. Nester was named Senior Vice President for Physician Practice Network Development (PPND). In this role, he was responsible for aligning the physician community and coordinating LVHN's business development and market expansion goals. In 2007, the division was renamed, Physician Hospital Network Development (PHND), as his role expanded to include oversight of Health Network Laboratories (HNL) and the formal cultivation of interhospital relationships. Functional resources within PHND included network sales, customer relationship management, decision support, business development and planning, physician and executive recruiting, health center operations, and Telehealth. These and other network resources were utilized to support relationship development efforts between LVHN and its community of physician practices, as well as partnering hospitals and health systems in the region.



This strategic approach has relied on aligned relationships to generate new clinical and business opportunities. In 2011, Dr. Nester was named Chief Strategy Officer. In this role, LVHN combined the business assets of PHND with network resources in post-acute operations and insurance in support of LVHN's strategic vision to transform into an accountable organization – one that is capable of absorbing clinical and financial risk. Additional areas of oversight now include Insurance and Payer Strategies, Health Systems Research and Innovation, and the Care Continuum.

Dr. Nester received his D.O. and M.S. degrees from the Philadelphia College of Osteopathic Medicine in Philadelphia and is a Certified Physician Executive through the American College of Physician Executives. In 2004, Dr. Nester received his M.B.A. from Columbia University in New York where he remains a regular lecturer at the Graduate School of Business and the Mailman School of Public Health. Dr. Nester is a member of the Board of Directors for the Hospital and Health System Association of Pennsylvania (HAP) and currently serves as the Chair of the Physician Leader Advisory Group for HAP. He has served on the Industry Advisory Board for the Columbia Alliance for Healthcare Management since 2005, is a past member of the Board of the Lehigh Valley Economic Development Corporation (from 2009 to 2012), and has served as the Chairman of the Board of the Lehigh Valley Physician Hospital Organization since 2009.

In next month's *Progress Notes*, Dr. Nester will share some of his thoughts about our clinicians and our Network, the current and future health care landscape and how we're adapting to the rapid changes in health care delivery. Stay tuned!

LVHN PRESIDENT AND CEO ANNOUNCES RETIREMENT



Early last month, Ronald W. Swinfard, MD, announced his retirement as President and Chief Executive Officer (CEO) of Lehigh Valley Health Network (LVHN), effective July 1, 2014. Dr. Swinfard has served in this position since November, 2010, when he succeeded the health network's longtime President and CEO, Elliot J. Sussman, MD.

On June 5, Dr. Swinfard informed LVHN's Board of Trustees of his decision to retire and the board accepted. "Dr. Swinfard has prepared our organization for the future of health care and leaves us in a good position to face this ever-changing landscape," said William F. Hecht, Chairman of LVHN's Board of Trustees.

"All of us eventually must decide when the time is right to move on with our lives," Dr. Swinfard said. "This is the right time for me and my family."

Dr. Swinfard said when he became President and CEO three and a half years ago, leading the nationally recognized health care organization and the Lehigh Valley's largest employer was a tremendous opportunity. He said he and LVHN's leadership team tried to accomplish more great things toward better health for the community.

"I think we have done that amid difficult challenges and major changes in the industry. I'm confident with the leadership, staff and organizational culture we have in place that our success in keeping and making our community well will continue."

"Dr. Swinfard has done a tremendous service for our community ensuring we can continue to heal, comfort and care at the level our friends, families and neighbors expect and deserve," Mr. Hecht said. "Tve enjoyed working with Dr. Swinfard, and the Board of Trustees is thankful for his leadership and is looking forward to a smooth transition. The board has been preparing for this day with a succession plan."

As part of that plan, the Board of Trustees named Brian A. Nester, DO, Acting President and CEO. Dr. Nester currently serves as LVHN's Chief Strategy Officer and will assume his new role July 1. "Tve had the privilege to work alongside Dr. Swinfard for the past ten and a half years, and I am grateful for his mentorship and all we have accomplished as a leadership team," Dr. Nester said. "I am honored the Board of Trustees has entrusted me to continue the important work and vision of LVHN during this interim period." Dr. Nester, who is a candidate for the position, will serve in this role while the Board of Trustees conducts a search that will include both internal and external candidates.

Dr. Swinfard's tenure as President and CEO has come amid major changes in health care, in particular, implementation of the federal Patient Protection and Affordable Care Act (PPACA). In response to the new law, Dr. Swinfard led LVHN's effort to form various industry partnerships, including the merger with the former Greater Hazleton Health Alliance in Hazleton, Pa. in January. Other health network strategies to move forward under health care reform included:

- The formation of AllSpire Health Partners, a consortium of seven hospital systems in New Jersey and Pennsylvania aimed at addressing quality, population health management, best practices and medical research in the Northeast region.
- The Optum Labs Research Collaborative of seven leading health organizations committed to improving the quality and value of patient care through sharing information assets, technologies, knowledge, tools, and scientific expertise.
- The transformation of the former Westfield Hospital in Allentown into LVHN-Tilghman, including the Center for Orthopedic Medicine.
- The ongoing and growing medical school partnership with the University of South Florida Morsani College of Medicine, which is designed to train tomorrow's doctors not just about medicine, but about the personal side of health care and what it takes to be a leader.

Dr. Swinfard also expressed pride in what he says makes LVHN different – a culture of engagement. "Health care is the most personal of experiences," he said. "We define our culture as people being at their best every day. Colleagues dedicated to the work they're doing to care for our patients means satisfied patients, which means patients choose LVHN for their care."

Dr. Swinfard and his wife, Dr. Sara Viessman, plan to remain in the Lehigh Valley upon his retirement.

NEW DESIGNATED INSTITUTIONAL OFFICIAL NAMED



Elaine A. Donoghue, MD, Vice Chair of Education for the Department of Pediatrics, was recently appointed Lehigh Valley Health Network's (LVHN) Designated Institutional Official (DIO) in the Division of Education, effective July 1. Dr. Donoghue replaces William Bond, MD, who has accepted the position as the director of research at the Jump Trading Simulation and Education Center, OSF HealthCare and the University of Illinois College of Medicine in Peoria, Ill.

As DIO, Dr. Donoghue will be responsible for oversight and administration of LVHN's residency programs. The DIO position is a requirement of the Accreditation Council for Graduate Medical Education (ACGME), which oversees residency education in the U.S. The DIO works in collaboration with the Graduate Medical Education Committee (GMEC). Together, they have the authority and responsibility for the oversight and administration of LVHN's residency programs, as well as the responsibility for assuring the regulatory requirements of ACGME and other educational and regulatory bodies, such as Centers for Medicare and Medicaid Services (CMS), National Residency Matching Program (NRMP) and The Joint Commission. The DIO is a part-time physician role within the Division of Education.

Dr. Donoghue earned her bachelor's degree from Georgetown University and her medical degree from Tulane University School of Medicine. She completed her Pediatrics internship at Tulane University and completed her Pediatrics residency at Emory University Affiliated Hospitals.

Dr. Donoghue has been a member of LVHN's Medical Staff since February 2010, and served as the Interim Chair of Pediatrics from November 2012 to November 2013. She currently practices with the Children's Clinic at Lehigh Valley Hospital-17th Street.

EPIC - THE PROVIDER SUPPORT PROGRAM



The Lehigh Valley Health Network (LVHN) Epic <u>Super User program</u> allows departments to involve users in their area in project preparation and function as an extension of end user training by providing elbow-to-elbow support during go-live to reinforce learning and facilitate performance.

Provider involvement in this program is restricted due to the potential impact on patient access. However, provider engagement is critical and peer-to-peer provider support is a positive element of go-live success.

The <u>Provider Support Program (PSP)</u> intends to provide the opportunity for LVHN providers to participate in this support system. The expectation is that the program will not require time away from current clinical duties other than that which providers already have allotted.

This decision was made by LVHN executives considering the time commitments of the Super User Program, need for maintaining patient access, the importance of provider engagement in the Epic transformation and experiences of other institutions installing Epic.

There are final touches that need to be done for the PSP. Additional information will be shared when it becomes available.

CMIO UPDATE

CE Downtime Got You Down?

Centricity Enterprise is periodically taken off line ("downtime") every other month for maintenance and to install patches, etc. To lessen the clinical impact, this is scheduled for midnight on the third Saturday of every other month (January, March, May, July, September, and November). The downtime can last until 5 a.m., although the system is usually back up by 3 a.m.

Hopefully, knowing these dates will help with staffing and planning your evening, if you happen to be in house during those times.

Using Centricity Enterprise to Order Medications for Discharge? – Don't Do It !

Please do NOT order medications in CE as a method to have the medication appear in DCI. Medication orders placed in CE are active orders as soon as they are placed, and will be administered to the patient. This can result in serious patient safety issues if the patient receives medications that are appropriate for post-discharge.

Reason for Consult? Should be More than "Medical Management"

Please do not list "medical management" as a reason for consult. Consultants require more information to understand why the consult is being requested, the urgency of the consult, and other pertinent information.

To Discontinue or to Cancel

Based on input from the Clinical Decision Support Committee, the Medication Safety Officer and our Pharmacy colleagues, the Discontinue Screen is being revised. The "D/C all actions" button will function as the previous "Retract" button. This button will remove all future actions of an order. The "D/C as of:" button should be used when you want to discontinue an order at a future date – such as a course of antibiotics, steroids, or for a recurrent diagnostic order that is scheduled in the future. The "Cancel – non-meds only" should be used to cancel existing non medication orders. This will remove all future actions for that order.

PHYSICIAN DOCUMENTATION

Clinical Documentation of Pneumonia

The clinical distinction between community-acquired pneumonia (CAP) and health care-associated pneumonia (HCAP) is crucial for correct management and antibiotic selection.

CAP is usually caused by *Pneumococcus*, *Chlamydia*, or *Mycoplasma pneumoniae* or by viruses, and is typically treated with one or more of the following antibiotics depending on whether the patient is admitted to an ICU: ceftriaxone, azithromycin, doxycycline or a fluoroquinolone (e.g., levofloxacin).

Patients with HCAP are considered high-risk for gram-negative and possibly staphylococcal infection, including MRSA, and they require multiple, broad-spectrum antibiotics such as piperacillin/ tazobactam, vancomycin, cefepime, aminoglycosides and others.

When it comes to the coding of pneumonia, the coding rules do not recognize nosocomial terms like HCAP, which means that this diagnosis will automatically default to a "simple" pneumonia like CAP, even though the patient may be in a critical, life-threatening condition.

To capture the true severity and complexity of HCAP with the correct codes, the physician must document what organisms are probable, likely, or suspected as the cause, or that the pneumonia is due to aspiration. Since HCAP is very likely to involve gram-negative organisms and/or staphylococcus, it is perfectly appropriate and necessary to mention these as the possible/probable cause when clinical criteria are met and multiple, broad-spectrum antibiotics are prescribed. A positive sputum culture is not required. The terms "coverage" or "coverage for" are not adequate documentation for coding purposes; <u>the</u> <u>suspected organism or organisms must be specifically</u> <u>mentioned.</u>

In summary, whenever your diagnosis is "HCAP," be sure to document the suspected organism or organisms based on clinical criteria and your antibiotic selection.

If you suspect aspiration pneumonia, please document as such.

Provider Communication


From the patient perspective, our provider communication is not where we want it to be. (LVH-Cedar Crest is at the 27th percentile, and LVH-Muhlenberg is at the 9th.) In addition to the ROADMAP (daily patient print out of summary information), there is now a new tool to assist in communicating to patients.

New Communication (white) Boards have been installed in patient rooms. They have a standardized look and feel across the network with some customization in areas like the Emergency Department and Mother/Baby Unit. Nursing is working to fill out all the information. As a provider, all you need to do is:

- 1) Look at it
- 2) Think about it
- 3) and Update it

That's it. The top right corner is perfect information to focus your time on the most important issues. Thanks for your help in improving patient care.

THE RETAIL PHARMACY VIEW

What's the skinny on Statins?

There have been many negative reports in the media about Statin use regarding cognitive issues, diabetes risk, liver function, muscle symptoms, and tolerance. A report in the *Journal of Lipidology* in May addressed these concerns.

- Cognitive: There is no definitive evidence that statins as a class have adverse effects on cognition.
- Diabetes: There is a small increased risk 10-12% of developing Diabetes while on statins, mostly in the higher dosages. However, the superior benefit of statins on cardiovascular disease outweighs the much smaller risk of developing Diabetes.
- Liver function: While statins cause a modest increase in liver enzymes, this typically does not indicate liver damage.
- Muscle Symptoms: approximately 1-5% of patients in controlled trials and 11-29% of patients in observation on statins experience myalgia. Sometimes switching brands (e.g., Zocor to Lipitor) alleviates this issue.
- Tolerance: Statin intolerance is usually a temporary state and resolves once discontinued.

Because statins are safe, the report recommends the clinician and patient should try to adjust dosage and type in order to maintain statin therapy at some level when cardiovascular risk is high.



New Drugs:

- Elestrin Gel: *Estradiol:* Hormone replacement gel to help treat hot flashes caused by menopause.
- Natesto Gel: Testosterone Nasal Gel: Replacement therapy in adult males for conditions associated with deficiency. Minimizes risk of secondary exposure to women and children.

ETHICS CORNER

Last month, we looked at some of the ethical considerations of ECMO technology. In this edition of "Ethics Corner," we will be discussing some of the ethical considerations of transcatheter aortic valve replacement (TAVR).

TAVR was developed to treat patients with severe symptomatic aortic stenosis that have been deemed too high risk for surgical aortic valve replacement. Among the factors making patients high surgical risk are: severely calcified valve leaflets, severe aortic regurgitation, acute myocardial infarction, left ventricular ejection fraction less than 20%, severe pulmonary hypertension and right ventricular dysfunction. The procedure involves replacing the aortic valve percutaneously via the transfemoral or sublclavian approach, or direct left apical puncture through a ministernotomy or right anterior thoracotomy.

The TAVR procedure "has been proposed as the standard of care for symptomatic patients with aortic stenosis who do not have reasonable surgical alternatives" after the PARTNER trial (cohort B) that compared TAVR to standard medical therapy. Despite the fact that this randomized controlled trial showed an outcome of 20% decrease in death due to cardiovascular causes at one year in the TAVR group, it is important to remember that in the clinical trial setting TAVR has a 43% absolute mortality at two years. In addition, TAVR has been associated with higher rates of stroke, bleeding and vascular complications than standard therapy.

As with any intervention, there is much for patients and families to discuss and weigh when considering a TAVR procedure.

- How will the TAVR procedure affect functional status? How are all aspects of their life possibly affected, from social relationships to transportation?
- 2) What are the risks of complications such as stroke or bleeding?
- 3) Has there been an advanced directive or end of life discussion with the patient or family to guide the care team in regards to patient wishes and surrogate decision makers if patient cannot speak for themselves? For example, what would the patient's wishes be if they were dependent on the ventilator or had a stroke after the procedure (tracheostomy, PEG tube, etc.)?



We judge that the advanced directive discussion is particularly important with this technology given the risks associated with its use and the fact that tragically, often patients will not be able to tell us what they want after this technology is used if it has not helped their particular situation.

These pre-procedure discussions may be daunting for some patients and families and there are resources available to help them. This really is an opportunity for a multidisciplinary approach. What we have to remember is that as difficult as these discussions may be, they are far more difficult if they do not occur and things do not turn out well for particular patients. This is a technology which can give a new lease on life to some patients and gives us a chance as caregivers to help patients look ahead and plan for what comes, no matter what.

However, with Kathleen, a nurse practitioner with OB/GYN Associates of the Lehigh Valley and Carbon County for over 11 years, she can turn the visit into a comfortable review of a woman's overall health. Kathleen approaches each patient with an openness that allows women to feel at ease and to share their concerns with her. Sometimes these concerns are more than just objective gynecologic complaints, and can include concerns such as marriage problems or depression. Every day she enjoys the fact that she can assist women with the education they need to be empowered with their own health. For many women, their visits to their OB/GYN are the only time they see a health care provider. For this reason, Kathleen uses her visits with them to help identify other medical problems and then refer them to the appropriate primary care practitioner or specialist.

A member of a team of over 10 clinical providers, Kathleen completes her office visits mostly at her group's Laurys Station location. Her gynecologic visits span from annual exams to problem visits. If needed, she performs procedures such as endometrial biopsies, saline infused sonograms, and IUD insertions. From the obstetrics side, she focuses on prenatal care of low risk pregnancies. She reviews questions and educates her patients about what is normal in pregnancy and also what they can expect during labor. Kathleen not only speaks from experience as a nurse practitioner, but as a mother of two. She and her husband, Ted, have a daughter, Teddi, who is completing a Radiography course in August, and a son, C.J., who works as an electrician's apprentice. She is thrilled about going with her daughter to Paris in September and is currently reading travel books to help plan her trip. When Kathleen is not researching for travel, she is usually reading a mystery or thriller novel.


