# **Diagnosis Calculator Added to Epic**

All U.S. health care organizations were required to begin submitting claims using the new ICD-10 code sets on Oct. 1 – and those that do not comply will see their claims rejected. Since ICD-10 includes changes to diagnosis and procedure codes, the new codes will affect nearly every aspect of the health care system. This includes hospitals, physician offices, health plans and patients.

To prepare LVHN for the transition to ICD-10 diagnosis codes, the Epic team implemented a change that affects the surgery scheduling workflow. A diagnosis calculator tool has been added to help you select the correct new codes.

**Previously:** You could select the correct diagnosis without any specifics. Generic ICD-9 codes were also accepted.

**Now:** This tool requires specificity when selecting a diagnosis and helps you select the correct ICD-10 diagnosis code based on the required questions.

# Flu Vaccine Update

All medical and allied health professional staff are considered to have patient contact. Therefore, they are required to get a flu shot.

Those who cannot be vaccinated because of a valid medical or religious reason must submit an exemption request, obtainable from any employee health services office, by Nov. 1. These individuals must be granted an exemption or be vaccinated by Nov. 23. Those approved for a permanent exemption in prior years do not need to request an exemption again this year.

Failure to comply with the immunization policy will result in a written warning. All medical and allied health professional staff and other staff with patient contact who are not vaccinated or granted an exemption within two weeks of the warning will be subject to termination.

- Vaccination clinics (see below)
- On units and in practices that participate in our peer vaccination program

### For Employed Physicians and APCs: Enroll in Benefits Oct. 9 to 30

If you're an employed physician or advanced practice clinician (APC) with LVHN or LVPG and you want Choice Plus medical, dental, vision, supplemental life insurance or flexible spending account (FSA) benefits coverage in 2016, you must enroll between Oct. 9 and Oct. 30, 2015.

In mid-September all benefit-eligible colleagues received a detailed packet of benefits information that included:

- What's Changing for 2016 Detailed information about important benefit changes
- 2016 Choice Plus Medical Plan Brochure Information and examples to help you choose between the Choice Plus PPO and HSA health plans
- Summary of Material Modifications A one-page sheet of the health plan changes for 2016
- ExpressCARE or Emergency Room information A one-page sheet to help you decide the level of care required
- Vision Plan Enhancements- National Vision Administrators (NVA) will be our new vision provider

in 2016. Colleagues will have an option of electing the basic plan or a buy-up plan.

Please review all documents carefully before you enroll in benefits. If you didn't receive your packet, call the benefits hotline at 484-884-3199 or access the HR Intranet for an electronic version.

To receive benefits in 2016 you must enroll between Oct. 9 and Oct. 30, 2015. Do so through Lawson on your SSO toolbar during these dates. **All LVHN employed physicians must re-enroll in benefits for 2016 to be eligible.** If you miss the Oct. 30, 2015 deadline, you won't be able to enroll in benefits until 2017 unless you have a significant life event (divorce, birth of a child, etc.)

This year the Health and Wellness Assessment is not required as a step to enroll in the medical plans. However, all colleagues are encouraged to take the assessment and continue to learn more about your health and taking care of yourself.

# Groundbreaking Marks Start of Specialty Care Pavilion Construction at LVH–Muhlenberg

Everybody loves to celebrate a new arrival.

So it was on Sept. 24 at LVH–Muhlenberg, where LVHN leaders and local officials donned blue hard hats and pink shovels. Together they broke ground on the four-story, 161,00-square-foot Specialty Care Pavilion that will bring numerous "new arrivals" – about 2,000 births a year – to LVH– Muhlenberg for the first time in the Bethlehem hospital's 54-year history.



In addition to the official ceremony, the event featured 11 Lehigh Valley-area children and their families.

The children conducted their own "groundbreaking," using miniature shovels in a tiny sandbox. "These children represent the type of strong families that will start right here at LVH–Muhlenberg," said hospital president Jim Geiger.

LVHN leaders also released new information about the Specialty Care Pavilion, which was initially announced in May and is scheduled for completion on July 1, 2017. "This project will extend our commitment to growing strong families closer to home for people in and around Northampton County," said LVHN president and chief executive officer Brian Nester, DO, MBA, FACOEP.

The total project cost of \$93.6 million will be paid for through a combination of LVHN capital funding and philanthropic gifts, including a \$600,000 pledge courtesy of the LVH–Muhlenberg Summer Festival and a \$300,000 pledge courtesy of the Auxiliary of LVH–Muhlenberg. The Specialty Care Pavilion will create 225 new construction jobs and 185 new patient care jobs.

Plans call for the Specialty Care Pavilion to include:

- Obstetrics and newborn services on the second and third floors, including:
  - A mother-baby unit with 20 private patient rooms
  - An admitting-holding nursery for use during the admission process or for procedures
  - A Level II NICU with 10 private rooms
  - · Eight labor, delivery and recovery rooms
  - Two operating rooms
  - Five obstetrics triage beds
  - · A three-bay post-anesthesia care unit area
  - And a four-bed antepartum unit
- A Center for Inpatient Rehabilitation on the first floor, providing patients a short period of intensive, hospital-based therapy following a serious illness, injury or procedure. It will include:
  - 28 beds
  - A therapy gym
  - · A suite where patients can perform activities of daily living
  - Specialized rehab equipment, including a harness patients can use as they learn to stand and walk again during recovery
- **Lobby space** on the first floor, including a new gift shop, café, a children's play center, private lactation rooms for breastfeeding mothers, additional rest rooms and an outdoor courtyard.
- Shell space on the fourth floor for future growth.

The Specialty Care Pavilion also will offer people in Northampton County tight connections to additional services available throughout LVHN. "Moms at LVH–Muhlenberg will have access to maternal fetal medicine for high risk pregnancy, assistive reproductive technology, and to all the services available through our Children's Hospital at Lehigh Valley Hospital," said Mary Bianchi, vice president, women and children's service line.

Erdman Healthcare Real Estate Solutions of Washington, DC, will provide the design/build services for



### Summer Research Scholars Program a Win-Win

The Summer Research Scholar program, made possible through the generosity of the Dorothy Rider Pool Health Care Trust, was once again very successful this year. Undergraduate students from universities across the region participated under the guidance of LVHN mentors, producing a total of 63 student projects.

One such research scholar was Douglas Wells. He is entering his senior year at the University of Pittsburgh and applying to medical schools, and was mentored by Sweety Jain, MD, of the department of family medicine. In just eight weeks, he was able to work on two different projects related to improving health care of the patients with disabilities. He worked with the Medical Home Project (MHP) team – a group of community members who partner with the department of family medicine - and was able to assess team

strengths and needs. In the second project, he worked with another summer scholar, Yasaira Rodriguez (mentored by Judith Sabino), and was able to train 112 LVHN medical personnel on disability etiquette.

"This summer was such an enlightening experience," Wells says. "I had the opportunity to observe steps being taken to eliminate health care disparity in the disability community here at LVHN. I was also able to take advantage of the network and learned about many areas of my personal interest, thus getting better insight into my future career. I was able to shadow physicians and staff in different specialties."

"During his internship, Douglas completed two very important projects for the MHP team – a survey and trainings," says Ellen Hunt, executive director of the Autism Resource Community Hub and a member of the MHP. "Douglas was able to achieve an impressive 97 percent survey response rate, which is unheard of. His presentation of the information gathered through the survey is data that will be used as guiding principles by MHP. We thank Douglas for his valuable work."

Jain mentored a summer research scholar for the first time and remarked that this was a very effective use of the time and resources. Through the work of the summer scholar, much was accomplished in a very short period of time.

In January 2016, the department of education will send out an announcement about the Summer Research Scholars program for 2016, when we look forward to matching a whole new set of exceptional students with our physicians and clinicians.

# Remember These Documentation Requirements

Health Information Management Operations has issued a reminder regarding documentation requirements as a follow-up to our recent Joint Commission survey.

All handwritten documentation must be legible, complete, signed, dated and timed by the person responsible for providing or evaluating the service provided.

An immediate postoperative note is required immediately after surgery, if a full operative report is not documented and available on the medical record prior to the patient being transferred to the next level of care. The immediate postoperative note must contain:

- Name of surgeon(s)
- Name of assistance (if any)
- Type of anesthesia used
- Procedure performed

- Description of each procedure finding
- Estimated blood loss
- Specimen removed
- Pre-op and post-op diagnosis
- Any complications
- Date of entry
- Time of entry

History and physical must be completed prior to any procedure and updated within 24 hours of admission with the following requirements:

- Chief complaint
- History of present illness
- Relevant past/surgical history
  - Current medications and dosages
  - Allergies and medication reactions
  - Existing co-morbid conditions
- Social and family history
- · Physical exam including a comprehensive physical assessment
- Conclusions and/or Impression
- · Course of action/plan for inpatient stay
- Date of entry
- Time of entry

# Benefit Managers Present Challenges to Drug Coverage

PBM. In the pharmacy world, this stands for pharmacy benefit manager. It is the folks from either insurance companies or businesses' human resources departments. They determine what is and is not covered by prescription plans.

Both you as providers writing prescriptions and we pharmacists battle with them constantly, trying to get coverage for medications you and we feel the patient should be on. Their rules are becoming more and more stringent as the years go by, new medications become available and drug prices rise. There are more closed networks, allowing only certain pharmacies, or only mail-order prescriptions, certain doctors and very tightly controlled formularies.

In some cases they receive special considerations from brand-name manufacturers to use their product rather than a generic. For example, Nexium is now available generically (esomeprazole), yet some PBMs require that only the brand name be used. Generic prices increase at times twofold or more as the number of manufacturers is reduced through consolidation or related to other business decisions. Typically, the timing of the price change by the PBM will go to the PBM's advantage.

Prescription insurance companies check prescription records of pharmacies regularly to make sure the pharmacies are in compliance with their rules. It is similar to a Joint Commission visit that's focused on just the pharmacy. One area that is being audited by insurance companies and causing trouble for pharmacies is when "used as directed" is the sig code for eye drops, inhalers, topicals, insulin and diabetes test strips. Please try to put the number of days' supply (and area to be used on topicals) on the prescription so the quantity dispensed is accurately reflected.

### **Quick Hits**

- **Codeine for kids:** The European Medicines Agency has recommended that codeine not be used in children under age 12 due to the dangerous side effects. The FDA is evaluating the findings and may issue a recommendation in the future.
- **Gliptins:** DPP-4 inhibitors for type 2 diabetes can cause severe and disabling joint pain, according to an FDA warning. These medications are available as single entities and in combo with metformin. Patients should not stop taking them, but should contact their providers. Trade names for single entities include Januvia, Nesina, Onglyza and Trajenta.
- Brilinta vs. Brintellix: The FDA warns that there has been some confusion of Brilinta, a bloodclotting medication, and Brintellix, an antidepressant, because of the similarity of their names. Please be careful to notate which one you want when prescribing.

- Nalfon 400 mg capsules: Fenoprofen
- Pulmicort 1 mg inhalation suspension: Budesonide Previously available in the 0.25 and 0.5 mg strengths only.

# Seated for Better Communication

Fiscal year 2016 performance for the first two months has been very positive overall with modest increases in physician communication.


Despite the increase in raw score, LVH–Muhlenberg experienced a one-point drop in percentile ranking. What that means is we are slowly getting better, but the nation is getting better even faster.

Press Ganey is the company that we use to conduct our HCAHPS surveys. The company offers a wealth of knowledge and resources. Behind all the data, it provides a list of our top areas on which to focus to have the biggest impact on overall hospital rating. Both LVH–Cedar Crest and LVH– Muhlenberg have physician communication areas included as five of the top 10 areas of focus. Among the Press Ganey resources, the first suggestion for improvement is to sit eye-to-eye with the patient.

Fortunately, we now have stools in all private rooms. Thanks to a project at LVH–Muhlenberg, where volunteers use iPads to ask patients about their doctors, we have seen a significant increase in patients reporting that the doctor sat down. Patients reported doctors sitting 29 percent of the time prior to the stools and 59 percent of the time after the stools were in place.

As mentioned in prior updates, patients perceive a 40 percent increase in time spent with the provider when the provider is sitting. However, one of the greatest provider fears of sitting down is being drawn into an extensive conversation. Because you are making a better connection with the patient, there may be times when you want to be there longer. However, sitting down is one of the best ways to have an exit strategy. Without being abrupt, standing up from the seat is a gentle way of transitioning out.


