Cedar Crest & I-78

Roadwork Continues on Cedar Crest Boulevard

Contractors have completed Phase 1 of a project, initiated and funded by Lehigh Valley Hospital, to ease the flow of traffic and improve automotive safety along Cedar Crest Boulevard and the hospital's main access road.

Phase I included the removal of a median at the entrance to the hospital's main access road and two islands that allow drivers to ease off Cedar Crest Blvd. and onto the hospital campus or the 1243-51 office buildings.

The second phase of the project begins Sept. 30 and will continue through Oct. 27. During this time frame, a section of Cedar Crest Blvd, extending north of the hospital to the I-78 exit ramp and south to Fish Hatchery Road, will be widened. Official Address Prevents Delays

Road Temporarily Closed

The road between the power plant and the main hospital building has been closed for underground utility upgrades. As a result, all traffic is being directed around the hospital on the I-78 side of the building. However, emergency room traffic is not affected by the project.
