Of course mergers represent change. Often, just the mention of a merger can be perceived by caregivers and employees as a threat. Leadership must oversee the melding of facilities, service lines, medical staffs and diverse cultures, while also working to alleviate these anxieties. Choosing the right partners and executing these mergers require planning, sensitivity and situational awareness. If done effectively, mergers will create a fertile ground for collaboration and mutual improvement.

One of the most successful mergers in the business world is, without a doubt, that of Walt Disney Corporation and Pixar Studios in 2007. Skeptics doubted the companies' powerful leaders could work together. But this union has produced 13 feature films, numerous short movies, countless awards and billions of dollars – indisputably a successful merger. Though our industries are different, there are lessons that can be learned from this epic merger as we move forward to expand and integrate our network at Lehigh Valley Health.

The Walt Disney-Pixar merger proposal was built on adding value to both the organizations and the animation and film industry. One of the underlying foundations for success in the Disney and Pixar relationship related to the fact that they functioned in similar industries, which led to "synergy" when they merged. Disney and Pixar as a combined force quickly boosted their market power and definitively became the premiere player in their industry. Functionally they improved as well. Post-merger Pixar was able to release two movies annually (as opposed to one) while creating a culture of creativity that resulted in improvements in both current products and new, meaningful product lines.

With our present mergers with Hazleton and Schuylkill, and anticipated similar future mergers, success will be achieved only by increased health offerings in our unique and shared populations. Like Disney and Pixar, we are in a position to capitalize on common goals and needs. Our priority must be to provide our communities – patients and providers – with better health and also a better environment to provide care. The proximity of these hospitals and the shared patient populations will invariably help make this mission feasible.

Benefits of merging will include expanding and creating service lines at all hospitals, adding new clinical programs and optimizing access to care that in the past perhaps required patients to leave the region. We will improve quality through standardization, strategically combining resources, and inclusion and collaboration. We will mitigate cost and strive to enhance the value of the care we offer. Through efficiency of scale we will develop a unified program of excellence in credentialing, information technology, quality improvement and peer review.

Ultimately, in today’s competitive health care market, expansion arguably will be necessary to survive. Growth through strategic joint ventures with the right partners and building on the strengths of each organization will be the key to our future success. This growth, however, must be embarked upon with mutual respect, understanding and humility. We must, as with Disney and Pixar, recognize that each organization adds value and strength that can only be optimized through working together as a single, integrated organization. This is an exciting time for LVHN, and as Buzz Lightyear would say, “To infinity and beyond!”

# LVHN, Schuylkill Health System Merge

Lehigh Valley Health Network (LVHN) and Schuylkill Health System (SHS) officially merged on Friday, Sept. 16, 2016.

Under the merger, which was approved by the necessary regulatory agencies, Schuylkill Health System is now part of Lehigh Valley Health Network. The LVHN brand is reflected in the new names of the two Pottsville hospitals, which will now be called Lehigh Valley Hospital–Schuylkill E. Norwegian Street and Lehigh Valley

Hospital–Schuylkill S. Jackson Street.

LVHN also announced that William (Bill) Reppy is the new president of Lehigh Valley Hospital–Schuylkill. Prior to his new role, Reppy was vice president of operations and chief safety officer at Lehigh Valley Hospital–Hazleton (LVH-H).

Brian A. Nester, DO, MBA, FACOEP, LVHN’s president and chief executive officer, said the merger gives LVHN the opportunity to extend its mission to heal, comfort and care to an even greater population. “This new arrangement with a longtime partner allows LVHN to grow services, improve technology and recruit physicians and other medical professionals to the Pottsville and Schuylkill County community. We intend to grow what was an already successful partnership that included teleburn and telestroke services, into a cohesive health network that gives people access close to home.”

Nester said several thousand people already travel from Schuylkill County to LVHN for tertiary services each year.

Nester said Reppy will oversee operations at the two Lehigh Valley Hospital–Schuylkill campuses and of the health network’s other services in Schuylkill County.

For Reppy, the appointment is a homecoming. He was born in St. Clair, Pa., raised in Orwigsburg, Pa., and worked at the former Good Samaritan Regional Medical Center (which later became Schuylkill Health-East Norwegian Street) in Pottsville from 1990-2005 as director of radiology and medical diagnostic services.

“Our pledge to the people of this community is that we will always listen to you,” Reppy said. “As we move forward, we will work to provide the services you need most, and we will always remember that we are here to serve you. By working together, we will change the health care landscape in Schuylkill County.”

Reppy said as part of campus integration each location will continue to operate an emergency department. Services such as intensive care, inpatient medical-surgical units, operating rooms, pediatrics and diagnostic imaging will be provided at the East Norwegian Street campus.

He said adult and adolescent behavioral health, as well as obstetrics will remain at the South Jackson Street campus.

Reppy said he expects integration of the hospital campuses to be completed by late fall. However, the overall plan to integrate two organizations will take time. “It is a complex process that cannot be done with the flip of a switch,” he said.

Reppy had served in his role in Hazleton since 2007. Prior to his position at LVH–H, Reppy served as the county administrator/chief administrative officer for Schuylkill County. He is a graduate of George Washington University, Saint Leo University, where he earned a bachelor’s degree in business management, and Kutztown University, graduating with a master’s degree in business administration. Reppy also served in the U.S. Navy.

# Flu Vaccine Update

Regardless of your role in our health network, we all share the same mission – to heal, comfort and care. To do your job to the best of your ability, you first have to take care of yourself. As flu season approaches, one of the best ways you can help our patients avoid influenza infection is to get a flu shot.

**As was the policy last year, all colleagues who have routine or intermittent patient contact are required to get a flu shot.** All medical and allied health professional staff are considered to have patient contact. Those who can't be vaccinated because of a valid medical or religious reason must submit an exemption request, obtainable from any employee health services office, by Nov. 1. These individuals must be granted an exemption or be vaccinated by Nov. 23. Those approved for a permanent exemption in prior years do NOT need to request an exemption again this year. Failure to comply with the immunization policy will result in a written warning. All medical and allied health professional staff and other staff with patient contact who are not vaccinated or granted an exemption within two weeks of the warning will be subject to termination.

Submission of documentation of influenza vaccine received outside the auspices of LVHN employee health is required. Proof of vaccination can be submitted by accessing the electronic form on the **LVHN Intranet, Colleague Resources, Influenza Information** or using this link:

# MedAbbrev: New Medical Abbreviations Resource

The LVHN group assessing readiness for the Joint Commission's information management standards pinpointed the need for an abbreviation resource, since access to the previous resource had ended. Resources were quickly identified and evaluated. The program, MedAbbrev, is now licensed for network use and designated as the official reference for abbreviations not listed on the commonly used abbreviation list.

Abbreviations in the official reference, MedAbbrev (Neil M. Davis Medical Abbreviations), or included in the facility-specific abbreviation list, may be used when documenting in health care records. Facility-specific abbreviations can be found in "Policy Tech" in the "Medical Abbreviations Policy" in the administrative manual. The MedAbbrev program homepage has been customized to display the LVHN list of Do Not Use abbreviations and contains more than 47,000 entries.

MedAbbrev can be accessed through the library services homepage, which is listed in the weblinks in EPIC and on the intranet homepage under the category "Educational Resources" on the right side of the screen. A link is also available on the library homepage at LVHH. Five users can use the resource simultaneously.

# Drug Discount Cards May Not Be What They Seem

The next time you are passing your front patient counter or waiting area, you may see brochures and displays for drug discount cards. Their advertisements can claim as much as a 50 percent reduction in cost of prescription medications for people who do not have insurance.

Some prescribers are even listing one of these discount card numbers on every Rx they send electronically. However, we compared prices of 10 of the most prescribed drugs when purchased using one of the more popular discount cards versus to the regular price of the medications from Health Spectrum Pharmacy. Nine out of the 10 drugs were cheaper when paid for out-of-pocket at a Health Spectrum Pharmacy.

The card offered no discount, but rather a higher price. One drug was three times more expensive using the card. The discount cards also charge a fee to the pharmacy that fills the prescription. So advise your patients to check the retail price of their prescriptions at their pharmacies, as it may be cheaper without the card than with it.

FYI: The majority of third-party insurance plans charge the same co-pay amount no matter where patients get their prescriptions filled. Utilizing Health Spectrum upon discharge not only offers patients great convenience, but they will pay the same price as their home pharmacy. For those without insurance, our out-of-pocket prices are more than competitive.

## **New Formularies from CVS Caremark, Express Scripts**

Will the prescription you write for a patient be covered by his/her insurance next year? CVS Caremark and Express Scripts, two of the biggest prescription insurance companies have released their formularies for 2017 and each features long lists of excluded drugs.

Both companies claim they have gotten huge savings for their customers, which in the end are not patients but rather the health insurance companies and private corporations that hire them to manage their prescription drug plans.

For example, CVS Caremark is dropping two commonly prescribed biologic drugs: the diabetes drug Lantus and a medication for those on chemotherapy, Neupogen. Instead, the company will pay for alternatives known as biosimilars. Since biosimilars cannot be automatically substituted, the patient will have to go back to the prescriber to get a new Rx or the pharmacist will have to call to get a new order. The consumer will be inconvenienced as will the prescriber and the pharmacist.

Buckle up everyone, there are 50-plus more biosimilars in the FDA approval pipeline.

**Dyanavel XR**, 2.5 mg/mL oral suspension (amphetamine extended release): A CII extended-release liquid for treatment of ADHD in children ages 6 and older.

**Emend** 125 mg/mL oral suspension (aprepitant): For the prevention of chemotherapy-induced nausea and vomiting in patients 6 months and older.
