### A Tribute to Two of Our Best

We recently lost two of the finest physicians who ever worked at Lehigh Valley Health Network. Martha Lusser, MD, passed away on Oct. 9 at the age of 71. She was a member of the Medical Staff for 37 years within the Department of Pediatrics and Neurology. Francis A. Salerno, MD, started his career at LVHN in 1990 as an internist and as our chair of Geriatrics. Dr. Salerno passed away at the age of 70 on Nov. 24. Although these physicians practiced at the opposite ends of the age spectrum, both were without question incredibly important to their patients and colleagues. They were true icons within their respective specialties.

Dr. Lusser was ahead of her time. In 1965, when she entered medical

school at the University of Missouri, only seven percent of all medical students were female. Graduating at the top of her class, Dr. Lusser began paving the way for women in medicine. She went on to receive additional training at Children's Hospital, Brigham Hospital and Beth Israel, earning certification by the American Board of Psychiatry and Neurology.

She spent her entire career in the Lehigh Valley and for most of it was the only pediatric neurologist in the region. Dr. Lusser was touted on many levels but one of her true skills was as a diagnostician. Numerous stories in the press highlight her aptitude in this realm – diagnosing unusual cases and saving a child's life. She cared for thousands of children with a broad milieu of neurologic conditions.

One of her colleagues was quoted as saying, "She was brilliant, caring and so kind to her patients – they all loved her." Her impact on these children's parents and families were also very significant. As a caregiver, she was described not only as a superior physician but also as an advocate and to many a friend. Dr. Lusser nearly single-handedly provided our region with pediatric neurologic services that were second to none.

Dr. Salerno, was also a true visionary, joining the LVHN community in 1990 as the Chair of the Geriatrics Division in the Department of Medicine. As most know, Dr. Salerno was blind. In 1992, he was the first boarded blind internist, thus opening the door for many other blind physicians. Dr. Salerno attended Temple University School of Medicine. He lost his eyesight early in his career, while a resident at Reading Hospital. He often noted that his disability made him a better doctor, forcing him to use his other senses to connect with patients.

He had too many professional accomplishments to list but highlights include establishing our Center for Healthy Aging at 17th Street, becoming a founding member of the American Geriatrics Society and being named the group's clinician of the year in 1993, and receiving the coveted Louis Braille Award for leadership in the field of geriatrics in 1999. Under Dr. Salerno's leadership, U.S. News and World Report ranked LVHN's geriatrics care as a top 50 program in the nation seven times.

He was a gifted clinician, adored by patients and families, and has been described by dozens of other physicians as the consummate role model and mentor. One of Dr. Salerno's students from 1981, who is currently on staff LVHN, noted, "Although he will be missed, there is a part of him in each of us, a part that has been changed by knowing this gentle giant."

Drs. Lusser and Salerno were two of the greatest physicians to grace the Medical Staff at LVHN. They were exceptional doctors because of their intelligence, compassion, work ethic, talents and skills. What makes them truly irreplaceable, however, is who they were as individuals and how they approached not only their patients but also their colleagues and the profession of medicine. They did so with commitment and love.

Drs. Lusser and Salerno leave a legacy at LVHN. They utilized the power and energy of medicine to the best of their abilities and improved the lives of so many individuals and families in this region. They faced significant challenges in their careers and personal lives, but they were resilient and forward thinking as they blazed a trail for others. They understood the joy of medicine. A sign hung on the wall in George Bailey's office in "It's a Wonderful Life." The sign read, "All you can take with you is that which you've given away." As doctors and human beings, they gave it all. As we enter into a new year sure to be filled with changes in medicine and challenges in our own lives, let us remember the legacy Drs. Lusser and Salerno have given us.

### Medical Staff Merger, Leadership Changes Announced

Two physicians were recently approved to join Troika and fill out the leadership of the LVHN Medical Executive Committee, moves that coincided with a major change in the overall medical staff structure.

LVHN's Board of Trustees along with all three hospital boards endorsed diagnostic radiologist Patricia Martin, MD, of Medical Imaging of the Lehigh Valley, PC, as medical staff president-elect, and family medicine physician Mark Lobitz, DO, former president of the medical staff at LVH–Hazleton, as medical staff past president. They will work in direct support of LVHN obstetrician/gynecologist Joseph Patruno, MD, of the Center for Women's Medicine, who is medical staff president. Martin will serve a six-year term, Lobitz a two-year-term.

Both join the presidential team as the medical staff of LVH-Hazleton is merged into the LVHN medical staff, creating one overall entity. Each medical staff voted overwhelmingly to approve the merger, which also received the blessing of the board of trustees. LVH–Hazleton adds about 250 clinicians to the 1,275-member LVHN medical staff, which previously had included LVH–Cedar Crest, LVH–17th Street and LVH–Muhlenberg.

"A singular medical staff makes a ton of sense on many levels," Patruno says. "It simplifies our processes in maintaining consistent structure and quality throughout all of our hospitals. It's also a powerful tool in terms of recruitment in that an incoming physician would have the added benefit of joining a nationally respected network as a whole rather than an individual hospital entity."

Patruno emphasized how all existing staff clinicians will have a more distinct place in LVHN's mission as well. "We will look to celebrate this inclusiveness not only in Hazleton but hopefully with our Schuylkill colleagues and in the future Pocono," Patruno says.

The new medical staff structure will continue to maintain executive medical leadership committees for LVH (which includes Cedar Crest and 17th Street), LVH–Muhlenberg and LVH–Hazleton to address issues specific to those hospitals. The network medical executive committee will focus on more global issues, primarily ensuring consistency in quality, performance and credentialing.

The first meeting of the entire merged staff took place Dec. 12, with the Hazleton site joining via teleconference. "It's important at the local level for physicians to feel they have a voice with the entire medical staff," says John Hart, LVHN's senior vice president for medical operations. "And this will become even more significant as LVHN continues to grow."

### Allied Health Staff Biennial Reappointment

In compliance with the regulations of the Pennsylvania Department of Health, the Medical Staff and hospital bylaws, the standards of the Healthcare Facilities Accreditation Program and The Joint Commission, each member of the hospital's allied health professional staff must be reappointed a minimum of once every two years.

On Jan. 1, 2017, the biennial reappointment process will be put into motion when reappointment applications will be available on the web for more than 790 members of the allied health professional staff.

Directions for completing the reappointment application process will be provided with the application. The practitioner should review the directions to make sure all the information is provided and arrangements for submission of all the required documents have been made.

Although some of the information has been populated for the practitioner, make sure to review all the information, make changes where appropriate and complete any missing data. This information will serve as both the official and confidential file for the Medical Staff Services office and the network.

This year, annual tuberculosis skin testing will be required for practitioners in the following departments/divisions: Anesthesiology (excluding pain medicine), Emergency and Hospital Medicine, Pathology and Laboratory Medicine, Infectious Diseases, and Pulmonary. Those who have a history of a positive test must annually provide the date of screening by their private physician for signs and symptoms of tuberculosis.

Practitioners will self-report compliance through directed questions on the reappointment application. The following information will be requested:

- Date of the test
- Results
- · If corrective action was necessary, when the action took place
- If a positive history, the date of screening by their private physician for signs and symptoms of tuberculosis

## Plaque Psoriasis: What, How, Why?

Approximately 7.5 million people in the United States carry a diagnosis of psoriasis, and 80 to 90 percent of these patients have plaque psoriasis.<sup>1</sup> First-line treatments include anti-inflammatory medications (NSAIDs) and disease-modifying agents (DMARDs), such as sulfasalazine, hydroxychloroquine and methotrexate. If these medications fail to control disease, we move into the ever-changing world of biologic therapy. The goal of this article is to summarize the current biologic agents on the market to aid in prescribing of these medications.

Biologics provide targeted therapy for autoimmune disorders that can be difficult to control with systemic therapy. All of the medications listed below cost around \$4,000/month for the average patient with commercial insurance. To increase patient access to these medications, co-pay cards and assistance programs are available for those who do not have federal insurance.

Most insurances companies now require a prior authorization to dispense these medications and that they be filled by a specialty pharmacy in an effort to control costs of these expensive medications. Specialty pharmacies are able to provide monitoring services and specialized disease and medication education due to increased availability of pharmacist time, which increases patient adherence and decreases waste.

Biologic therapies are an effective next step to control disease for patients for whom traditional therapies prove ineffective. However, agents must be selected based on patient specifics, mechanism of action, method of administration and cost.
