At LVHN, we are blessed with remarkable heart care providers and cardiovascular offerings within our medical staff. This provider group is overseen by talented medical and interventional cardiologists and a devoted team of cardiothoracic surgeons. As a network, we often focus on the clinical achievements and accolades of our medical staff and colleagues, and rightfully so. But the true greatness of our heart care providers comes from the intangibles, culture and drive to excel that have been created among them.

Cardiac services represent the epitome of clinical excellence in LVHN. Cardiology and cardiothoracic surgery at Lehigh Valley Hospital has been nationally ranked by U.S. News and World Report for four consecutive years and 11 times since 2002. Out of 4,667 U.S. hospitals rated, LVHN ranked 35th on this elite list in 2016. LVHN is clearly the leader in cardiac care in the region, but also ranks above many other exceptional hospitals in the state, including well-respected academic institutions, such as Penn State Hershey Medical Center and Jefferson Health System. These rankings are based on reputation, survival, patient safety and care-related metrics. Specific examples of our clinical excellence include LVHN being ranked consistently in the top one percent of hospitals in the country for heart attack survival.

Innovation, or a willingness to offer unique and novel care options, is also needed to establish a program of excellence. Our cardiac service lines include many examples of leading-edge efforts that make us both different and better. We were the first network in the area to offer transcatheter aortic valve replacement (TAVR), a minimally invasive, life-saving procedure for patients with aortic stenosis. It seems apropos the division will implant its 500th patient this coming month. Similarly, starting in April 2016, we began implanting WATCHMAN™, a newly approved therapy for people with atrial fibrillation designed as an alternative to blood thinners in preventing stroke.

Education and research remain critical elements of our mission at LVHN, and few factions of our medical staff have had more success in this area than our cardiology colleagues. Our cardiology fellowship receives approximately 450 applications for its five spots every year. Beyond getting excellent training, graduates of this program have a 100 percent board pass rate over the past five years. Our cardiovascular physicians have published or presented more than 30 peer-reviewed publications and presentations over the past year, several of these being meaningful national studies that will greatly impact the specialty.

Finally, community involvement and social responsibility is also a focus of our heart doctors – they care and “show heart” both inside and outside of the hospital setting. The department recently sponsored the distribution of portable electrocardiogram (EKG) units that have been placed in 90 ambulances within the region. This critical technology allows for better monitoring, and therefore management, of cardiac patients in the field, optimizing their care when they reach the hospital. Raymond Singer, MD, MMM, our chief of cardiothoracic surgery, will also be assuming the role of the Director of the Heart Ball in Lehigh Valley this year. This is a local and national event sponsored by the American Heart and Stroke Association that last year raised more than \$70 million for cardiovascular research.

Our network, hospitals and medical staff members at LVHN are genuinely special. We offer our patients excellent cardiac care, and we do it – if you will – with heart. The cardiology and cardiothoracic surgery department is a nationally-ranked, innovative, education-centered and community-minded group all year long, not just in February. Now, don't forget to pick up that heart-shaped box of chocolates for all of your loved ones.

## Conflict of Interest/Commitment Questionnaire

As stipulated in the Medical Staff Bylaws, all members of the medical staff are required to complete the LVHN Conflict of Interest/Commitment Questionnaire on an annual basis.

This year, you are required to complete the Conflict of Interest Questionnaire by April 2, 2017. Please remember, the overarching purpose of our conflict of interest policy is to protect LVHN's interest when it is entering into or contemplating a transaction or arrangement that might benefit the private interest of any individual who has a role in the decision-making process with respect to the transaction or arrangement, or who otherwise has the ability to affect the decision-making process in any manner.

The Internal Audit and Compliance Services department has partnered with Health Endeavors to administer the Conflict of Interest Questionnaire. The information is confidential and will be reviewed by LVHN Compliance Services.

In January, you received an email via your LVHN email account that included your personalized link to access the new online questionnaire. Deadline for completion is April 2.

## LVHN Medical Staff Merger Spawns Revised Committee Structure

The recent merging of the medical staffs at Lehigh Valley Hospital, Lehigh Valley Hospital–Muhlenberg and Lehigh Valley Hospital–Hazleton into one LVHN Medical Staff has also brought about committee structure modifications designed to ensure that each hospital staff has input into network-wide concerns while maintaining guardianship over issues at the local level.

Under this structure, the Medical Executive Committee (MEC) acts as the organizational body overseeing all functions and duties of the LVHN Medical Staff. Its primary purpose is to regulate quality, credentialing and peer reviews across the entire medical staff.

Additionally, each hospital corporation now has an Executive Medical Leadership Committee (EMLC), which includes representation on the MEC but mainly has principal responsibility to address matters impacting patient care, professional staff, quality and performance on-site. The committee can tackle issues through recommendations to the MEC, but also is able to empower multidisciplinary teams to take care of problems.

“As LVHN grows through additional mergers, the challenge has been to bring together the medical staffs of multiple hospitals into a common association where each has appropriate representation and input into the governance of a single medical staff,” says Joseph Patrino, MD, LVHN Medical Staff President. “While still a work in progress, we believe this model allows us to maintain the efficiencies of centralized medical leadership while also making sure each hospital has a significant voice in local and network matters.”

The MEC consists of the Troika, which includes Medical Staff President Joseph Patrino, MD, Medical Staff President-Elect Patricia Martin, MD, and Medical Staff Past President Mark Lobitz, DO, as well as the LVHN President and CEO Brian Nester, DO, LVHN Executive Vice President and Chief Medical Officer Thomas Whalen, MD, LVHN Associate Chief Medical Officer and LVPG President Michael Rossi, MD, and Senior Vice President, Quality and Safety, Anthony Ardire, MD. The committee also includes all LVHN department chairs, the chairs of each EMLC, the senior medical directors of each EMLC and John Stanley, chair of the LVHN board of trustees.

The ELMC consists of a committee chair and senior medical director, both of whom also sit on the MEC, and a vice-chair for each discipline with a significant hospital site presence, appointed individually by the corresponding LVHN department chair. The ELMC chair is elected each July by committee members. The committee also includes up to five at-large members who are elected at the Annual Medical Staff Meeting to serve for the following year.

Membership to the MEC and EMLC includes both employed and independent clinicians. In order to be eligible for ELMC at-large positions, clinicians must have at least 51 percent of their activity at that particular hospital site.

Currently, LVHN Medical Staff directors are exploring the possibility of a merger with the medical staff at LVH–Schuylkill. Similar efforts will be explored with LVH–Pocono in the future.

“We had a positive experience with a similar model called the Medical Advisory Committee following our merger with LVH–Muhlenberg back in the late '90s,” Patruno says. “We’ve borrowed what we learned there for this model. We look to continue to make it even better going forward.”

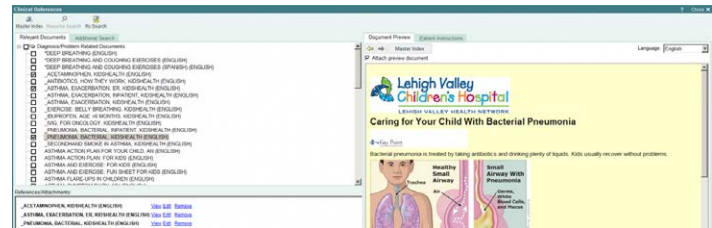
