Informed Consent: The How, the Why Now and the Opportunity

Recently, the topic of informed consent has taken front stage in our offices and hospital settings and across Pennsylvania. Informed consent refers to a process by which a treating provider discloses appropriate information to a patient so that he or she may make a voluntary choice to accept or refuse treatment. As this definition implies, informed consent is more than signing a consent form. It is a process. This is a process most of us learned, and were asked to perform, early in our medical training. It is one we have likely performed thousands of times during our careers. So why has informed consent become a renewed topic of discussion in health care and our clinical setting?

The reason relates to a recent ruling by the Pennsylvania Supreme Court in a malpractice case, Shinal v. Toms. The patient (Shinal) in this case underwent a surgical procedure that involved a complication. Her lawsuit was predicated less on the complication than the fact that she never received appropriate informed consent from her surgeon prior to going to the operating room.

The rules and expectations for informed consent in Pennsylvania are based on the Medical Care Availability and Reduction of Error (MCARE) Act. This law makes it clear that the physician who is doing a procedure/surgery, and only that physician, is able to perform the informed consent. In this case, it was clear consent was performed not by the surgeon (Toms), but by his physician assistant. Although the patient lost the malpractice suit originally – after several appeals grounded on the inadequate consent process – the patient was granted a retrial in June of this year. This ruling and retrial alerted the medical community to the risk involved with not performing informed consent by the book.

At Lehigh Valley Health Network, we perform well over 50,000 surgical procedures annually and do tens of thousands of other procedures in both the inpatient and outpatient settings, each requiring informed consent. In reviewing the expectations for consent, it is clear that we are by and large compliant in this process. Quality assurance tools such as check-off lists assure that appropriate steps, including a properly signed consent, are

completed before any patient enters an operating room.

Still, I believe, certain system stressors have threatened the consent process and the one-on-one interaction that is imperative during this process. Demand for the services and the expertise of our outstanding physicians have made access a challenge, driving us to see more patients while inevitably having less time with them. The push toward standardization and system-based care, which includes bundles structured around clinical teams as opposed to the individual physician, have also affected the more traditional interactions between patients and their doctors. Finally, financial stressors and expectations – both at the level of the network and also us as individuals – have influenced patient volume, prioritized efficiency over connection and also undoubtedly altered the nature of patient-physician communication.

Regardless of the reasons not to do so, not properly consenting a patient prior to a surgery or procedure carries with it significant medical-legal risk for the physician and really the physician alone. Importantly, as we counsel a patient before a procedure, we must remember that we are the only ones who have the knowledge, expertise, experience and most importantly the wisdom to provide informed consent. Although other members of our teams can provide information and education, we as the physicians actually performing and overseeing the case must be willing to explore the patient's understanding of the operating room plan. It involves more than simply reviewing the steps of the procedure, risks, benefits and alternatives, but also examining the patient's expectations, beliefs and fears regarding the procedure. These less tangible but important elements of care can only be dealt with through a direct dialogue and two-way exchange between the physician and the patient.

Perhaps there are some positives, however, as this situation may be a wakeup call of sorts. With the aforementioned stressors, really owning informed consent may force us to slow down and show more patience with patients. This patience and a mindful, personal interaction may also improve the patient experience. It may also increase our inpatient HCAHPs survey scores in the area of "communication with physicians," where we continue to have an opportunity to improve.

The reality is the rules and the expectations for providing informed consent in Pennsylvania, even with the Shinal v. Toms case, have not changed. These were always the rules and they have merely been re-emphasized. Based on this ruling, we are now in the process of reviewing our current systems to assure we are compliant in the processes of obtaining consent with the goal of protecting patients but also our doctors. This may be a stressor on our systems and even result in delays. Yet, the process of providing proper consent is a reminder that the foundation for medicine is based on an interaction and connection; a connection between a single doctor and a single patient. Embracing this connection through properly providing informed consent is the way we will ensure we are providing the best care, supporting the patient experience and maintaining humanity in the practice of medicine.

Influenza Vaccination Update

No matter your role in our health network, we all share the same mission – to heal, comfort and care. To do your job to the best of your ability, you first have to take care of yourself. As flu season approaches, one of the best ways you can help our patients avoid influenza infection is to get a flu shot.

The Lehigh Valley Health Network (LVHN) Medical Executive Committee requires all Medical and Allied Health Professionals who have routine or intermittent patient contact get a flu shot. All Medical and Allied Health Professional Staff are considered to have patient contact. Those who cannot be vaccinated because of a valid medical or religious reason must submit an exemption request, obtainable from any Employee Health Services office, by Nov 1. These individuals must be granted an exemption or be vaccinated by Nov. 23. Those approved for a permanent exemption in prior years do NOT need to request an exemption again this year. Failure to comply with the immunization policy will result in a written warning. All Medical and Allied Health Professional Staff and other staff with patient contact who are not vaccinated or granted an exemption within two weeks of the warning, will be subject to termination.

Submission of documentation of influenza vaccine received outside the auspices of LVHN employee health is required. Proof of vaccination can be submitted by accessing the electronic form at LVHN Intranet, Colleague Resources, Influenza Information or using this link:

If you fax your proof of vaccination, the document must include printed name, date of vaccination, and either your computer user ID (used to sign into LVHN computers) or your social security number. This is to assure your vaccine is properly documented in the tracking system.


