This message is from John Pierro, Executive Vice President and Chief Operating Officer, Lehigh Valley Health Network. Last week, we shared our decision to return to a partnership with Sodexo at our Lehigh Valley locations and continue discussion with Morrison in the north and northwest regions to evaluate a change in those regions. After further discussions and evaluation with Morrison, we have made the decision to transition to Sodexo network-wide at all LVHN locations.

LVHN colleagues who provide food & nutrition services at LVH–Hazleton, LVH–Schuylkill S. Jackson Street, LVH–Schuylkill E. Norwegian Street, LVH–Pocono and LVH–Dickson City will continue to be employed by LVHN. They will be managed by Sodexo.

Partners who provide food & nutrition services at LVH–Cedar Crest, LVH–17th Street, LVH–Muhlenberg, LVHN–Tilghman, LVH–Hecktown Oaks, LVHN–Mack Boulevard, LVH–Carbon, LVHN–1503 N. Cedar Crest and LVHN–Highland Avenue will be offered employment with Sodexo.

Sodexo will be onsite at all LVHN locations for the next four months understanding our patient population, culture and operations to propose the most comprehensive program, which will include the latest technology. During the transition, Sodexo will share information about changes in processes, procedures and services that will be implemented at all LVHN locations. The transition is anticipated to be complete in March 2023.

Crothall Healthcare, the partner who provides environmental services at LVHN, will continue to operate as is at all locations. Crothall partners will experience no changes.

# How to Protect Yourself and Your Family From Flu, RSV and COVID-19

Health care experts warn of a "tripledemic" with a high number of COVID-19, flu and RSV cases happening simultaneously.

COVID-19 has been the dominant virus over the last two years with fewer cases of other respiratory illnesses such as the <u>flu</u> and <u>respiratory syncytial virus</u> (RSV). Many health care

experts say this year could be different and warn of a "tripledemic" with a high number of COVID-19, flu and RSV cases happening at the same time.

Several Lehigh Valley Health Network (LVHN) infectious diseases experts took to Facebook Live to answer your questions about a potential "tripledemic" and what you can do to protect yourself and your family from respiratory viruses this winter. Here are some of the main takeaways.

#### What's behind the surge in respiratory viruses?

According to <u>Timothy Friel</u>, <u>MD</u>, Chair, Department of Medicine, LVHN, the spike in respiratory illnesses is because of a lack of immunity within the community. "We've seen so few cases of influenza and RSV over the last few years that our ability to develop an immune response has gone away a little bit. Unfortunately, theses viruses are back with a vengeance. We are seeing a higher number of RSV cases earlier than ever before," he says.

#### **COVID** is still in the mix

Friel says that the good news about COVID-19 is that cases have continued to decline and almost everyone has some type of immunity against the virus. However, new variants are circulating which are causing an expected increase in cases as we head into the winter.

#### We could see the worst flu season in over a decade

Health care experts predict how the flu will impact North America by how the virus impacts Australia and other countries in the Southern Hemisphere. This year, those countries saw much higher numbers of flu cases and an increase in hospitalizations among those over 65 and children under 4.

#### RSV is affecting older children and adults

RSV is a common respiratory illness that generally affects children under the age of 2, however, pediatric infectious diseases physician <u>Tibisay Villalobos</u>, <u>MD</u>, with Lehigh Valley Reilly Children's Hospital, says this year they are seeing older children as well. "We have been admitting children of all ages, mostly infants because they are most vulnerable, to the hospital. A lot of older children with health issues like asthma or developmental issues also are getting really sick," she says.

#### How can you protect your children from RSV?

Villabos says that the same precautions used to prevent transmission of COVID-19 can be used to prevent RSV. "Encourage children to wash their hands, use their own eating utensils, and of course if they are older to wear a mask to school if they have been sick," she says.

#### **Testing for flu and COVID is key**

Friel says they would like testing to be front and center on people's minds. "We have very good, effective treatments for influenza and COVID-19 that can change the course of illness and reduce the likelihood of severe disease and hopefully keep people out of the hospital. This medication can only be used if people test," Friel says.

#### Virtual care options

Friel advises the best way to determine whether you need to test or further treatment is to schedule a virtual visit. "Virtual visits are the quickest and most convenient way to be seen while you're sick, while protecting others from your illness. Your doctor can advise whether any testing may be necessary," he says. <u>Virtual visits</u> can be scheduled through LVHN's secure patient portal <u>MyLVHN.org</u> or through the MyLVHN app.

#### Best way to prevent flu and COVID-19

While there are effective treatment options for the flu and COVID-19, Terry Burger, RN, Administrator for Infection Control and Prevention, LVHN, stresses the importance of preventive measures. "We do have effective vaccines for both flu and COVID. I strongly, strongly encourage people to run, not walk, to get both of those vaccines. They take two weeks to work, and we are already into the season," she says.

Pennsylvania Sen. Pat Browne of Lehigh County on Friday announced \$1 million in state funding to replace vital imaging equipment at <u>Lehigh Valley Hospital (LVH)–Muhlenberg</u>.

The funds allowed Lehigh Valley Health Network (LVHN) to purchase a new Medtronic O-Arm imaging device for use in minimally invasive spinal surgery. It replaces an older unit no longer in service.

Prior to surgery, the O-Arm takes a 360-degree scan of the spine, providing 3D images allowing the surgeon to have enhanced and precise visualization of a patient's anatomy. This gives a surgeon the most accurate anatomical road map possible for the precision insertion of medical hardware such as screws and rods.

"Funding like this allows us to spread resources even further in all areas of care," said <u>Brian A. Nester, DO</u>, MBA, President and Chief Executive Officer, LVHN. "We appreciate the support of Senator Browne and the commonwealth for leading-edge technology that supports the great work of doctors, nurses and other health professionals across the state."

"We are fortunate to have outstanding health care partners, like Lehigh Valley Health Network, in our region," Browne said. "This project is a prime example of LVHN's dedication to remaining on the leading edge of medical technology, which has translated into better outcomes for the patients they care for. I am proud to support their efforts in advancing the care options available to our residents."

LVHN surgeons performed more than 2,000 spinal surgeries last fiscal year across the health network, including nearly 1,200 at LVH–Muhlenberg and <u>LVH–Cedar Crest</u>, where O-Arm units are located. "O-Arm imaging is an essential part of our success and great patient outcomes," Nester said.

Over the summer, work began to update API time and attendance time clocks at LVHN locations throughout the Lehigh Valley. Those updates are are now complete and colleagues now have a more convenient way to clock in and out.

Use a mobile app to conveniently clock in and out

Small wireless systems known as API Beacons (pictured below) are now located near time clocks. The process for clocking in and out has not changed, but these devices allow colleagues who have the API symplr Workforce app installed on their phone or mobile device to clock in or out while they are within 10 feet of the API Beacon.



Using the mobile app to clock in and clock out is optional. If you choose to use the app, follow these steps:

- Download the app using these directions.
- Stand within 10 feet of the API Beacon.
- Log in to your account. Turn on Bluetooth and locations settings.

Providing the best experience for patients and guests includes offering a convenient place to park close to their destination. That is why colleagues, including those visiting from other LVHN locations, should only park in spots designated for colleagues at LVH–Cedar Crest.

Reference this map, which clearly labels parking lots for colleagues, as well as where physicians and residents can park. The map also marks designated parking spots for guests

Lot U/U2, Lot K, Lot B, Lot M, Lot J and levels 3, 4 and 5 in the 1250 parking deck are designated as "staff lots" and are reserved for colleagues. Two-hour parking is available on the

lower level of H parking deck for colleagues visiting LVH–Cedar Crest from other LVHN locations.



Shuttles are available at all staff lots from 6-10 a.m. and 2-8 p.m.

Barriers and chains are in place to block certain parking spots for safety reasons. Please do not move these barriers.

As a reminder, colleagues who do not observe parking rules will receive a warning the first time, after that a ticket and fine will be issued by the Salisbury Township Police Department. Colleagues who continually break parking rules will face disciplinary action.

Michael Padden's ability to "look and listen" saved an elderly woman in distress. While driving to work, Padden noticed the woman lying on the side of the road. He immediately pulled over to help. He parked his truck on the side of the road and stopped traffic to shield the woman from oncoming vehicles. She told him she was 90 years old and without a driver's license. That's why she was walking to the store, which was about three miles away. On her way, she lost her footing and fell, hitting her head and injuring herself. On top of that, she wasn't dressed warmly for the chilly weather. Padden called 911 and stayed by the woman's side until an ambulance arrived. "Michael demonstrated compassion for this helpless elderly woman, and instead of passing this opportunity by, he took the time to care for and protect this individual. He truly went above and beyond to ensure her safety," says nominator Kathleen Law. "This is a fine example of an LVHN colleague, a true Partner in Caring, who also provided care and compassion to our community."

#### Megaly Muniz, Patient Transport, LVH-Muhlenberg

Muniz overheard a colleague choking on her lunch. Experiencing trouble breathing, the colleague began to panic. Muniz and a physician ushered her to the emergency department. Muniz collected her personal belongings and checked on her several times before leaving for the day. Muniz kept her cool during a very stressful situation while doing everything she could to prevent a worst-case scenario.

#### Robin Christman, Care Manager, Remote Patient Monitoring

Christman was working with a patient who was renting a single room and unable to afford food, medication or transportation. The patient often walked to a local shelter to eat. Christman reached out to several population health service organizations, securing much-needed assistance for this patient. Using a food delivery service and her own money, Christman had healthy meals delivered to the patient for one week.

#### Marysue Rother, RN, Care Navigator, Payor Based Care Coordination

Rother was working with a patient with serious heart problems. During one of the patient's hospital stays, Rother discovered he was not taking his medication because he couldn't afford it. Rother called the pharmacy to determine the total out-of-pocket cost for all 13 necessary drugs. She then tapped into the department's charity fund to get the medication paid for until a long-term solution could be put in place. Rother's diligent effort ensured this patient got life-saving treatment during his most vulnerable time.

#### Warren Furry Jr., Patient Care Coordinator, NICU, LVH-Cedar Crest

When a mom inadvertently left her breastmilk behind in the NICU, Furry went above and beyond to make sure she received it in a timely manner. The mom lived 90 miles away and could not pick it up in person. With the help of Lehigh Valley Reilly Children's Hospital President Anne Baum, Furry packaged three cartons of frozen breastmilk and sent it home to this very grateful, busy mom.

#### Kevin Cowell, DO, LVPG Family Medicine-Hecktown Oaks

When the department underwent staffing changes, Cowell made himself available to our patients whenever and wherever he was needed. He even made a house call to a homebound patient who lived several miles away. This extra effort ensured a seriously ill patient got the best possible inperson care. The patient and family were exceedingly grateful for his personal, caring touch.

#### Christine Lanasa, RN, Health Coach/BeneQUIT Specialist

Lanasa has a passion for helping colleagues reach their wellness goals. In her role, she motivates people to prioritize their health. 

# LVHN Physician Receives Federal Service Medal for Actions in Nation's Pandemic Response

National Disaster Medical System recognizes Jonathan Goldner, DO, with COVID-19 Pandemic Civilian Service Medal

<u>Jonathan Goldner, DO</u>, Associate Chief Medical Officer at <u>Lehigh Valley Hospital (LVH)</u>—<u>Pocono</u>, has been awarded the Federal COVID-19 Pandemic Civilian Service Medal for his exemplary service to the nation as part of the National Disaster Medical System (NDMS) during the federal medical response to the COVID-19 pandemic.

Goldner is a medical officer for NDMS, which is part of the Department of Health and Human Services. The federal program supports communities with medical care during disasters or public health emergencies at the request of states.

The medal is awarded under the authority of the U.S. Surgeon General to civilians who deployed for 30 consecutive or 60 cumulative days to provide medical care. During the recent NDMS Training Summit in Indianapolis, Goldner was recognized for his selfless commitment to public health.

"I thought I had seen it all until COVID-19 came into our world," Goldner said. "My experience with the virus started on March 9, 2020, as a member of the NDMS. I was deployed to California, where the cruise ship Grand Princess docked for two weeks in Oakland. Initially, we had been told there were just 21 patients. The reality was there were hundreds. I spent two weeks in full isolation gear, and it became obvious our world had changed."

"The COVID-19 pandemic strained our country's health care system and medical personnel for almost three years," said NDMS Director Michael Smith. "Dr. Goldner and his NDMS colleagues served as a lifeline to hundreds of hospitals and long-term care facilities by providing temporary relief to staff, adding bed capacity, and improving outcomes for COVID-19 patients. This medal is reflective of his selfless commitment to the public health and medical needs of our residents."

Goldner has been a medical officer with the NDMS since 2014 and has held key physician leadership roles at LVH–Pocono.

Most recently, Goldner was named Chief Medical Officer of LVH–Pocono, which took effect Nov. 1, 2022.

In addition to his many accolades, Goldner has authored articles and is a co-author for the current Society of Critical Care Medicine Guidelines for Admission, Discharge and Triage in Critical Care Units, and has received numerous awards.



#### Gift Enhances Lehigh Valley Fleming Neuroscience Institute's Deep Brain Stimulation Program

LVHN Trustee Joel Hoffman's generosity will help patients with Parkinson's disease, other movement disorders

A substantial gift from Lehigh Valley Health Network (LVHN) Board of Trustees member Joel Hoffman will help LVHN grow its deep brain stimulation program and expand comprehensive neurological and neurosurgical care for the treatment of movement disorders, including Parkinson's disease.

In recognition of his gift, the deep brain stimulation program at Lehigh Valley Fleming Neuroscience Institute has been named the Hoffman Family Deep Brain Stimulation Program.

Hoffman, an Allentown native and Dieruff High School and Temple University graduate, has been an LVHN trustee since 2019. He is a retired senior vice president and chief analytics officer for Optum, a pharmacy benefit manager and health care provider, part of UnitedHealth Group.

Hoffman's gift will allow LVHN to enhance its program in several ways, including the provision of a dedicated nursing resource to provide navigation services to seamlessly guide patients through world-class movement disorders care. The gift also will support a clinical research coordinator and allow for new equipment and technology, staff education, and more – all to assist patients enrolled in the Deep Brain Stimulation Program.

"Joel's selfless generosity will elevate LVHN's Deep Brain Stimulation Program and allow us to provide even more comprehensive care for those with Parkinson's disease as well as other conditions, including essential tremor and dystonia," said <u>Steven Lewis, MD</u>, Physician-in-Chief of <u>Lehigh Valley Fleming Neuroscience Institute</u> and Chief of Neurology at LVHN.

Hoffman, who has Parkinson's disease, benefitted from deep brain stimulation he received in Phoenix about five years ago and said it "truly dialed back the clock" on his symptoms.

"LVHN and the people of the Lehigh Valley are family, and it is important to me that 'family' be able to access comprehensive care for movement disorders so they may benefit from the same treatments I have been so lucky to receive," said Hoffman.



#### **LVHN Offering Free Pediatric Flu Shot Clinics Throughout Region**

Lehigh Valley Health Network has added additional pediatric flu shot clinics throughout the region.

Cases of influenza are already rising throughout the area. You can protect your child with a free flu shot at one of Lehigh Valley Health Network's (LVHN) pediatric flu shot clinics. The vaccine

is available to children over the age of 6 months. No appointment is needed. Masks are still required at all LVHN health care facilities.

"One of the best ways to protect yourself and your children from influenza is to get vaccinated. Early data suggest that this year's flu vaccine should be protective against the predominant circulating influenza strains," says pediatrician Debra Carter, MD, Executive Vice Chair, Pediatrics, LVHN.

Those with a suspected or confirmed COVID-19 diagnosis, regardless of symptoms, should postpone getting a flu shot until they have met the criteria to discontinue isolation. This protects health care professionals and others who are receiving their flu shot from contracting COVID-19.

#### Why get the flu shot?

Although the flu has been largely overshadowed by COVID-19 in recent years, Terry Burger, RN, LVHN Administrator for Infection Control and Prevention, says public health officials expect to see more flu cases than in the last few years.

"Anyone can get the flu. Based on the rising number of flu cases this early in the season, across the nation and right here in Pennsylvania, we know this is going to be a severe flu season," Burger says.

According to pediatric infectious diseases physician Tibisay Villalobos, MD, with Lehigh Valley Reilly Children's Hospital, the flu vaccine is especially important for children under 3 and those children with medical conditions. "The practices we were using to prevent COVID-19 were very effective in preventing the flu and other respiratory illnesses as well. Now there is a whole group of older children who have not been exposed to the flu, so it's important to get them vaccinated. Getting older children vaccinated will also protect younger siblings," she says.

# **Considering Over-the-Counter Hearing Aids? Here's What You Should Know**

Audiologist Jessica Jenkins, AuD, shares the pros and cons of these devices

There's been a lot of buzz surrounding the Food and Drug Administration (FDA)'s recent ruling on over-the-counter (OTC) hearing aids, which has made it possible for adults 18 and older to buy certain products in stores and online without a prescription.

While these products are a safe option for certain adults with mild to moderate hearing loss, there are important things to consider before purchasing these devices. Audiologist <u>Jessica Jenkins</u>, <u>AuD</u>, with LVPG Ear, Nose and Throat, shares what everyone should know about this latest development.

#### Pros and cons of OTC hearing aids

OTC hearing aids are easily accessible, with many large retail chains already offering them both in stores and online (or planning to). On average, OTC options also tend to be cheaper than prescription devices (which often aren't covered by health insurance policies), making hearing aids accessible for more people than ever before.

"OTC devices may be a good option for certain adults with minor hearing difficulties, but there are some downsides that you should be aware of before buying them," Jenkins says.

OTC hearing aids are specifically meant for adults with mild to moderate hearing loss. However, without getting a professional hearing test done before purchase, it can be difficult to tell if you will truly benefit from them.

"While the FDA requires labeling on these devices that explains what mild to moderate hearing loss sounds like, it can still be difficult to determine the level of your hearing impairment and if you will get any benefit from an OTC product," Jenkins says. "In addition, without evaluation from an ear, nose and throat specialist and audiologist, there's no way to know if your hearing loss is being caused by a condition that should be treated with medications or surgery. If that's the case, OTC products won't fix the underlying issue or make much difference in your hearing."

There also will not be hands-on support for your OTC hearing aids, which will leave you on your own to figure out how to use them and make sure they fit properly.

"When you purchase hearing aids from an audiologist, a custom fitting appointment and training sessions on how to insert, use, and care for them are included in the price. Unfortunately, with OTC devices, that support isn't part of the package," Jenkins says. "In addition, with prescription hearing aids, we are able to tailor the devices to each person's specific hearing needs and update them as their hearing changes over the years. OTC options may allow for some basic adjusting, but nothing tailored to your specific hearing loss."

#### Recommendations from an audiologist

If you are considering OTC hearing aids, Jenkins recommends getting a diagnostic hearing test to make sure your hearing impairment isn't more serious than mild or moderate and that it isn't being caused by a treatable condition. Even though it's not required for OTC purchase, it will put you on the right track for your specific hearing needs.

"If you are experiencing a problem with your hearing, these initial consultations and tests are often covered by health insurance plans," Jenkins says.

Even if you do have mild to moderate hearing loss and qualify for the OTC option, Jenkins still recommends discussing the pros and cons of prescription hearing aids with your audiologist.

"Some people find out their health insurance policy covers more than they thought, or they qualify for assistance through Pennsylvania's Office of Vocational Rehabilitation," Jenkins says. "If you are someone who might benefit from an OTC device, we will make sure you know that's an option during our discussion, too."

If you do decide on the OTC route, Jenkins recommends purchasing devices with a trial or exchange period as well as a warranty. She also recommends looking for devices that are adjustable to the shape of your ear and don't completely block your natural hearing while they are in. Also, before purchasing a device, be sure to check its packaging to make sure it has been FDA approved as an OTC hearing aid.

"If you try OTC hearing aids and they just aren't working for you, you can always make an appointment with an ENT specialist or audiologist as your next step," Jenkins says. "We will fully evaluate your hearing loss, and if needed, support you throughout your prescription hearing aid journey."
