ANNUAL REPORT as Chief of Staff
Allentown Hospital - June, 1960

Mr. President, and members of the Allentown Hospital Association:

As Chief of Staff, I again have the privilege of reporting to you on the activities of the medical staff during the past year. The Medical Staff, as many of you know, is composed of Active, Associate, Emeritus, and Courtesy Staff members. The Active Staff is composed of four divisions, and about eighteen different departments. The four divisions are medicine, surgery, obstetrics and gynecology, and pediatrics, and there are many subdivisions under these four. Each division has a head, and each department has a chief and assistant-chief.

We have a Medical Board which is composed of the heads of the four major divisions, and four others elected annually by the active staff. All matters of discipline as far as the house staff and the medical staff are concerned are referred to this Board. The report of the Credentials Committee, the Tissue Committee, the Library Committee and others are presented to the Board at the monthly meeting. The general staff meets four times a year at which time reports from the Medical Board and the various committees are received and discussed. Statistics on the patients admitted, the deaths and the complications are presented at these quarterly meetings. Each division, and a number of the departments have weekly or bi-weekly or monthly conferences at which time the members are required to attend and the patient care including the diagnosis and treatment is discussed.
