PRESIDENT'S ANNUAL REPORT

1976 - 1977

It is with pleasure that I report and review the activities and financial status of this organization to it's membership, the Adminstrators and the Board of Directors of the Allentown and Sacred Heart Hospital Center.

The main thrust continues to be fund raising. A major portion of our income is realized from monies accrued from the sales of merchandise and live plants in our attractive gift shop, the 'Tree Top Shop'. From the wise management by the Chairpersons, the astute selection of the buyers, the steadfastness of the committee and the vast number of faithful members helping in the shop daily, the Auxiliary can be proud of the tremendous efforts produced by this all-volunteer team. The profits for the reporting period of June 1976 - April 1977 were a fantastic total of \$34.848.55. These monies were placed in the Auxiliary savings account for distribution back to the Hospital.

The Auxiliary's big annual fund raising event adopted the name 'May Daze' this year and was held on the Hospital grounds May 21,1977. This fun day was a delightful success with perfect weather with the exception of the cool breezes which prevented the inflation; of the Forbes Hot Air Balloon. The general public and hospital personnel turned out in large numbers purchasing flowers, eating food, enjoying the Carnival section, viewing the invited craftsmen and buying the handmade items contributed by Auxiliary members. The 'make-up' booth for children was extremely popular, but nothing topped the 'dunking booth'. The list of 'celebraties' in our minds stood ten feet tall that day in being such good sports and showing a suprising talent in the area of taunting. The beautiful quilt went to a lucky Auxiliary member. As of this reporting date net profit is \$7,500.00. I cannever begin to express my warmest thanks to all the Hospital Department Heads who helped us so graciously. We could not have accomplished all that advance preparation without them.

We had one other money maker this year, a mini Christmas Boutique held in the hospital lobby in December. Our wonderful 'Twig' groups made lovely gift items which quickly sold and made \$708.74. They continue to be the 'hard core' of working hands in numerous ways, meeting quietly in homes and sharing their talents. We all enjoyed the newest Twig, the Choral group and found them to be delightfuly entertaining.

The Auxiliary's membership numbers 496 and invites all interested persons to it's open meetings. We continue to use Health Care concerns as instructional programs.

The Auxiliary joined with Adminstration in a program saluting all volunteers. Awards were presented and a special reception followed. Broadly speaking this organization gives a well deserved thanks to all it's members who this past year have assisted the Hospital Center in some fashion. Each serves within the framework best suited to themselves, using the flexibility of their membership. Their effectivness is known to them but the results are shared by all in this institution.
